The Board of Directors of the Company at its meetings held on 27th February, 2023 and 28th February, 2023 have allotted a total of 16000 number of unsecured, unrated and unlisted Optionally Convertible Debentures of the face value of Rs. 10,00,000/- each ("OCDs") aggregating to Rs. 1600 Crores to ATC Telecom Infrastructure Private Limited ("ATC"), which was approved by the shareholders of the Company at the Extra-ordinary General Meeting of the Company held on 25 February 2023.

As the holder of debentures requested conversion of 14,400 OCDs into Equity Shares, the Board of Directors of the Company allotted 144,00,00,000 Equity Shares on 23rd March 2024. As on 1st April 2024, 1600 OCDs aggregating to Rs. 160 Crores were outstanding. During the financial year 2024-25, the Company received a conversion request for the balance 1600 OCDs. Consequently, the Capital Raising Committee allotted 16,00,00,000 equity shares in lieu of the conversion request on 12th July 2024.

As there is no field of Optionally Convertible Debentures in e-Form MGT-7, the Optionally Convertible Debentures have been shown under Fully Convertible Debentures field.
