

**TERMS AND CONDITIONS GOVERNING THE
Vi20 FANfest**

A. INTRODUCTION

THIS **Vi20 FANfest Contest** (HEREINAFTER "**Contest**") IS OPTIONAL FOR **VODAFONE IDEA LIMITED** (HEREINAFTER REFERRED TO AS "**VIL**") SUBSCRIBERS OF Vi. THE ELIGIBLE SUBSCRIBER/S PARTICIPATING IN THE Vi20 FANfest SHALL BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS. IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT PARTICIPATE IN THE Vi20 FANFEST CONTEST

B. DEFINITIONS

"**Eligible Subscriber/You**" shall mean a subscriber in whose name the mobile phone number under Vi brand Subscriber Identity Module (SIM) is registered with VIL.

C. Vi20 FANfest DETAILS

i) **Vi20 FANfest Period:** 2nd October 2020 till 10th November 2020. VIL reserves the right to extend or shorten the period, as it deems fit. If, in any State and/or territory or part thereof, the running of this Santa Surprise is prohibited as per local rules or laws, the Eligible Subscribers from such State and/or territory or part thereof shall not be eligible to participate in the Santa Surprise. No further notice shall be given by VIL, in this regard.

ii) **Vi20 FANfest Description, Selection Process and Gratification:**

Activity: The hunt can be done on Social Media Platform, Facebook and Vi Website. Eligible Subscribers may participate in Vi20 FANfest by taking part in online puzzle. On successful completion of the puzzle the Eligible Subscribers shall crack a code of 6 digits.

Once the 6 digit Online Code ("Code") is received through display on Facebook or Website, the Successful Eligible Subscribers ("**SES**") are to access the designated link in the micro site placed in VIL website <https://myvi.in/vi20-fanfest-contest> promptly and submit/share such Code on the designated site.

Method of getting the gifts: Every SES who shares the code shall be receiving the following gifts.

- For each match of the Vi20 FANfest, all SES submitting all 7 code in the designated site will win an assured prize.
