

TERMS AND CONDITIONS –GOGREEN contest

Please read the following terms and conditions carefully before participating in this contest known as **"Vodafone GOGREEN contest"**. By proceeding with playing the Vodafone GOGREEN **contest**, you agree to be legally bound by these terms and conditions (**"terms and conditions"**). If you do not agree to these terms and conditions, please do not participate in the **Vodafone GOGREEN contest**.

Terms and Conditions

1. **"Win Vodafone GOGREEN Contest"**(hereinafter referred to as the **"Contest"**) is conceptualized, organized and hosted by Vodafone India Limited for enabling its postpaid subscribers ("Subscribers"), to participate in the Contest.

3. The Contest is open for all Subscribers across Mumbai who satisfy the eligibility criteria mentioned in Clause 4 below.

Notwithstanding the foregoing, if the operation of or participation in the Contest is prohibited in any part of Mumbai, thereof as per applicable law, the Subscribers from such part thereof shall not be eligible to subscribe to or participate in the Contest. No further notice shall be given by the Organizer or VIL , in this regard.

4. **Eligibility Criteria:**

- Subscriber must have an active Vodafone sim card of Mumbai;
