

TERMS AND CONDITIONS GOVERNING THE OFFER “Go Digital & Win Uber Voucher”

A. INTRODUCTION

THIS DOCUMENT IS AN ELECTRONIC RECORD IN TERMS OF THE INFORMATION TECHNOLOGY ACT, 2000 AND RULES THERE UNDER AS APPLICABLE. THIS ELECTRONIC RECORD IS GENERATED BY A COMPUTER SYSTEM AND DOES NOT REQUIRE ANY PHYSICAL OR DIGITAL SIGNATURES.

FOR THE PURPOSES OF THESE TERMS AND CONDITIONS, WHEREVER THE CONTEXT SO REQUIRES “COMPANY”, “WE”, “US” OR “VIL” SHALL MEAN VODAFONE IDEA LIMITED HAVING ITS REGISTERED OFFICE AT SUMAN TOWER, PLOT NO. 18, SECTOR –11, GANDHINAGAR –382 011, GUJARAT AND ITS SUCCESSORS AND ASSIGNS.

THE FOLLOWING TERMS & CONDITIONS SHALL BE APPLICABLE TO REFERRER AND REFEREE SUBSCRIBERS OF VIL (AS DEFINED BELOW) PARTICIPATING IN THE OFFER KNOWN AS “Go Digital & Win Uber Vouchers” DURING THE OFFER PERIOD AS MENTIONED HEREIN.

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE PARTICIPATING IN THIS OFFER KNOWN AS “Go Digital & Win Uber Vouchers” (Offer). BY PARTICIPATING IN THE OFFER, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS (“TERMS AND CONDITIONS”). IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT PARTICIPATE IN THE OFFER.

For the purposes of these Terms and Conditions, wherever the context so requires “You” or “Your” shall mean any natural person who, being a Referrer or Referee, has participated in the Offer.

B. DEFINITIONS

- a. “Subscriber” shall mean the rightful user of the VIL mobile connection who is on Vodafone network, having a post-paid subscription and in whose name the mobile phone number (MSISDN) is registered with VIL. In the event the user number / connection is registered in the name of a company/ firm, the employee who is authorized to use the MSISDN shall submit a No Objection Certificate (NoC) and authorization of the employer/principal duly permitting the employee to use the number for subscribing for this Offer and accept the terms applicable herein.
- b. “Active Subscriber” shall mean a Subscriber who uses the Subscriber Identity Module (“SIM”) of Vodafone on a regular basis for purposes other than to participate in any offer or contest offered by VIL.

ii. Go to the Gift Card option in the menu:

- a. Go to the Payment section in the Uber app
- b. Tap 'Add Payment Method' and select Gift Card
- c. Enter Gift Card code
- d. You can now view the Uber credits added to your account

iii. Gift Card worth Rs 100 will be added in the total available balance

d. The Referrer and Referee should read, understand and accept the terms and conditions put on the Uber website/app. Any personal information that the Referrer or Referee shares towards availing the Uber services, shall be at his sole discretion and VIL shall not be liable for any use of a Subscriber's information by Uber. The Referrer or Referee assumes the ownership of the unique e-gift card code, once he/she receives it

e. Uber Voucher shall be valid for a period of 6 Months starting from 15th July'19 and will expire on 13th March'20

f. This offer is for limited period only

g. VIL does not take any responsibility or liability with respect to Uber Gift Card codes including the fulfillment of redemption benefits.

h. VIL does not take any responsibility or any liability of any third party/Uber product or services.

i. Uber Voucher codes cannot be exchanged for cash and credit and cannot be reloaded. It cannot be used to purchase other gift cards.
