

Terms & Conditions governing Nokia Smartphone Bundle Offer (“Offer”):

THIS DOCUMENT IS AN ELECTRONIC RECORD IN TERMS OF THE INFORMATION TECHNOLOGY ACT, 2000 AND RULES THERE UNDER AS APPLICABLE. THIS ELECTRONIC RECORD IS GENERATED BY A COMPUTER SYSTEM AND DOES NOT REQUIRE ANY PHYSICAL OR DIGITAL SIGNATURES.

VODAFONE INDIA LIMITED AND VODAFONE MOBILE SERVICES LIMITED ARE HEREINAFTER COLLECTIVELY REFERRED TO AS “**VODAFONE INDIA**”. THE FOLLOWING TERMS & CONDITIONS SHALL BE APPLICABLE TO ALL VODAFONE INDIA POST PAID OR PREPAID SUBSCRIBERS PARTICIPATING IN THE OFFER UPON BUYING NEW 4G HANDSETS OF NOKIA SMARTPHONE HANDSETS (SPECIFIC MODELS AS MENTIONED BELOW) BOUGHT IN INDIA DURING THE PERIOD AS MENTIONED IN ANNEXURE-1 (HEREINAFTER REFERRED TO AS “**OFFER PERIOD**”).

BY PARTICIPATING IN THE OFFER, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS (“**TERMS AND CONDITIONS**”). IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT PARTICIPATE IN THE OFFER.

“**2G ICR Circles**” shall mean the following circles, Andhra Pradesh, Himachal Pradesh, Madhya Pradesh & Chhatisgarh, Bihar, Jammu & Kashmir.

“**Subscriber**” shall mean: (i) the rightful user of the mobile connection who is either on prepaid or postpaid subscription, in whose name the mobile phone number (MSISDN) is registered with Vodafone India. In the event the user number / connection is registered in the name of a company/ firm, the employee who is authorized

to use the MSISDN shall submit a No Objection Certificate (NoC) and authorization of the employer duly permitting the employee to use the number for subscribing for this Offer and accept the terms applicable herein. Postpaid - Any customer who has bought a new Nokia 4G Smartphone (specific models mentioned in Annexure – A) and inserts a Vodafone 4G SIM for the 1st time, he will get an activation message 'Hi, You are eligible for Vodafone 5 GB offer. We will activate the offer within 48 Hrs. Refer T&C on [www.vodafone .in](http://www.vodafone.in).' Subscriber has to have 1GB or above rental plans already , and offer data gets attached within 48 hrs,
