VODAFONE INDIA LIMITED AND VODAFONE MOBILE SERVICES LIMITED are hereinafter collectively referred to as "**Vodafone India**". THE FOLLOWING TERMS & CONDITIONS SHALL BE APPLICABLE TO ALL VODAFONE INDIA POST PAID OR PREPAID SUBSCRIBERS PARTICIPATING IN THE OFFER UPON BUYING NEW ONEPLUS5 MODEL HANDSET FROM AMAZON INDIA ONLINE MARKETPLACE DURING THE PERIOD AS MENTIONED IN ANNEXURE- 1 (HEREINAFTER REFERRED TO AS "**OFFER PERIOD**").

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE PARTICIPATING IN THIS OFFER. BY PARTICIPATING IN THE OFFER, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS ("**TERMS AND CONDITIONS**"). IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT PARTICIPATE IN THE OFFER.
