# `TERMS AND CONDITIONS GOVERNING THE OFFER "#RechargeforGood"

# A. INTRODUCTION

THIS DOCUMENT IS AN ELECTRONIC RECORD IN TERMS OF THE INFORMATION TECHNOLOGY ACT, 2000 AND RULES THERE UNDER AS APPLICABLE. THIS ELECTRONIC RECORD IS GENERATED BY A COMPUTER SYSTEM AND DOES NOT REQUIRE ANY PHYSICAL OR DIGITAL SIGNATURES.

THE OFFER IS CONCEPTUALIZED, ORGANIZED AND HOSTED BY VODAFONE IDEA LIMITED (**"VIL"**) FOR THE ELIGIBLE SUBSCRIBERS OF IDEA BRAND.

THE FOLLOWING TERMS & CONDITIONS SHALL BE APPLICABLE TO VIL PREPAID SUBSCRIBERS AVAILING specific recharge plans as mentioned under the Offer Details AND PARTICIPATING (SUBJECT TO ELIGIBILITY) IN THE OFFER KNOWN AS "**#RechargeforGood**" ("**Offer**") DURING THE OFFER PERIOD AS MENTIONED HEREIN.

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE PARTICIPATING IN THIS OFFER KNOWN AS **"#RechargeforGood**". BY PARTICIPATING IN THE OFFER, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS ("TERMS AND CONDITIONS"). IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT PARTICIPATE IN THE OFFER.

For the purposes of these Terms and Conditions, wherever the context so requires "You" or "Your" shall mean any natural person who being an Eligible Subscriber has participated in the Offer.

## B. **DEFINITIONS**

- a. **"Subscriber**" shall mean the rightful user of the VIL Vodafone mobile connection who is on prepaid subscription, in whose name the mobile phone number (MSISDN) is registered with VIL.
- b. "ActiveSubscriber" shall mean a Subscriber who uses the Subscriber Identity Module ("SIM") of VIL on a regular basis for purposes other than to participate in any offer or contest offered by VIL.
- c. "Eligible Products" shall mean all those prepaid recharge plans as specified below under the Offer details.
- "Eligible Subscriber" shall mean an Active Subscriber who is a prepaid customer of VIL and who is recharging other prepaid Vodafone Subscribers of his choice with Eligible Products, to avail the Offer. An Eligible Subscriber must also satisfy the following criteria at the time of participation and during continuation of Offer:
  - i. Subscriber must be an Indian citizen belonging to any one of the telecommunication service areas of VIL as mentioned herein;
  - ii. Subscriber must not have been subject of any criminal proceeding;
  - iii. Subscriber must not be of an unsound mind; and

  - vi. Subscribers must be a registered user in MyVodafoneApp (MVA);
  - vii. Subscriber must ensure proper due diligence in recharging for others and ensure that Subscriber has necessary authorisation / consent from such other subscribers whose number has been recharged.
  - viii. Subscriber must take full responsibility of the individual whose number being recharged and also the responsibility of any error on his/her part in feeding the number for recharge, shall be solely on his/her account.

## C. OFFER DETAILS – <u>DESCRIPTION, ELIGIBLE PRODUCTS, STEPS AND RESTRICTIONS</u>

## 1. DESCRIPTION

- (a) Existing or New Customers (referred to as Party-A) on MVA (in the logged-in journey) doing recharges of Eligible Products through MVA for other prepaid Vodafone Customers (referred to as Party-B) within the Offer Period will get Cashback.
- (b) VIL is providing a FLAT Cashback in the form of discount vouchers on specified Hero Recharges, to be redeemed when the Eligible subscriber does next recharge of his / her own mobile number: (which are as mentioned) Rs.149/199/219/249/299/398/399/499/555/599 and for all other recharge denominations mentioned below, slab based cash back in the form of discount vouchers will be provided.
- (c) This Offer does not apply to non-VIL customers.

- (d) All consumer plans are meant only for the use of retail customers for non-commercial usages and are not meant for commercial/ nonretail use. Following usage by customers will be deemed to be Commercial/ non-retail usage and shall be chargeable as per the governing policy
- (e) The Eligible Subscribers Party-A, will receive the cashback Voucher as per the cashback grid:

- i. For Hero Recharge MRPs, Party-A will be simply eligible for designated cash back in the form of Discount Voucher.
- ii. For all other MRPs, Party-A will become eligible for cashback discount vouchers once s/he achieves the threshold.
- iii. Customer subject to threshold criteria, may be eligible for multiple vouchers on a single day or over the entire campaign
- (f) Party-A(Eligible party), shall receive the Cashback in the form of the discount vouchers redeemable during next recharge of his own mobile number.
- (g) The discount vouchers shall be sent in Eligible Subscriber's MyVodafoneApp ("MVA") associated with the Vodafone number through which the recharge was done during the offer period.
- (h) The Eligible subscriber shall receive the Vouchers in his /her MVA account, the Vouchers will be provided within 96hours of meeting the eligibility criteria.
- (i) The maximum cashback in the form of the discount voucher that the Eligible Subscriber can be entitled to via this offer, is of Rs 100
- (i) The Eligible Subscriber shall be able to view the Vouchers at any time in his MVA.
- (k) The Eligible Subscriber shall be entitled to redeem the Vouchers for any future recharges of Rs.49 or above, for their self-recharge only (i.e. only for Party-A msisdn recharge and only against that MSISDN through which recharge was done for Party B) and only by using MVA. The Eligible Subscriber at a time can redeem a single Voucher against single self-recharge.
- (l) The Voucher balance credited in MVA account under this Offer is NOT redeemable for cash or to be used for any other purchases by the Eligible Subscriber. Further, Eligible Subscriber cannot transfer this Voucher balance to anyone including but not limited to its bank account, other e-wallet accounts or other MSISDNs in the name of Eligible Subscriber. These Vouchers are solely redeemable for recharges on his/her Idea MSISDN through MVA
- (m) The Eligible Subscriber shall have to redeem the Vouchers on or before 180 days from the day of obtaining the discount voucher. Unless the vouchers are redeemed as per process, the same shall expire automatically without any further communication and no request of extension shall be entertained.
- (n) The Voucher balance can only be redeemed against recharge of Eligible Subscribers Vodafone mobile number only and the Voucher shall lapse if the Eligible Subscriber ports out from Vodafone network or churns from Vodafone network.

# D. OFFER PERIOD

This is a limited period Offer by VIL, available till 31<sup>st</sup> May 2020, 23.59.59 hrs ("**Offer Period**"). VIL reserves the right to extend or shorten the Offer Period, as it deems fit.

# E. OFFER AREA

- a. The Offer is valid in select Indian telecom service areas as mentioned below
  - i. All VIL telecom service areas within the geographical limits of India as appropriately captured below:

Andhra Pradesh, Telangana, Assam, Delhi &NCR, Gujarat and Daman and Diu, Haryana, Kolkata, Mumbai, Maharashtra and Goa, North East, Rajasthan, Tamil Nadu, Uttar Pradesh (East), Uttar Pradesh (West), Rest of West Bengal (Excluding Kolkata), Kerala, Karnataka, Madhya Pradesh, Odisha, Himachal Pradesh, Bihar, Jammu & Kashmir, Ladakh.

ii. Notwithstanding the foregoing, if the operation of or participation in the Offer is prohibited in any State and/or territory or part thereof as per applicable law, the Subscribers from such state and/or territory or part thereof shall not be eligible to subscribe to this Offer.
