

TERMS & CONDITIONS FOR VODAFONE SPOT THE BALL COMPETITION

THIS DOCUMENT IS AN ELECTRONIC RECORD IN TERMS OF THE INFORMATION TECHNOLOGY ACT, 2000 AND RULES THERE UNDER AS APPLICABLE. THIS ELECTRONIC RECORD IS GENERATED BY A COMPUTER SYSTEM AND DOES NOT REQUIRE ANY PHYSICAL OR DIGITAL SIGNATURES.

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE PARTICIPATING IN THIS COMPETITION KNOWN AS VODAFONE SPOT THE BALL COMPETITION. THIS COMPETITION IS AN OPTIONAL COMPETITION CONCEPTUALIZED, ORGANIZED AND HOSTED BY VODAFONE INDIA LIMITED AND VODAFONE MOBILE SERVICES LIMITED, (HEREINAFTER COLLECTIVELY REFERRED TO AS "**VODAFONE INDIA**").

THE FOLLOWING TERMS & CONDITIONS (these "**Terms and Conditions**") SHALL BE APPLICABLE TO THE SUBSCRIBER/S OF VODAFONE INDIA WHO IS EITHER A POST PAID OR PREPAID SUBSCRIBER INTENDING TO PARTICIPATE IN THE **VODAFONE SPOT THE BALL COMPETITION** (HEREINAFTER "**COMPETITION**"). THE COMPETITION SHALL BE LIVE FROM 27st April, 2018 TO 27th May, 2018, BOTH DAYS INCLUSIVE, (HEREINAFTER REFERRED TO AS "**COMPETITION PERIOD**"). THE ELIGIBLE SUBSCRIBER/S PARTICIPATING IN THE COMPETITION SHALL BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS.

For the purpose of these Terms and Conditions, wherever the context so requires "You" or "Your" shall mean any natural person, who being an Eligible Subscriber has participated in the Competition.

1. By participating in the Competition, You acknowledge that You have read, understood, accepted and agreed to be bound by the full set of Terms & Conditions set forth herein. If You do not agree to these Terms & Conditions, then You have no right to participate in the Competition and you should not participate in the Competition.
2. You as Eligible Subscriber of this Competition would ensure that there You wouldn't misuse any of the Terms & Conditions of this Competition. For participating in this Competition, You agree to follow the modes as stated in point 7 below and abide by the norms as are mentioned on the official interface and as further stated herein. You may participate in this Competition only as permitted by law and during Your participation in the Competition You are prohibited from any UNLAWFUL, HARASSING, LIBELOUS, OFFENSIVE OR VULGAR behaviour. You are not allowed to insult or harm any person or organization, religion or community through this Competition.
3. **Eligibility:** An Eligible Subscriber shall: (i) be a rightful user of Vodafone India's mobile connection, who is either on prepaid or post-paid subscription, in whose name the mobile phone number (MSISDN) is registered in the records of VODAFONE INDIA. In the event the user MSISDN number / connection is registered in the name of a company/ firm, the employee who is authorized to use such MSISDN shall submit a No Objection Certificate (NoC) and authorization of the employer duly permitting the employee to use the number for participating in this Competition and accept the terms applicable herein; and (ii) not have any outstanding dues payable to VODAFONE INDIA on account of the mobile connection; and (iii) must be of at least 18 years of age as on 27st April, 2018; (iv) be residents and citizens of India who are Subscribers on Vodafone India network and; (v) must

enter correct information at the time of participation in the Competition through the modes mentioned herein below; and (vi) be a registered user in MyVodafone App ("MVA")'.

4. **Competition Area:** The Competition is open to all Vodafone subscribers (except J&K, TN and Chennai). If, in any State and/or territory or part thereof, the running of this Competition is prohibited as per local rules or laws, the Eligible Subscribers from such State and/or territory or part thereof shall not be eligible to participate in the Competition. No further notice shall be given by Vodafone India, in this regard.
5. **Commencement Date of Competition:** This is a limited period Competition commencing on 27th April, 2018 & will be played on the MyVodafone App.
6. **End of Competition:** Competition will end on 27th May, 2018 ("End Date") at 23:59 hrs unless extended by Vodafone India and communicated explicitly.
7. **Modes of entry in the Competition:** An Eligible Subscriber may participate in the Competition through any of the following modes:
 - a) MVA
8. **Competition Description:**
 - a) During the Competition Period on visiting the MyVodafone App, the Eligible Subscriber will be prompted to participate in the Competition. .
 - b) The Eligible Subscriber will have to search for ball which will be released on different pages of MyVodafone App on different days during the Competition Period.
 - c) In a day, every 1000th Eligible Subscriber who finds the ball will be declared as the winner for the Amazon voucher ("Voucher")for the day. If 30,000 Eligible Subscriber find the ball on one day, 30 winners will be declared and if 50,000 users find the ball, 50 winners shall be declared.
 - d) There can be maximum 50 winners in a day.
 - e) If the winner does not claim/raise alarm over receipt of Voucher in 2 days of winner declaration, in such cases the Vodafone India shall not be liable to provide a new Voucher to the winner.
 - f) Every day results will be declared on the leader board on MyVodafone App.
 - g) In case the Eligible Subscriber is not a winner the, s/he will be informed of the same through an in-app message which in turn will also tell the Eligible Subscriber of ongoing eligibility for the next 30 days.
 - h) An SMS will be sent to the winners with the voucher code on the day of winner declaration.

- i) Based on the results of the Eligible Subscribers, upto 50 Eligible Subscribers shall be selected as a winner during the Competition Period on a particular day. Unless otherwise stated herein, the selection of the winner will be conducted by an independent auditor. The decision of the agency & auditors in this regard shall be final and binding on the Eligible Subscribers. No dispute, of whatsoever nature, in this respect shall be entertained by Vodafone India.

9. Rewards and Benefits:

- a) Every 1000th user who finds the ball will be declared the winner for the voucher for the day. If 30,000 users find the ball on one day, 30 winners will be declared and if 50,000 users find the ball, 50 winners shall be declared.
- b) In a day, every 1000th Eligible Subscriber shall receive a congratulatory SMS/e-mail from Vodafone India, which will be sent on the said MSISDN/email id .
- c) There can be maximum 50 winners in a day.

10. Selection of Winners:

- (a) Unless otherwise stated herein, the selection of a winner will be conducted by an independent auditor. Decision of the Agency & Auditors, appointed by VODAFONE INDIA in this regard, shall be final and binding on the Eligible Subscribers. No dispute, of whatsoever nature, in this respect shall be entertained by VODAFONE INDIA.
 - (b) The process of selecting the winners would be done by an independent auditor. No dispute, of whatsoever nature, in this respect shall be entertained by VODAFONE INDIA. The winners would receive a congratulatory SMS/e-mail from Vodafone India's appointed agency's outbound agency , informing about their selection as winner and prizes under Competition. Also the winners' email id, social media handles and identity proof, address proof would be taken. The winners would need to send their scanned photo on the email id and the winner authorises Vodafone to suitably insert the said photo on the Vodafone website or Facebook, twitter or any other media as VODAFONE INDIA may deem appropriate, at its discretion.
 - (c) By participating in this Competition, You confirm and waive the applicability of rules and regulations of the National Do Not Call registry and You agree to receive promotional messages and alerts under the current Competition and upcoming Competitions from Vodafone India, as it may in its sole and absolute discretion decide.

If the modified Terms and Conditions are not acceptable to you, your only recourse is to either not participate in the Competition or cease participating in the Competition. f) **Disqualifications:**
