TERMS AND CONDITIONS GOVERNING THE CONTEST

PLAY AND WIN

A. INTRODUCTION

THIS DOCUMENT IS AN ELECTRONIC RECORD IN TERMS OF THE INFORMATION TECHNOLOGY ACT, 2000 AND RULES THERE UNDER AS APPLICABLE. THIS ELECTRONIC RECORD IS GENERATED BY A COMPUTER SYSTEM AND DOES NOT REQUIRE ANY PHYSICAL OR DIGITAL SIGNATURES.

THE CONTEST IS AN OPTIONAL CONTEST CONCEPTUALIZED, ORGANIZED AND HOSTED BY ONMOBILE GLOBAL LIMITED, A COMPANY INCORPORATED UNDER THE COMPANIES ACT, 1956 AND HAVING ITS REGISTERED OFFICE AT TOWER 1, 94/1 C AND 94/2, VEERASANDRA VILLAGE, ATTIBELE HOBLI, ANEKAL TALUK, ELECTRONIC CITY PHASE 1, BANGALORE – 560 100, INDIA (HEREINAFTER REFERRED TO AS "ONMOBILE") FOR THE ELIGIBLE RIGHTFUL SUBSCRIBERS OF VODAFONE INDIA LIMITED, AND VODAFONE MOBILE SERVICES LIMITED (HEREINAFTER COLLECTIVELY REFERRED TO AS "VODAFONE INDIA").

ONMOBILE AND VODAFONE INDIA SHALL HEREINAFTER JOINTLY OR INDIVIDUALLY AS THE CONTEXT MAY REQUIRE BE REFERRED TO AS "ORGANIZER(S)"

THE FOLLOWING TERMS & CONDITIONS SHALL BE APPLICABLE TO ALL VODAFONE INDIA POST PAID AND PREPAID SUBSCRIBERS PARTICIPATING IN THE CONTEST KNOWN AS "ELIGIBLE SUBSCRIBER" DURING THE CONTEST PERIOD AS MENTIONED HEREIN.

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE PARTICIPATING IN THIS CONTEST KNOWN AS PLAY AND WIN. BY PARTICIPATING IN THE CONTEST, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS ("TERMS AND CONDITIONS"). For the purposes of these Terms and Conditions, wherever the context so requires "You" or "Your" shall mean any natural person who being an Eligible Subscriber has participated in the Contest.

B. DEFINITIONS

"Subscriber" shall mean the rightful subscriber of the Vodafone India mobile connection who is either on prepaid or post-paid subscription, in whose name the mobile phone number (MSISDN) is registered with Vodafone India. In the event, the subscriber's number / connection is registered in the name of a company/ firm, the employee who is authorized to use the MSISDN shall submit a No Objection Certificate (NoC) and authorization of the employer duly permitting the employee to use the number for subscribing for this Contest and accept the terms applicable herein.

- (2) "Active Subscriber" shall mean a Subscriber who uses the Subscriber Identity Module ("SIM") of Vodafone India on a regular basis for purposes other than to participate in any offer or Contest offered by Vodafone India.

E. CONTEST DETAILS – ACTIVATION, STEPS AND RESTRICTIONS

(a) Subscription to Contest

Subscribers can initiate participation in the Contest by sending the SMS keyword 'ACT DO' to 199 (FREE) or alternatively by calling the number 556770 (toll free) or dialling the Unstructured Supplementary Service Data (**USSD**) string *567*910# from a Vodafone number.

(b) Un-Subscription from the Contest

If, Subscriber wish to discontinue participating in the Contest, Subscriber should send 'CAN DO' as an SMS to the 199 or alternatively by calling the number **556770** and pressing '1' from a Vodafone number.

(c) To Play

To play the contest Subscriber shall send SMS keyword 'GET' to 556770 (free) or alternatively by calling the number 556770.

NOTE: Applicable only for Subscription Contests.

(d) Total number of questions:

There are total 540 number of questions which will be randomly asked from the Subscriber for the purpose of this Contest.

Note: Fall-back/Missed charging feature available:

Subscribers with status as 'Suspended' will be allowed to play only for five (5) consecutive days.

Subscribers who are charged Re 1 will receive three (3) questions.

Subscribers who are charged Rs 2 will receive four (4) questions.

Subscribers who are charged Rs 3 will receive five (5) questions.

Subscribers who are charged Rs 4 will receive six (6) questions.

Note: Fall-back charging will not be applicable for post-paid Subscribers as charging happen on base price.

(ii) Contest Flow

1. Contest on Voice:

(a) Subscribers will be informed of the rules, gratifications and Terms and Conditions of the Contest upon Subscription.

- (b) After every question and answer options, a 'beep' will be played. Subscriber will have to answer by choosing one of the options only after the 'beep' is played.
- (c) After every answer input, next question and the answer options will be given to the Subscriber. After every wrong answer, the Subscriber will be played an appropriate prompt (e.g. "Sorry! That's a wrong answer ") and given the next question and answer options.
- (d) To listen to a question again Subscribers may press (*).
- (e) If a Subscriber discontinued playing the Contest, then the Subscriber may resume playing by Subscribing as per Subscription details provided above for Subscription. If for example, a Subscriber stops playing the Contest after answering question no. 9 then if the Subscriber calls again with the same number, the Subscriber will be played question no. 10 question. If for example, a Subscriber listens to the 9th question but drops the call without answering the 9th question, then, if the Subscriber calls again, the Subscriber will be played the 9th question which may be different from what the Subscriber has earlier received.
- (f) If a Subscriber stops playing the Contest after answering the question no. 9, then the Subscriber will be sent a reminder SMS on the Subscriber's number registered with Vodafone India followed by another question and answer options. In case the Subscriber does not answer this question, the Subscriber will be engaged three (3) times a day with questions and answer options via SMS.
- (g) The Subscriber can play this contest only once.

2. Missed Questions Feature:

- (a) After Subscriber finishes answering all questions for the day, if Subscriber is charged for the day, that day's score will be added to the total score. If the Subscriber is not charged that day's score will not be added to the total score. Communication to charged Subscriber of the day and not charged Subscriber of the day will be different. (E.g. Charged subscriber will get the communication "Now you can play the missed questions for the day...". A not charged Subscriber will get the communication "Press 8 to get charged and play missed questions of the day")
- (b) Post calculations as specified in (a) above, the OnMobile system will check for the questions that were missed earlier and in case there are any missed questions then Subscriber will be redirected to the missed questions flow else exit prompt is played.
- (c) The Subscriber will be redirected to press "8" button on IVR as a consent and get charged to play the missed questions of earlier days.
- (d) If there are missed questions on earlier days, then first Subscriber will be given the missed questions for the days when the Subscriber was charged and then he will be given the missed questions for the non-charged days.

(e) Before presenting the question for any non-charged day, the Subscriber will be asked to give consent for getting charged for that particular day. Once the Subscriber has given its consent and is charged successfully, he will be presented with set of questions for that day.

(iii) GRATIFICATIONS AND WINNER SELECTION PROCESS

1. Bumper Gratification

- (A) The selection for the Bumper Gratification will be conducted at the end of the Contest Period.
- (B) One (1) MSISDN across all circle groups except Gujarat*, with minimum cumulative score of 90 points, in the least amount of time during the Contest Period will be selected as the winner of Rs. 50000 worth iPhone7.
- (C) In the selection of the Bumper Gratification, in case of a tie in the score and time taken, 1 round of tie-breaker will be conducted for all the tied MSISDNs on Voice. In case of a further tie in the score and time taken, in the tie-breaker, the selection will be conducted by checking the time taken by the MSISDNs to answer x-1, x-2 questions in the tie-breaker. i.e., if the tie-breaker has 35 questions, and there is a tie in this, then, the time taken for an MSISDN to answer 35-1=34 questions will be considered. In case of a tie in this, then the time taken to answer 34-1=33 questions, and so on will be considered.

2. Gujarat Bumper Gratification

- (A) The selection for the Gujarat Bumper Gratification will be conducted at the end of the Contest Period.
- (B) One (1) MSISDN from Gujarat, with highest score in the least amount of time during the Contest Period will be selected as the winner of Rs 274,600 worth Renault Kwid STD.
- (C) In the selection of the Gujarat Bumper Gratification in case of a tie in the score and time taken, 1 round of tie-breaker will be conducted for all the tied MSISDNs on Voice. In case of a further tie in the score and time taken, in the tie-breaker, the selection will be conducted by checking the time taken by the MSISDNs to answer x-1, x-2_questions in the tie-breaker. i.e., if the tie-breaker has 35 questions, and there is a tie in this, then, the time taken for an MSISDN to answer 35-1=34 questions will be considered. In case of a tie in this, then the time taken to answer 34-1=33 questions, and so on will be considered.

3. Gujarat Monthly Gratification

- (A) The selection for the Gujarat Monthly Gratification will be conducted as per the schedule as provided in Table 1 below.
- (B) One (1) MSISDN from Gujarat, with the minimum cumulative score of 45 points, in the least amount of time, during that month will be selected as the winner of Rs 25000 worth LED TV.
- (C) One (1) MSISDN can get the Gujarat Monthly Gratification only once in the Contest Period.
- (D) In the selection of the Gujarat Monthly Gratification in case of a tie in the score and time taken, 1 round of tie-breaker will be conducted for all the tied MSISDNs on Voice. In case of a further tie in the score and time taken, in the tie-breaker, the selection will be conducted by checking the time taken by the MSISDNs to answer x-1, x-2_questions in the tie-breaker. i.e., if the tie-breaker has 35 questions, and there is a tie in this, then, the time taken for an MSISDN to answer 35-1=34 questions will be considered. In case of a tie in this, then the time taken to answer 34-1=33 questions, and so on will be considered.

4. Monthly Gratification

- (A) The selection for the Monthly Gratification will be conducted as per the schedule as provided in Table 1 below.
- (B) One (1) MSISDN across all circle groups* except Gujarat, with the minimum cumulative score of 25 points, in the least amount of time, during that month will be selected as the winner of BANK GIFT CARD of Rs. 10000.
- (C) One (1) MSISDN can get the Monthly Gratification only once in the Contest Period.
- (D) In the selection of the Monthly Gratification in case of a tie in the score and time taken, 1 round of tie-breaker will be conducted for all the tied MSISDNs on Voice. In case of a further tie in the score and time taken, in the tie-breaker, the selection will be conducted by checking the time taken by the MSISDNs to answer x-1, x-2_questions in the tie-breaker. i.e., if the tie-breaker has 35 questions, and there is a tie in this, then, the time taken for an MSISDN to answer 35-1=34 questions will be considered. In case of a tie in this, then the time taken to answer 34-1=33 questions, and so on will be considered.

NOTE: One (1) individual winner, irrespective of MSISDN can win only one of the above gratifications throughout the Contest Period.

5. Weekly Gratification

- (A) The selection for the Weekly Gratification will be conducted as per the weekly schedule as provided in Table 2 below.
- (B) One (1) MSISDN per circle group* except Gujarat, with minimum of 14 points, in the least amount of time, during that Week, will be selected as the winner of Mobile Recharge up to Rs.1000.
- (C) One (1) MSISDN can get the Weekly Gratification only once in the Contest Period.
- (D) In case of a tie in the selection of Weekly Gratification, the winner will be selected which MSISDN has achieved the score 1st in point of time.

6. Gujarat Weekly Gratification

- (A) The selection for the Gujarat Weekly Gratification will be conducted as per the weekly schedule provided in Table 2 below.
- (B) One (1) MSISDN from Gujarat Circle, with minimum of 18 points, in the least amount of time, during that Week, will be selected as the winner of a Smartphone worth Rs.5000.
- (C) One (1) MSISDN can get the Gujarat Weekly Gratification only once in the Contest Period.
- (D) In the selection of Gujarat Weekly Gratification in case of a tie in the score and time taken, 1 round of tie-breaker will be conducted for all the tied MSISDNs on Voice. In case of a further tie in the score and time taken, in the tie-breaker, the selection will be conducted by checking the time taken by the MSISDNs to answer x-1, x-2_questions in the tie-breaker. i.e., if the tie-breaker has 35 questions, and there is a tie in this, then, the time taken for an MSISDN to answer 35-1=34 questions will be considered. In case of a tie in this, then the time taken to answer 34-1=33 questions, and so on will be considered.

7. Daily 1st Gratification

- (A) Three (3) MSISDNs across circle groups* except Gujarat, with minimum of four (4) points, in the least amount of time, on that day, will be selected as the winner of Mobile Recharge worth Rs.200.
- (B) One (1) MSISDN can win Daily 1st Gratification only once in the Contest.
- (C) The winning MSISDNs will be removed from the list of eligible MSISDNs for Daily 2nd Gratification of that day.
- (D) In case of a tie in the selection of Daily 1st Gratification, the winner will be selected which MSISDN has achieved the score 1st in point of time. Example: if a MSISDN scores 4 points in 100 milliseconds on 10:30AM and another MSISDN also scores 4 points in 100 milliseconds on 11:00AM. Then the user who scored 4 points in 100 milliseconds on 10:30AM will be selected as a winner.

8. Daily 2nd Gratification

- (A) One (1) MSISDN, per circle groups* except Gujarat, with minimum of two (2) points, in the least amount of time, on that day, will be selected as the winner of Mobile Recharge worth Rs. 100.
- (B) Selection of daily 2nd Gratification will be conducted after daily 1st Gratification.
- (C) One (1) MSISDN can win Daily 2nd Gratification only once in the Contest.
- (D) In case of a tie in the selection of Daily 2nd Gratification, the winner will be selected which MSISDN has achieved the score 1st in point of time. Please refer to example in Clause 7 (D) above.

9. Gujarat Daily 1st Gratification

- (A) One (1) MSISDN, from Gujarat, with minimum of six (6) points, in the least amount of time, on that day, will be selected as the winner of BANK Gift Card worth Rs.2000.
- (B) One (1) MSISDN can win the **Gujarat Daily 1**st **Gratification** only once in the Contest Period.
- (C) The winning MSISDNs will be removed from the list of eligible MSISDNs for Gujarat Daily 2nd Gratification of that day.

(D) In case of a tie in the selection of **Gujarat Daily 1**st **Gratification**, the winner will be selected which MSISDN has achieved the score 1st in point of time. Please refer to example in Clause 7 (D) above.

10. Gujarat Daily 2nd Gratification

- (A) One (1) MSISDN, from Gujarat, with minimum of three (3) points, in the least amount of time, on that day, will be selected as the winner of Mobile Recharge worth Rs.1000.
- (B) One (1) MSISDN can win the Gujarat Daily 2nd Gratification only once in the Contest Period.
- (C) In case of a tie in the selection of **Gujarat Daily 2nd Gratification**, the winner will be selected which MSISDN has achieved the score 1st in point of time. Please refer to example in Clause 7 (D) above.

11. Assured Gratification

- (A) First 100 MSISDNs daily, across all circle groups, who attempts one (1) question on that day, will be selected as the winner of Mobile Recharge worth Rs.20.
- (B) One (1) MSISDN can win assured Gratification only once in the Contest Period.
- (C) The points scored by an MSISDN from the questions that the MSISDN is entitled to answer in a day, based on that day's charged value will only be considered for selection.
- **12. NOTE:** In the selection of the winners of all the above Gratifications except Monthly Gratifications, Gujarat Monthly Gratifications, Bumper Gratification, and Gujarat Bumper Gratification the score considered for selection will NOT include the scores accumulated by users by answering missed questions, if any and will only consider the respective question of each particular day.

Note: If a Subscriber plays the Contest over both the channels (Voice & SMS), Subscriber's score will only be cumulative and not exclusive for each of the channels. i.e.: if the Subscriber has started playing the Contest on voice and has scored 2 points in 3 questions, if Subscriber drops the call and resumes playing through SMS, Subscriber will be given the 4th question, and if Subscriber answers the question correctly, Subscriber's score will be 3. And this will be the score that will be considered for the winner selection for all the Gratifications.

(D) MODIFICATION OF TERMS AND CONDITIONS
