

## TERMS AND CONDITIONS GOVERNING THE CONTEST

### DREAM ON WHEELS SEASON 2

#### **A. INTRODUCTION**

THIS DOCUMENT IS AN ELECTRONIC RECORD IN TERMS OF THE INFORMATION TECHNOLOGY ACT, 2000 AND RULES THERE UNDER AS APPLICABLE. THIS ELECTRONIC RECORD IS GENERATED BY A COMPUTER SYSTEM AND DOES NOT REQUIRE ANY PHYSICAL OR DIGITAL SIGNATURES.

THE CONTEST IS AN OPTIONAL CONTEST CONCEPTUALIZED, ORGANIZED AND HOSTED BY ONMOBILE GLOBAL LIMITED, A COMPANY INCORPORATED UNDER THE COMPANIES ACT, 1956 AND HAVING ITS REGISTERED OFFICE AT TOWER 1, 94/1 C AND 94/2, VEERASANDRA VILLAGE, ATTIBELE HOBLI, ANEKAL TALUK, ELECTRONIC CITY PHASE 1, BANGALORE – 560 100, INDIA (HEREINAFTER REFERRED TO AS “ONMOBILE”) FOR THE ELIGIBLE RIGHTFUL SUBSCRIBERS OF VODAFONE INDIA LIMITED, AND VODAFONE MOBILE SERVICES LIMITED (HEREINAFTER COLLECTIVELY REFERRED TO AS “VODAFONE INDIA”).

ONMOBILE AND VODAFONE INDIA SHALL HEREINAFTER JOINTLY OR INDIVIDUALLY AS THE CONTEXT MAY REQUIRE BE REFERRED TO AS “ORGANIZER(S)”

THE FOLLOWING TERMS & CONDITIONS SHALL BE APPLICABLE TO ALL VODAFONE INDIA POST PAID AND PREPAID SUBSCRIBERS PARTICIPATING IN THE CONTEST KNOWN AS “DREAM ON WHEELS SEASON 2” DURING THE CONTEST PERIOD AS MENTIONED HEREIN.

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE PARTICIPATING IN THIS CONTEST KNOWN AS DREAM ON WHEELS SEASON 2. BY PARTICIPATING IN THE CONTEST, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS (“TERMS AND CONDITIONS”). IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT PARTICIPATE IN THE CONTEST.

For the purposes of these Terms and Conditions, wherever the context so requires “You” or “Your” shall mean any natural person who being an Eligible Subscriber has participated in the Contest.

#### **B. DEFINITIONS**

- (1) “**Subscriber**” shall mean the rightful subscriber of the Vodafone India mobile connection who is either on prepaid or post-paid subscription, in whose name the mobile phone number (MSISDN) is registered with Vodafone India. In the event, the subscriber’s number / connection is registered in the name of a company/ firm, the employee who is authorized to use the MSISDN shall submit a No Objection Certificate (NoC) and authorization of the employer duly permitting the employee to use the number for subscribing for this Contest and accept the terms applicable herein.

- (2) **“Active Subscriber”** shall mean a Subscriber who uses the Subscriber Identity Module (“SIM”) of Vodafone India on a regular basis for purposes other than to participate in any offer or Contest offered by Vodafone India.
- (3) **“Eligible Subscriber”** shall mean an Active Subscriber of Vodafone India who has subscribed to the Contest. An Eligible Subscriber must also satisfy the following criteria at the time of participation and during continuation of Contest –
- (i) Subscriber must be of at least 18 years of age;
  - (ii) Subscriber must be a resident of India;
  - (iii) Subscriber must be an Active Subscriber of Vodafone India;
  - (iv) Subscriber must be a Contest or Pack Member;
  - (v) Subscriber must belong to any of the telecom service circle/s mentioned below;
  - (vi) Subscriber with ‘0’ (ZERO) balance will be allowed to play for five (5) consecutive days only, but the points scored will be considered for winner selection only after successful charging. However, after five (5) Days the Subscriber, who is a pre-paid Subscriber, has less than Re. 1/Day- balance, the Subscriber will not be able to play the Contest.
  - (vii) Subscriber must not be of an unsound mind; and
  - (viii) Subscriber must not be under any legal disability e.g. insolvency, restraint by court orders etc. and / or is prohibited from entering any contractual relationship.
  - (ix) Subscriber must not have been subject of any criminal proceeding;
  - (x) Should not have ported out of Vodafone India during the Contest period.
  - (xi) Subscription will be open only in the herein mentioned Circles of Vodafone India and Subscribers roaming outside their home Circle will be barred from subscribing to the Contest and participating in any Contest thereunder.
  - (xii) Further, the Subscriber who participate in the Contest and get selected as winners of each category of gratifications in accordance with the winner selection process under the Terms and Conditions of the Contest shall be required to be the registered Vodafone India Subscribers of the winning mobile phone number and not merely the players using such mobile number (“Winner(s)”). If the Winner is not able to provide sufficient evidence to show that subscriber is the Subscriber of the winning mobile number, Organizer’s reserve the right to award the gratification to the next eligible Winner or to forfeit the gratification, at its sole discretion.

#### **C. CONTEST PERIOD**

- (a) This is a limited period Contest for Eligible Subscribers of Vodafone India, available from 06 January 2018, 00:00:01 hrs. till 05 April 2018, 23:59:59 hrs., both days inclusive (**“Contest Period”**);

- (b) Organizer's reserves the right to extend or shorten the Contest Period, as it deems fit.

#### **D. CONTEST AREA**

- (a) The Contest is valid in select Indian cities / telecom service areas as mentioned Table -1 below –

- (i) Notwithstanding the foregoing, if the operation of or participation in the Contest is prohibited in any State and/or territory or part thereof as per applicable law, the Subscribers from such State and/or territory or part thereof shall not be eligible to subscribe to or participate in the Contest. Vodafone India or OnMobile shall give no further notice in this regard.

#### **E. CONTEST DETAILS – ACTIVATION, STEPS AND RESTRICTIONS**

##### **(a) Subscription to Contest**

Subscribers can initiate participation in the Contest by sending the SMS keyword 'ACT DO' to 199 (FREE) or alternatively by calling the number 556770 (toll free) or dialling the Unstructured Supplementary Service Data (**USSD**) string \*567\*910# from a Vodafone India number.

##### **(b) Un-Subscription from the Contest**

If, Subscriber wish to discontinue participating in the Contest, Subscriber should send 'CAN DO' as an SMS to the 199 or alternatively by calling the number **556770** and pressing '1' from a Vodafone India number.

(c) To Play

To play the contest Subscriber shall send SMS keyword 'GET' to 556770 (free) or alternatively by calling the number 556770.

NOTE: Applicable only for Subscription contests.

(d) Total number of questions:

There are total 540 number of questions which will be randomly asked from the Subscriber for the purpose of this Contest.

(i) Charging

Note: Fall-back/Missed charging feature available:

Subscribers with status as 'Suspended' will be allowed to play only for five (5) consecutive days.

Subscribers who are charged Re. 1 will receive three (3) questions.

Subscribers who are charged Rs. 2 will receive four (4) questions.

Subscribers who are charged Rs. 3 will receive five (5) questions.

Subscribers who are charged Rs. 4 will receive six (6) questions.

Note: Fall-back charging will not be applicable for post-paid Subscribers as charging happen on base price.

(ii) Contest Flow

**1. Contest on Voice:**

- (a) Subscribers will be informed of the rules, gratifications and Terms and Conditions of the Contest upon Subscription.

- (b) After every question and answer options, a 'beep' will be played. Subscriber will have to answer by choosing one of the options only after the 'beep' is played.
- (c) After every answer input, next question and the answer options will be given to the Subscriber. After every wrong answer, the Subscriber will be played an appropriate prompt (e.g. "Sorry! That's a wrong answer ") and given the next question and answer options.
- (d) To listen to a question again Subscribers may press (\*).
- (e) If a Subscriber discontinued playing the Contest, then the Subscriber may resume playing by Subscribing as per Subscription details provided above for Subscription. If for example, a Subscriber stops playing the Contest after answering question no. 9 then if the Subscriber calls again with the same number, the Subscriber will be played question no. 10 question. If for example, a Subscriber listens to the 9<sup>th</sup> question but drops the call without answering the 9th question, then, if the Subscriber calls again, the Subscriber will be played the 9th question which may be different from what the Subscriber has earlier received.
- (f) If a Subscriber stops playing the Contest after answering the question no. 9, then the Subscriber will be sent a reminder SMS on the Subscriber's number registered with Vodafone India followed by another question and answer options. In case the Subscriber does not answer this question, the Subscriber will be engaged three (3) times a day with questions and answer options via SMS.
- (g) The Subscriber can play this contest only once.

## **2. Missed Questions Feature:**

- (a) After Subscriber finishes answering all questions for the day, if Subscriber is charged for the day, that day's score will be added to the total score. If the Subscriber is not charged that day's score will not be added to the total score. Communication to charged Subscriber of the day and not charged Subscriber of the day will be different. (E.g. Charged subscriber will get the communication "Now you can play the missed questions for the day". A not charged Subscriber will get the communication "Press 8 to get charged and play missed questions of the day")
- (b) Post calculations as specified in (a) above, the OnMobile system will check for the questions that were missed earlier and in case there are any missed questions then Subscriber will be redirected to the missed questions flow else exit prompt is played.
- (c) The Subscriber will be redirected to press "8" button on IVR as a consent and get charged to play the missed questions of earlier days.
- (d) If there are missed questions on earlier days, then first Subscriber will be given the missed questions for the days when the Subscriber was charged and then he will be given the missed questions for the non-charged days.
- (e) Before presenting the question for any non-charged day, the Subscriber will be asked to give consent for getting charged for that particular day. Once the Subscriber has given

its consent and is charged successfully, he will be presented with set of questions for that day.

**(iii) GRATIFICATIONS AND WINNER SELECTION PROCESS**

**(1) Bumper Gratification**

- (a) The selection for the Bumper Gratification will be conducted at the end of the Contest Period.
- (b) One (1) MSISDN across all circle groups except Gujarat\*, with the minimum cumulative score of 100 points, in the least amount of time during the Contest Period will be selected as the winner of a KTM Duke 200 up to Rs.190,000.

**(2) Gujarat Bumper Gratification**

- (a) The selection for the Gujarat Bumper Gratification will be conducted at the end of the Contest Period.
- (b) One (1) MSISDN from Gujarat, with the maximum points, in the least amount of time during the Contest Period will be selected as the winner of Renault Kwid RXT up to Rs.340, 000.

**(3) Monthly Gratification**

- (a) The selection for the Monthly Gratification will be conducted as per Table 3 below.
- (b) One (1) MSISDN across all circle groups\* except Gujarat, with the minimum cumulative score of 30 points, in the least amount of time, during that month will be selected as the winner of a smartphone worth Rs. 20,000.
- (c) One (1) MSISDN can get the Monthly Gratification only once in the Contest Period.

**(4) Gujarat Monthly Gratification**

- (a) The selection for the Gujarat Monthly Gratification will be conducted as per Table 4 below
- (b) One (1) MSISDN, from Gujarat, with the minimum cumulative score of 36 points, in the least amount of time, during that month will be selected as the winner of a Bank Gift Card worth Rs.50, 000.

- (c) One (1) MSISDN can get the Gujarat Monthly Gratification only once in the Contest Period.

**Note:** One (1) individual winner, irrespective of MSISDN can win only one of the above Gratifications.

- In the selection of the Bumper Gratification, Gujarat Bumper Gratification, Monthly Gratification and Gujarat Monthly Gratification, in case of a tie in the score and time taken, One (1) round of tie-breaker will be conducted for all the tied MSISDNs on Voice. In case of a further tie in the score and time taken, in the tie-breaker, the selection will be conducted by checking the time taken by the MSISDNs to answer x-1, x-2 questions in the tie-breaker. i.e., if the tie-breaker has 35 questions, and there is a tie in this, then, the time taken for an MSISDN to answer 35-1=34 questions will be considered. In case of a tie in this, then the time taken to answer 34-1=33 questions, and so on will be considered.

**(5) Weekly Gratification**

- (a) The selection for the Weekly Gratification will be conducted as per Table 5 below.
- (b) One (1) MSISDN per circle group\* except Gujarat, with the minimum 12 points, in the least amount of time, during that Week, will be selected as the winner of Mobile Recharge worth Rs.2,000.
- (c) One (1) MSISDN can get the Weekly Gratification only once in the Contest Period.

**(6) Gujarat Weekly Gratification**

- (a) The selection for the Weekly Gratification will be conducted as per Table 6 below.
- (b) One (1) MSISDN from Gujarat Circle, with minimum 18 points, in the least amount of time, during that Week, will be selected as the winner of Bank Gift Card worth Rs.10,000.
- (c) One (1) MSISDN can get the Weekly Gratification only once in the Contest Period.

Note: In the selection of the Gujarat Weekly Gratification, in case of a tie in the score and time taken, One (1) round of tie-breaker will be conducted for all the tied MSISDNs on Voice. In case of a further tie in the score and time taken, in the tie-breaker, the selection will be conducted by checking the time taken by the MSISDNs to answer x-1, x-2\_questions in the tie-breaker. i.e., if the tie-breaker has 35 questions, and there is a tie in this, then, the time taken for an MSISDN to answer 35-1=34 questions will be considered. In case of a tie in this, then the time taken to answer 34-1=33 questions, and so on will be considered.

**(7) Daily Gratification**



- (a) One (1) MSISDN, per circle groups except Gujarat\*, with the score of at least 3 points, in the least amount of time, on that day, will be selected as the winner of Mobile Recharge worth Rs.250.
- (b) One (1) MSISDN can win Daily Gratification only once in the Contest Period.

**(8) Gujarat Daily Gratification**

- (a) Two (2) MSISDNs, from Gujarat, with the score of at least 6 points, in the least amount of time, on that day, will be selected as the winner of Mobile Recharge worth Rs.1,000.
- (b) One (1) MSISDN can win the Gujarat Daily Gratification only once in the Contest Period.

**(9) Assured Gratification**

- (a) First 3000(Three Thousand) MSISDNs, across all circle groups\*, who played at least 2 questions, will be selected as the winner of Mobile Recharge of Rs.20.
- (b) One (1) MSISDN can win assured Gratification only once in the Contest Period.

**Note:** (a) In case of a tie in the selection of any of the above Daily Gratifications and Weekly Gratification except Gujarat Weekly Gratification, the winner will be the MSISDN which has achieved the score 1st in point of time. The points scored by an MSISDN from the questions that the MSISDN is entitled to answer in a day, based on that day's charged value will only be considered for selection.

- (b) In the selection of the winners of all the above Gratifications except Monthly, Gujarat Monthly, Bumper Gratification, and Gujarat Bumper Gratification the score considered for selection will NOT include the scores accumulated by users by answering missed questions if any and will only consider the respective question of each particular day.
- (c) Scores of users who are charged later for the earlier days will be considered ONLY for Monthly, Gujarat Monthly, Bumper Gratification, and Gujarat Bumper Gratification.
- (d) The time taken for answering a question on "Voice" mode, is calculated from the time OnMobile's system plays beep (after question) till the answer DTMF input received by system. On SMS channel time taken is calculated from the time system pushes the question till the answer input received by system.
- (e) A Subscriber is eligible to win more than one gratification during the Contest Period, which means that Subscriber can win more than one gratification provided Subscriber meets the above said criteria of the respective Gratifications and will get selected.

Note: If a Subscriber plays the Contest over both the channels (Voice & SMS), his/her score will only be cumulative and not exclusive for each of the channels. i.e., if the Subscriber has started playing the Contest on voice and has scored 2 points in 3 questions, if Subscriber drops the call and resumes playing through SMS, Subscriber will be given the 4th question, and if Subscriber

answers the question correctly, his/her score will be 3 and this will be the score that will be considered for the winner selection for all the Gratifications.
