

## TERMS AND CONDITIONS – “Win family passes for Aladdin Show” contest

Please read the following terms and conditions carefully before participating in this contest known as **participate and win a family passes for Aladdin show contest**. By proceeding to participate in “**Win family passes for Aladdin Show” contest**, you hereby agree to abide by all the terms and conditions (“**terms and conditions**”) of this contest.

There shall be five (5) winners selected by computer system. The winner be contacted by Vodafone and Vodafone will inform location to the winner to collect the passes.

Each winner will be eligible for up to a maximum of four (4) passes to the Aladdin show in Mumbai @ NCPA , Mumbai
