TERMS AND CONDITIONS VODAFONE ONASADHYA 2017

I. INTRODUCTION

This document is an electronic record in terms of the Information Technology Act, 2000 and Rules there under as applicable. This electronic record is generated by a computer system and does not require any physical or digital signatures.

The offer is gratuitous and optional, conceptualized, organized and hosted by Vodafone Mobile Services Limited, a company incorporated under the companies act, 1956 and having its registered office at Peninsula Corporate Park, Ganpatrao Kadam Marg, Lower Parel, Mumbai – 400 013, India (hereinafter referred to as "organizer" or "VMSL") for the eligible rightful subscribers of VMSL.
