



## TERMS AND CONDITIONS GOVERNING THE CHALLENGE

### Stop the GIF

#### A. INTRODUCTION

THIS **Stop the GIF Contest** (HEREINAFTER “**CHALLENGE**”) IS OPTIONAL FOR **VODAFONE IDEA LIMITED** (HEREINAFTER REFERRED TO AS “**VIL**”) SUBSCRIBERS OF VODAFONE BRAND. THE ELIGIBLE SUBSCRIBER/S PARTICIPATING IN THE CHALLENGE SHALL BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS. IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT PARTICIPATE IN THE CHALLENGE

#### B. DEFINITIONS

a. “**Eligible Subscriber/You**” shall mean a subscriber in whose name the mobile phone number under Vodafone brand Subscriber Identity Module (SIM) is registered with VIL.

#### C. CHALLENGE DETAILS

i) **Challenge Period:** 29<sup>th</sup> Jan to 1<sup>st</sup> Feb, 2020. VIL reserves the right to extend or shorten the Challenge Period, as it deems fit. If, in any State and/or territory or part thereof, the running of this Challenge is prohibited as per local rules or laws, the Eligible Subscribers from such State and/or territory or part thereof shall not be eligible to participate in the Challenge. No further notice shall be given by VIL, in this regard.

ii) **Challenge Description, Selection Process and Gratification:**

- a. **Activity:** As a chance to customers to win passes for Comic Con, Ahmedabad, we conduct a ‘Stop the GIF’ activity on social media.
  - i. **Facebook:** Fans must stop the running Super Zoozoo in the highlighted area, share a screenshot online in the comments section of the Facebook sponsored post with the hashtag #Zooniverse
  - ii. **Instagram:** Fans must upload the screenshot (as mentioned above) on their profile along with tagging @Vodafoneindia (on Instagram) and using #Zooniverse. Their profile has to be public in order to receive consideration for the entry.
  - iii. Winners of the same, stand a chance to win couple passes for Comic Con, Ahmedabad
- b. **Method of Selection:** An external auditor to evaluate and select 100 best entries on the parameters of originality, creativity etc. and should not contain entries like any harmful, harassing, blasphemous, defamatory, obscene, libellous, invasive of another's privacy. The decision of the auditor in this regard shall be final and binding, no dispute, shall be entertained by VIL.
- c. **Gratification:** Comic Con, Ahmedabad couple passes will be given as a gratification. The same should be redeemed as per the terms & conditions and within the validity period stipulated therein. No requests will be entertained for stolen/lost/misplaced/damaged passes.

#### D. **OTHER CONDITIONS:**

- a. Multiple entries of the same individual/participant through single or multiple IDs will be disallowed.
- b. The participant, for any video taken of any other person/third party, must take full responsibility of taking consent from such person/third party used in the video before submitting his/her entry.
- c. Participant should not
  - i. Do any reverse engineering, hacking or bugging of the Challenge page to manipulate its operation;
  - ii. Submit the entries with the content which violates applicable laws or infringes third party rights.

- d. In consideration of participation in the Challenge, each participant grants a license to VIL to feature any or all of the submitted materials/entries in any or all media for publicity and communication purposes.
- e. The winner agrees to participate in all promotional activity relating to the Challenge and further consents to VIL using his/her name, likeness, photo, image, and/or voice to picture, tape or portray him/her as a Challenge winner in any or all media.
- f. The contest is open to people residing in Ahmedabad, Rajkot, Baroda and Surat only
- g. VIL is neither responsible nor guarantees the quality of the goods/services being offered as gratification(s) as offered under Comic con passes.
- h. All incidental costs/taxes/levies related to the gratification(s), if any, shall be exclusively borne by the winner.
- i. The gratification will be subject to compliance with applicable documents and formalities as required by VIL.
- j. The gratification cannot be assigned or transferred.
- k. The Challenge cannot be used in conjunction with any alternative contest or promotion.
- l. VIL shall not be responsible for any claims arising out of technical failures before, during or after the completion of the Challenge including but not limited to any technical failures in the mobile connectivity, internet connectivity. Further, VIL shall not be responsible for any claims arising out of any failure(s) which is beyond the reasonable control of VIL.
- m. The participant hereby agrees and undertakes not to hold VIL and/or any of their group entities or affiliates, their respective directors, officers, employees, agents, vendors, responsible for or liable for, any actions, claims, demands, losses, damages, costs, charges and expenses, either direct or remote that you may/might have suffered, sustained or incurred, or claim to suffer, sustain or incur, by way of and /or on account of this Challenge.
- n. The employees of VIL and their group companies, affiliate or associate companies shall not be eligible to participate in the Challenge.
- o. Post selection of winners, the Comic Con passes can be collected from the Vodafone stall at the entrance of the venue at GUCEC, Memnagar, Ahmedabad during the period the event is open on 1<sup>st</sup> & 2<sup>nd</sup> Feb 2020.
- p. VIL reserve the right to extend, cancel, discontinue, prematurely withdraw, change, alter or modify this Challenge or any part thereof including the eligibility criteria, other terms & conditions and gratification(s) at their sole discretion at any time during its validity. You are therefore advised to check Website regularly for any update(s) or amendment(s) made to these terms and conditions.
- q. These Terms and Conditions are subject to laws of India. Any disputes or any matter arising here from will be referred to a Sole Arbitrator to be appointed by VIL whose decision shall be final and binding on the parties in accordance with arbitration proceeding under the Arbitration and Conciliation Act, 1996. The place of Arbitration shall be at Mumbai. The language of Arbitration Proceeding shall be English.
