

TERMS AND CONDITIONS -DRIVE HOME YOUR DREAM CAR COMPETITION

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE PARTICIPATING IN THIS COMPETITION KNOWN AS "DRIVE HOME YOUR DREAM CAR COMPETITION". BY PROCEEDING WITH PLAYING THE DRIVE HOME YOUR DREAM CAR COMPETITION, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS ("Terms and Conditions"). Terms and Conditions

"DRIVE HOME YOUR DREAM CAR COMPETITION" (hereinafter referred to as the "Competition") is conceptualized, organized and hosted by OnMobile Global Limited, a company incorporated under the Companies Act, 1956 and having its registered office at Tower# 1 94/1 C & 94/2, Veerasandra Village, Attibele Hobli, Anekal Taluk, Electronic City Phase 1, Bangalore- 560100- India ("OnMobile" or "Organizer") for enabling active subscribers, who use the Vodafone India Subscriber Identity Module ("SIM") on a regular basis for purposes other than to participate in the Competition, prepaid or post-paid category of Subscribers who are the rightful user of the Vodafone India connection, in whose name the mobile phone connection number ("MSISDN") is registered with Vodafone India (hereinafter referred to as "Subscriber(s)") as specified in Circles stated in Clause 2 herein, of either Vodafone India Limited, Vodafone Mobile Services Limited, Vodafone West Limited, Vodafone East Limited, Vodafone South Limited, Vodafone Digilink Limited, Vodafone Cellular Limited and Vodafone Spacetel Limited (hereinafter individually or collectively referred to as "Vodafone India") to participate in the Competition. In the event the MSISDN is registered in the name of a company/ firm, the employee who is authorized to use the connection shall submit a No Objection Certificate (NoC) and authorization of the employer duly permitting the employee to use the number for participation in the Competition, receive the prizes and accept the terms applicable for the Competition. The Competition is open to Subscribers during the period from 14th February 2015, 00:00:01 hrs to 14th May 2015, 23:59:59 hrs ,both days inclusive (hereinafter referred to as the "Competition Period"). Organizer reserves the right to extend or shorten the Competition Period, as it deems fit.
- 2. The Competition is open for all active Subscribers who satisfy the eligibility criteria mentioned in Clause 3 below and who belong to the following Vodafone India telecom circles ("Circle(s)") of ANDHRA PRADESH, ASSAM, NORTH EAST, BIHAR, DELHI, JAMMU & KASHMIR, GUJARAT, HARYANA, KARNATAKA, KERALA, MAHARASTRA, MADHYA PRADESH, ORISSA, MUMBAI, PUNJAB, HIMACHAL



PRADESH, RAJASTHAN, UTTAR PRADESH EAST, UTTAR PRADESH WEST, KOLKATA, WEST BENGAL, CHENNAI and TAMIL NADU. Notwithstanding the foregoing, if the operation of or participation in the Competition is prohibited in any State and/or territory or part thereof as per applicable law, the Subscribers from such State and/or territory or part thereof shall not be eligible to subscribe to or participate in the Competition. No further notice shall be given by the Organizer or Vodafone India, in this regard.

3. Eligibility

This Competition is open for participation for all Subscribers who fulfil the following criteria:

- 1. He/she must be of or above 18 years of age;
- 2. He/she must be a resident of India;

- 4. He/she must be an active Subscriber;

- Warrant the accuracy, truthfulness and currency of all information that You have submitted; and

- Confirm and undertake that You will make an informed choice regarding the option to play
 through voice on Interactive Voice Response ("IVR") or Out Bound Dialer, Short Message Service
 ("SMS") or on Unstructured Supplementary Service Data ("USSD") and after understanding the
 implications of the same.



The Competition will be available in the below mentioned languages:

English, Hindi, Gujarati, Marathi, Punjabi, Bengali, Malayalam, Telugu, Kannada, Oriya and Tamil on IVR ("Interactive Voice Response") and in English and Hinglish languages on Short Message Service ("SMS").

A Participant, by participating in the Competition, hereby agrees to the Terms and Conditions mentioned below and gives his/her irrevocable consent to the process of selecting the Winners under this Competition as set out herein, and any appropriate changes that may be made to this Competition by the Organizer including due to any legal or regulatory requirement, instructions from any judicial or a quasi-judicial body or due to any natural calamity beyond the reasonable control of the Organizer or Vodafone India, its affiliates and associates or for any reason whatsoever. 5. Charging:

- The questions in the Competition are divided into 10 sets ("Set(s)") having different number of questions in each Set. All Participants of the Competition will be charged as follows depending upon the mode of playing the Competition chosen by them:

(iv)The charged amount will not be refunded to Participants under any circumstances.

6. Questions and Scoring

- The Competition consists of 750 questions with 2 answer options each.
- All questions under this Competition shall be based on information available to the public at large.
- Set 1 will consist of 5 questions, Set 2 will consist of 10 questions, Set 3 will consists of 15 questions, Set 4 will consist of 20 questions, Set 5 will consist of 30 questions, Set 6 will consist of 50 questions, Set 7 will consist of 100 questions, Set 8 will consist of 170 questions, Set 9 will consist of 200 questions and Set 10 will consist of 150 questions, which may be played by the Participants.
- All Participants may choose to play all questions at once, else he/she can continue playing the
 questions on any of the days during the Competition Period.
- For every right answer the Participant will get 1 point. There is no negative marking for a wrong answer.
- The Participant will be sent the questions one after the other till he/she finishes answering all the questions of the Competition.

7. Competition on Voice

- This will be followed by question and answer options on USSD channel.

 After every right or wrong answer, the Participant will be sent one USSD message with the right or wrong answer response, along with the score details and the next question and answer options.



- In case of an invalid USSD input by the Participant, the Participant is sent a message on USSD stating that the input provided by him/her is invalid and will contain details of how to answer the question correctly. This will be followed by another question and answer options.
- If a Participant stops playing after answering the nth question then when he/she dials USSD string *567*7# again, he/she will get the (n+1)th question on USSD.
- The Participant is given the questions one after the other till he/she finishes answering all the questions.
- Once the Participant answers all the questions, an exit message will be sent as a USSD. The same
 will happen if the Participant dials USSD string after he/she has answered all the questions or if
 he/she tries to answer a question after having answered all the questions.

10. Competition on OBD

Competition will be available for playing on OBD. Once the Participant has successfully been accepted as a participant to the Competition, a welcome prompt is played to the Participant that introduces him/her to the Competition.

Participants will be informed of the rules, prizes to be won and Terms and Conditions URL of the Competition on the OBD.

Participants can press * to listen to a question again.
