

Terms and Conditions of the "Durga PujoFestival Offer"

September 25, 2015

- 1. The Durga Pujo Festival Offer (hereinafter referred to as the "Offer") is organized by Vodafone East Limited (hereinafter referred to as "Vodafone") for its valid prepaid and postpaid Subscribers of Kolkata circle (hereinafter referred to as the "Subscribers") subject to the terms and conditions mentioned herein.
 - 2. The Offer starts from 7th October '15, 00:00:01 hours and shall be valid till 24th October '15, 23:59:59 hours (both days inclusive)(hereinafter referred to as "Offer Period").
 - 3. To be eligible for participation in this Offer, the Subscriber has to upload Durga Pujo celebration photograph on the URL www.facebook.com and tag it with the hashtag #VodafonePujo along with the following conditions:
 - i. Subscriber shall only capture in the uploaded photograph.
 - ii. The Subscriber shall not put him/herself at risk while taking photographs.
 - iii. The Subscriber shall avoid vulgarity in the photographs.
 - iv. The Subscriber shall not use profanity in his/ her posts, comments, hashtags, etc.

Prepaid Subscribers:

Postpaid Subscribers:

Free Data upto 3GB 3G per bill cycle for 12 bill cycles.

Company owned Company Paid subscribers of Vodafone will not be able to avail this Festival Offer.

* Post utilisation of 3 GB of Free Data's the speeds will be throttled upto 64 KBPS



- 6. Subscribers availing any specific offer along with handset of Vodafone would not be eligible to avail this Offer.
- 7. The 2G benefit will be forfeited on existing 2G data plan/pack once this Offer is activated on the number of the winner who avails this Offer.
- 8. Subscribers selected for the Durga Pujo Festival Offer having an existing MI pack on their number would be able to take either of the one, either Durga Pujo Festival Offer or existing MI pack. Both MI pack & Durga Pujo Festival Offer cannot be taken simultaneously.
