



TERMS AND CONDITIONS OF FLASH CAR JEETO COMPETITION

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE SUBSCRIBING TO AND PARTICIPATING IN THIS COMPETITION KNOWN AS “**FLASH CAR JEETO COMPETITION**”. BY PROCEEDING WITH SUBSCRIPTION TO THE **FLASH CAR JEETO COMPETITION**, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS (“**Terms And Conditions**”). IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT SUBSCRIBE TO THE **FLASH CAR JEETO COMPETITION**. **PARTICIPATION IN THIS COMPETITION IS PURELY VOLUNTARY.**

TERMS:

- 1.** This **FLASH CAR JEETO COMPETITION** (hereinafter referred to as the “**Competition**”) is conceptualized, hosted, organized and conducted by Celltick Mobile Media(India) Private Limited, a company incorporated under the Companies Act, 1956 and having its registered office at, 111/A Wing, Everest Grande, Opp Ahura Centre, Mahakali Caves Road, Andheri-East, Mumbai -400 093 (hereinafter referred to as “**Celltick**” or “**Organizer**”), for enabling active subscribers, who use the Subscriber Identity Module (“**SIM**”) on a regular basis for purposes other than to participate in the competition, pre-paid or post-paid category of Subscribers who are the rightful user of the Vodafone connection, , in whose name the mobile phone connection number (MSISDN) is registered with the Vodafone India (hereinafter “**Subscribers**”) as specified in circles stated in point 2 herein, of either Vodafone India Limited, Vodafone Mobile Services Limited, Vodafone West Limited, Vodafone East Limited, Vodafone South Limited, Vodafone Digilink Limited, Vodafone Cellular Limited and Vodafone Spacetel Limited (hereinafter collectively referred to as “**Vodafone India**”) to subscribe in the Competition and participate therein. In the event the number / connection is registered in the name of a company/ firm, the employee who is authorized to use the connection shall submit a No Objection Certificate (NoC) and authorization of the employer duly permitting the employee to use the number for participation in the Competition, receive the prizes and accept the terms applicable for the Competition. The Competition is open to Subscribers during the period from **10-10-2014** from **00:00:01 hrs to 08-11-2014** till **23:59:59 hrs**, (hereinafter referred to as the “**Competition Period**”). Organizer reserves the right to extend or shorten the Competition Period, as it deems fit.
This is a Pay Per Use (“**PPU**”) product and broadcast will be sent on a daily basis.
- 2.** The Competition is open for all Subscribers who satisfy the eligibility criteria mentioned below and who belong to the following Vodafone India telecom circles (“**Circle(s)**”) of ANDHRA PRADESH, ASSAM AND NORTH EAST, BIHAR, DELHI, GUJARAT, HARYANA, JAMMU AND KASHMIR, KARNATAKA, KERALA, KOLKATA, MAHARASTRA, MADHYA PRADESH, MUMBAI, ORISSA, PUNJAB, RAJASTHAN, UTTAR PRADESH EAST, UTTAR PRADESH WEST AND WEST BENGAL, , TAMIL NADU and CHENNAI. This competition will not be applicable for subscribers in Himachal Pradesh.
- 3.** A Subscriber by participating in the Competition, hereby agrees to the Terms and Conditions mentioned herein and gives his/her irrevocable consent to the Terms and Conditions including to the procedure for winner selection of the Competition as set out herein, and any appropriate changes that may be made to this Competition by the Organizer or Vodafone India including due to any legal or regulatory requirement, instructions from any judicial or a quasi-judicial body or due to any natural calamity beyond the reasonable control of Vodafone India or Celltick, their affiliates and associates or for any reason whatsoever.



4. For the purposes of these Terms and Conditions, wherever the context so requires “You” or “Your” shall mean any natural person who is a Subscriber.
5. Also, by participating in this Competition, You:
 - Agree that you have carefully read and understood the Terms and Conditions of the Competition and consented to be bound the same;
 - Warrant the accuracy, truthfulness and currency of all information that You may have submitted;
 - Agree that You are entering into this Competition as an independent party and nothing herein establishes an employer-employee relationship between You and Vodafone India or between You and Celltick and You are acting voluntarily, using Your own time and resources to participate in the Competition, solely at Your own risk; and
 - Warrant that prior to playing the Competition, it shall be deemed that You have read, understood and have agreed to be bound by the Terms and Conditions herein.
6. Participation in the Competition will be construed as an acknowledgement and acceptance of the Terms and Conditions set out herein and You further agree to be bound by the Terms and Conditions stated herein.
7. Subscribers who are roaming outside their home circle will also be entitled for participating in the Competition, except if Subscriber is roaming in Himachal Pradesh where in case of any Subscriber who is travelling to that circle will not be able to play the competition as the service is not live in that circle. In such a scenario the customer will be able to play the competition only when he is back in the eligible circles.
8. These Terms and Conditions are available on the Website of the Organizer at the following address: www.celltick.com/flashcarjeeto (“Website”). The Terms and Conditions can be amended or varied from time to time or withdrawn without any prior notice and therefore, please visit the Website to keep Yourself updated and informed.

9. Procedure and Eligibility to participate in the Competition

This Competition is valid for Subscribers who fulfill the following criteria:

- He/she must be of at least 18 years of age;
- He/she must be a resident of India;
- He/she must be an existing active Subscriber of Vodafone India;
- He/she must belong to any one of the Circles mentioned in Clause 2 above;
- He/she must not be of an unsound mind; and
- He/she must not be under any legal disability e.g. insolvency, restraint by court order etc. and / or is prohibited from entering any contractual relationship.

Further, the Subscribers who participate in the Competition and are chosen as winners of each category of prize in accordance with the winner selection process under the Terms and Conditions of the Competition shall be required to be the registered Vodafone India Subscribers of the winning mobile phone number and not merely the players using such mobile number (“Winner”). If the



Winner is not able to provide sufficient evidence to show that he/she is the Subscriber of the mobile number, the Organizer reserves the right to award the prize to the next eligible Winner or to forfeit the prize, at its sole discretion.

If, in any State and/or territory or part thereof, the running of this Contest is prohibited as per local rules or laws, the Subscribers from such State and/or territory or part thereof shall not be eligible to participate in the Contest. No further notice shall be given by the Organizer or Vodafone India, in this regard.

10. To subscribe to the Competition:

The Competition is valid for all active Vodafone India Subscribers who could either be a prepaid or postpaid user.

- To play the Competition, Subscribers need to just play the competition from the home screen (through Flash broadcasts (on Active Flash enabled SIM's).
- Subscribers can also play the competition by sending SMS "flash jeeto" for Competition activation to short code 12320.
- There is no additional amount charged while activating Vodafone Flash.
- Competition will be available via broadcasts on all Active Flash enabled SIMs.
- Participating Subscriber ("Participant(s)") can answer the competition questions @Rs. 5 per question.
- Each correct answer is worth 1 point.
- Prizes will be for daily, weekly and monthly winners.
- **There are 3 bumper prizes whereby top 3 customers who have accumulated highest points for the entire month will stand a chance to win the bumper prizes(details mentioned below in the grid)**
- Before the launch of every competition all the existing Subscribers will be sent promotional broadcasts, informing them of the upcoming competition, the prizes and its charges.
- Users without Vodafone Flash SIMs can upgrade their SIMs to Vodafone Flash enabled SIMs from any of the Vodafone stores to play the Competition.

11. Competition Flow

- Competition will be open in **all the above mentioned circles** as stated in point 2 herein above of Vodafone India.
- All Vodafone active Subscribers can play this Competition via broadcasts.
- Users will receive several broadcasts a day, promoting a competition that will entitle the maximum point winner to a defined prize.
- As users start answering the questions, they would be presented with more and more questions and opportunities to answer them for gaining more points and increasing the possibility of winning.
- On answering each question the user will be informed about his current score followed by the next question.
- Participants on answering the questions will be charged Rs. 5/- per question answered through broadcasts.
- Participants will score one point for every right answer. There will be no negative marking for wrong answers.



- The questions have 3 answer options each.
- The 4th option in menu will be the info (more info, Competition details). A click on this will be Toll Free and after reading the information message/details user will have an option to go back to the Competition question and continue playing.
- The score counter will be set to ZERO at the beginning of the Competition and then again back to Zero at the end of the Competition Period.
- In case the participant stops playing the Competition and if he comes back to play the Competition after a gap of days, then he starts back with the last accumulated points at what he stopped playing the Competition.

12. Charging:

Subscriber can start playing the Competition anytime during the validity of the Competition, the Subscriber will be charged Rs. 5/- per question played in the Competition. In case if the subscriber does not wish to play the competition then all he needs to do is not answer the questions.

13. Competition Promotion

- Through broadcasts – Active Vodafone Flash enabled users will receive periodic broadcasts in a day.
- Non-Flash users will have to acquire a Vodafone Flash enabled SIM from the Vodafone Store.
- Competition will be available in English on Cell broadcast/SMS.

14. Competition Period

The Competition starts on the proposed date 10-10-2014 at 00:00:01 hours and closes on last day of 08-11-2014 at 23:59:59 hours (“**Competition Period**”) and during this Competition Period it is open for either a prepaid or a post-paid subscriber. (The duration and start/end dates will depend on the theme and will be mutually decided between Vodafone India and Celltick)

15. Selection of successful winners –

The prizes that the winner to the Competition wins is purely owing to his/her participation to the Competition and based on the performance and meeting of the selection criteria of Competition, as laid out in the Terms and Conditions. These prizes to the winning Subscriber shall be distributed by Celltick through any means, and at any time, upon such terms and conditions as it may deem fit.

The selection process of the successful winners for the prizes in this Competition will be as follows:

The selection for the winner will be conducted after the end of Competition Period (except for the daily winners who would be short listed on a daily basis). The selection of the winners will be done purely basis the logs and data containing time, duration and the number of answers given by each customers and total points accumulated by the customers as verified and certified by the independent auditor appointed by the Organizer. The MSISDN with the highest



scores basis the logs and data verified by independent auditor will be the winner. In case of a tie, the participant who has reached the score earlier basis the time stamp will be chosen as the winner.

Daily Winners Selection – The winners for these will be selected basis the highest cumulative points achieved for the particular day across all Vodafone circles, 1 winner will be selected with the highest cumulative points achieved across all Vodafone circles each day for 30 days, Daily winners gratification will be disbursed post 3 days of the winning date by the Organiser. In case of a daily winner, Winner will be shortlisted the next day post which Celltick will share the MSISDN to Vodafone who will confirm the winner details. On getting confirmation from Vodafone, Celltick will forward the daily talk time to the Winner. The daily winners will be selected each day basis the highest cumulative points achieved on a pan India Level across all circles, Rs.1500/- recharge for top scorer of the day, Rs.1000/- recharge for second top scorer and Rs.500/- recharge for third top scorer for 30 days, total of 90 winners for 30 days of the competition (Rs.90000/-), In case if the customer is a postpaid customer then we shall credit his postpaid account with Rs.1500/-, Rs.1000/-, Rs.500/- respectively.

Weekly Winner Selection – The winner for these will be selected basis the highest cumulative points achieved for the week for a customer across all Vodafone circles. Weekly prizes will be given post end of the competition period. Each week there will be 1 prize selected whereby 1 customer will be selected every week basis the highest cumulative points achieved for the week on a pan India basis across all circles, 1 winner each for every week, total of 5 winners, each winner gets Sony Still Camera DSCW830 Black. (total Rs.45000/-)

Bumper 1st Prize Selection - The winner for these will be selected basis the highest cumulative points achieved for the month. Bumper 1st prize will be given post end of the competition period. There is only one 1st Bumper prize which will be selected basis highest cumulative points over a period of the competition period. The winner will be given Maruti Suzuki Alto K10 LXI (998cc Petrol, Manual, 20.2 kpl). – Ex showroom price. The winner has to bear registration, insurance and other charges if any. The total amount of the gratification is Rs. 4,20,000 /- including TDS, which will be borne by the Organizer.

Bumper 2nd Prize Selection - The winner for these will be selected basis the 2nd total highest cumulative points achieved for the month for a customer across all Vodafone circles. Bumper 2nd prize will be given post end of the competition period. There is only one 2nd Bumper prize which will be selected basis highest cumulative points over a period of the competition period across all Vodafone circles Royal Enfield Classic 350 Standard (346cc, Petrol, Manual, 30 kmpl) to be given to the 2nd Bumper prize winner Ex Showroom price. The winner has to bear registration, insurance and other charges if any. The total amount of the gratification is Rs. 1,80,000 /- including TDS, which will be borne by the Organizer.

Bumper 3rd Prize Selection - The winner for these will be selected basis the 3rd total highest cumulative points achieved for the month for a customer across all Vodafone circles. Bumper 3rd prize will be given post end of the competition period. There is only one 3rd Bumper prize which will be selected basis highest cumulative points over a period of the competition period across all Vodafone circles, Gold Voucher worth Rs.50000/-, to be given away as the 3rd bumper prize. (Rs.65,000/- includes tax). , which will be borne by the Organizer.



In case of a tie, the winner with highest cumulative points in the least amount of time basis the data and log timings as verified by the independent auditor shall be selected as the final winner. And even post which if the winners are on tie then we shall provide both the winners with the actual prize (which means that we shall give away same prize to both the winners)

A customer is eligible to win any number of prizes, He/She should fall into the criteria of selection basis his achievements. There is no restriction on their winning any number of prizes as long as he/she achievements are basis the selection criteria.

16. The prize(s) under the Competition are neither assignable nor transferable under any circumstances. All the prizes under the Competition shall be subject to the Subscriber complying with such Terms and Conditions as may be applicable and duly complied with by the Winners of the Competition.
17. The list of Winners of all prizes will be announced by the Organizer after the end of the Competition and after the winner selection process is completed.
18. All prizes will be given after deducting various taxes, license fees and charges as applicable, except as otherwise stated in writing.
19. The Winner shall not be entitled to the prize, in case he/ she fails to clear all outstanding dues payable to Vodafone India and / or is not an active Subscriber of Vodafone India on the date of claiming the prize.
20. To be eligible to claim the prizes of the Competition, the winning MSISDNs have to be active Subscribers of Vodafone India at the time of the Winner announcement.
21. The verification of the independent auditor as appointed by the Organizer in respect of all transactions under this Competition, including without limitation the selection of winners and other related transactions shall be final and binding and no complaints, claims, correspondence or communication shall be entertained in this regard.
22. All prizes offered in this Competition will be sponsored and distributed by Celltick or a third party designated.
23. All prizes offered in this Competition are subject to availability. The Organizer shall not entertain any requests for any particular model, color, variant or design of the prizes offered under this Competition. Organizer reserves the right to provide alternate models or brands for any of the prizes of the same value without prior intimation or consent of the Subscribers to the Competition.
24. After the selection and validation by the independent auditor of the Winners of all the prizes under the Competition, the Winners will be contacted, by calling them on 3 consecutive days on the number of the Winner registered with Vodafone India, and will be given further details as to how, when and where they can collect their respective prizes. **Also the winner needs to be submitting their respective documents within 7 days from the date of confirmation by the organisers** In the event the Winners do not answer the calls of the Organizer, an SMS will be sent to the MSISDN of the Winners intimating them regarding their winnings and providing them the details as to how, when and where they can collect their respective prizes ("Intimation"). Post sending the SMS the customer needs to be responding the same day or the next day. The prizes must be claimed by the Winners within 15 days from the date of Intimation to the Winner, failing which, the prize(s) will be deemed to be forfeited by the Organizer(s) under the respective categories under the Competition. The Prizes offered under the Competition may be given to the Winners during a special event, the venue, date and time of which shall be announced by the Organizer, at its sole discretion, subsequent to completion of the Competition. In the event no special event is being conducted by the Organizer, the Winners



shall be requested to provide their address to which the prizes may be sent by Organizer, by calling the number provided in the SMS within 7 days from the date of sending the SMS, failing which the prize shall be forfeited. The prizes shall, under no circumstance be distributed from the amount charged by Celltick or Vodafone India for playing the Competition. Delivery of prizes will be subject to the Winners giving the correct address and his/her availability there. The Winners agree that there shall be no liability on Organizer or Vodafone India in the event such message does not reach such Winner on any account for any reason whatsoever. In the event that any of the Winners cannot be reached over phone or through SMS for a period of 3 days from the date of Intimation or are ineligible or are disqualified, for any reason whatsoever, the Organizer reserves the right to forfeit the prize at its sole discretion.

- 25.** Without prejudice to the foregoing Clause 24, any failure on the part of the Winners of the Competition to comply with directions issued by the Organizer or Vodafone India shall entitle the Organizer or Vodafone India, at their discretion, to cancel and forfeit the prize for the said Winner and/or the same prize will be given to the next eligible Winner. All costs and expenses for collecting the prize unless otherwise specified shall be borne solely by the Winners and the prize shall not be transferable and no request shall be entertained by the Organizer or Vodafone India for such transfer. In the event the prizes cannot be delivered, when specified that they will be delivered, due to reasons beyond the control of the Organizer, the Winners shall collect them from the place specified by the Organizer.
- 26.** These Terms and Conditions are subject to guidelines/ directions issued by the Department of Telecommunications (“DoT”), Telecom Regulatory Authority of India (“TRAI”) or any other statutory authority from time to time.
- 27.** Neither Vodafone India nor Celltick shall be responsible for any claims arising out of technical failures before, during, between or after the completion of this Competition, including but not limited to any technical failures in the telephone lines, mobile connectivity, any action that has been initiated, actioned or completed through the Subscribers’ mobile phone, failure of servers or the failure to provide the correct Competition score updates or any mistakes arising out of technical snags or resultant inability of the listener for participation. Further, neither Vodafone India nor the Organizer shall be responsible for any claims arising out of any failure(s) which is beyond the control of the Organizer or Vodafone India.
- 28.** The Subscribers hereby agree and undertake not to hold the Organizer, Vodafone India and/or any of their group entities or affiliates, their respective directors, officers, employees, agents, vendors, responsible for or liable for, any actions, claims, demands, losses, damages, costs, charges and expenses, either direct or remote that they may/might have suffered, sustained or incurred, or claim to suffer, sustain or incur, by way of and /or on account of their subscription to the Competition or participation in it.
- 29.** Organizer, Vodafone India and their affiliates shall be entitled to use, in any manner, the details of the Subscribers, including the Information i.e. name, photograph etc. for their sales, marketing and promotional purposes, including the prizes awarded to them, if any. By subscribing to and participating in the Competition, all Subscribers hereby agree to the same. Organizer and Vodafone India may, at their discretion, choose not to disclose the identity of the selected Subscribers to other Subscribers except as expressly mentioned in the Terms and Conditions herein.



30. Prize(s) shall neither be transferable nor exchangeable for cash, unless otherwise expressly agreed by the Organiser. Mere participation in the Competition shall not entitle a Subscriber to the prize. No other person or agent can claim the prize on behalf of the Subscriber.
31. A Subscriber shall be considered ineligible if he/she does not conform to the conditions as stipulated in these Terms and Conditions, or cannot provide any of the required documents as stipulated in clause 32 herein.
32. All prizes must be claimed by the Winners, along with the documents specified herein below within the time period specified by the Organizer and Vodafone India. The documents required to be submitted along with the claim by the Winners include the following (the document list is only inclusive and not exhaustive and can change as per the requirements of law):
- a. Identity Proof;
 - b. Address Proof;
 - c. Photocopy of PAN Card;
 - d. In case of Winner holding a post-paid connection of Vodafone India number and is entitled to a prize, the value of which exceeds [Rs. 5,000/-], self-attested copy of the latest bill issued by the operator in respect of the Vodafone India number registered with the Organizer under the Competition;
 - e. In case of Winner holding a pre-paid connection of Vodafone India number and is entitled to a prize, the value of which exceeds [Rs. 5,000/-], an affidavit in the format provided by the Organizer, declaring that the Winner is the rightful user of the Vodafone India number and the same is registered with the operator in the name of the Winner;
 - f. Letter of Compliance with rules and regulations and declarations in the format as may be required by Vodafone India or applicable law.
 - g. Any prize of value in excess of INR 10,000/- in a year*** will attract deduction of tax at source and all taxes to be paid on the prize/s shall be paid by the Organizer at the prevailing rate. Further, all the Winners must furnish a valid Indian PAN Card to claim the prize amount, or prize, irrespective of the value of the same, failing which the Winners' prize shall be forfeited, or the prize shall be rolled over to the next eligible Winner, at the sole discretion of the Organizer(s).

***A Subscriber earning prize in excess of INR 10,000 in a year in aggregate from all competitions or offers conducted by Celltick Global Limited as one of the Organizers irrespective of the Operator or other Organizers will be subject to TDS under the Income Tax Act, 1961.

33. Organizer and Vodafone India are not liable for any direct or indirect costs or expenses in relation to the Competition which are to be borne by the Subscriber personally, including without any limitation applicable taxes to be borne by the Subscribers eligible for the prize.
34. In all competitions launched by Organizer for Vodafone India Subscribers ("**Vodafone Competition(s)**") for the financial year 2014-15, one individual Winner, irrespective of the number of mobile connections registered in his/her name with Vodafone India, is entitled to win prizes aggregating up to Rupees Five Lakhs only ("**Threshold Limit**"). However,



- a. Notwithstanding the Threshold Limit, If an individual Winner, irrespective of the number of mobile connections registered in his/her name with Vodafone India, has not crossed the Threshold Limit and subsequently wins an individual prize in the financial year 2014-15 which results in his/her cumulative winnings for the financial year 2014-15 to cross the Threshold Limit, shall, as an exception, be entitled to his/her cumulative winnings in the financial year 2014-15. It is to be noted that the individual Winner will be entitled to such an exception only if a prize under any Vodafone Competition in the financial year 2014-15, individually results in him/her crossing the Threshold Limit in the financial year 2014-15;
 - b. Once any individual Winner, irrespective of the number of mobile connections registered in his/her name, achieves the Threshold Limit for the financial year 2014-15, he/she will not be eligible to win prizes worth Rupees Ten Thousand or above in the financial year 2014-15; and
 - c. All trade names shall continue to remain owned by their respective owners.

37.
