- 2. The Competition is open for all active Subscribers who satisfy the eligibility criteria mentioned in Clause 4 below and who belong to the Vodafone India telecom Service Areas ("Circle(s)") as mentioned in above table and who have successfully subscribed to the Competition Pack (hereinafter referred to as "Competition Pack Member(s)") by following the subscription process mentioned hereunder.
- 3. The Competition will be known by and be made available in the below mentioned languages: English, Malayalam, Telugu, Kannada, Tamil, Hindi, Gujarati, Marathi, Punjabi and Bengali, Oriya, Assamese on IVR.

 - o Through Interactive Voice Response ("IVR"), a double subscription is required.
