Organizer reserves the right to extend or shorten the Competition Period, as it deems fit.
- 2. The Competition is open for all active Subscribers who satisfy the eligibility criteria mentioned in Clause 3 below and who belong to the following Vodafone India telecom circles ("Circle(s)") as mentioned in below table and who have successfully subscribed to the Competition Pack (hereinafter referred to as "Competition Pack Member(s)") by following the subscription process mentioned hereunder.

4. Eligibility

This Competition is open for subscription for all Subscribers who fulfil the following criteria:
