



## **TERMS AND CONDITIONS FOR THE VODAFONE PLAY N WIN COMPETITION PACK**

PLEASE READ THESE TERMS AND CONDITIONS CAREFULLY BEFORE SUBSCRIBING to the **"VODAFONE PLAY N WIN COMPETITION PACK"**. BY PROCEEDING WITH REGISTRATION/SUBSCRIPTION TO THE **VODAFONE PLAY N WIN COMPETITION PACK**, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS. IF YOU DO NOT AGREE TO THESE TERMS ("Terms and Conditions"), PLEASE DO NOT SUBSCRIBE TO THE **VODAFONE PLAY N WIN COMPETITION PACK**.

### **Terms and Conditions:**

The Vodafone Play N Win Competition Pack (hereinafter referred to as "Play N Win Competition Pack") is hosted and organized by **OnMobile Global Ltd.**, a company incorporated under the Companies Act, 1956 and having its registered office at Tower# 1 94/1 C & 94/2, Veerasandra Village, Attibele Hobli, Anekal Taluk, Electronic City Phase 1, Bangalore- 560100- India (hereinafter referred to as "**OnMobile**" or "**Organizer**") for enabling subscribers of Vodafone India Limited, Vodafone Mobile Services Limited, Vodafone West Limited, Vodafone East Limited, Vodafone South Limited, Vodafone Digilink Limited, Vodafone Cellular Limited and Vodafone Spacetel Limited (hereinafter collectively referred to as "Vodafone India") to subscribe to the Play N Win Competition Pack. The Play N Win Competition Pack is open for all Vodafone India users (hereinafter referred to as "Subscribers<sup>1</sup>") who could either be in a pre-paid or in a post-paid category of Vodafone subscribers, residing in India and within the Vodafone India telecom service areas listed below ("Circles"). Subscription to this Play N Win Competition Pack is valid from **9<sup>th</sup> March 2011** [from 00:00:01 hrs] to **29<sup>th</sup> October 2013** [till 23:59:59 hrs]. Once the Subscriber has subscribed to the Play N Win Competition Pack, he/she will become a member of Play N Win Competition Pack ("Play N Win Competition Pack Member(s)") and will be allowed to participate in any competition that may be launched as part of this Play N Win Competition Pack. **Procedure and Eligibility for subscription:**



1. The Play N Win Competition Pack is open for subscription for all active prepaid and postpaid Vodafone India Subscribers who fulfill the following criteria:
  - Subscriber must be 18 years of age and/or above;
  - Subscriber must be a resident of India;
  - Subscriber must not have been either convicted and/or prosecuted for the commission of any criminal offence;
  - Subscriber must not be under any legal disability e.g. insolvency, restraint by court order etc. nor be of an unsound mind and / or prohibited from entering any contractual relationship; and
  - Subscriber must belong to any one of the Circles mentioned above.

An active Subscriber shall mean the MSISDN who uses the Subscriber Identity Module (“SIM”) on a regular basis rather than only to participate in competitions under the Play N Win Competition Pack or any other competitions offered by the Organizer.

## 2. To subscribe to the Play N Win Competition Pack

- a. **The Vodafone India Subscriber(s) may either call 556770 or dial the Unstructured Supplementary Service Data (“USSD”) string \*567\*880# on a cellular phone, or send a Short Message Service (“SMS”) by messaging ACT WIN to 144/111 or press 1 through Out Bound Dialer (“OBD(s)”) or In Bound Dialer.**
  - Subscription to the Play N Win Competition Pack is without any additional charges other than the normal usage charges. As soon as a Subscriber sends a subscription request for the Play N Win Competition Pack:
    - a) Through USSD or SMS, he/she will receive an acknowledgement telling him/her that his/her subscription request has been received. Once his/her subscription is confirmed he/she will receive an SMS on his/her Vodafone India number confirming the subscription to the Play N Win Competition Pack.
      - Upon pressing 1 through OBD/ IVR, he/she will be informed that his/her subscription request has been received and once the same is confirmed by the Subscriber, he/she will receive a subscription confirmation SMS on his/her Vodafone India number.
  - The other relevant steps and terms and conditions involved for each competition under the Play N Win Competition Pack will be communicated to the Subscriber through a promotional SMS or Out Bound Dialer to the Subscriber’s Vodafone India number at the time of communication of launch of individual competitions under this Play N Win Competition Pack. The terms and conditions of each competition launched under the Play N Win Competition Pack shall be made available on the Website.
  - Once the Subscriber is successfully subscribed to the Play N Win Competition Pack he/she will get an SMS informing him/her about the current or upcoming competition, prizes to be won and that the current competition can be played at just Rs 2/-or Re 1/- per day, depending on the balance available on his/her number registered with Vodafone India.

Upon effective un-subscription, an SMS will be sent to the Vodafone India number of the Subscriber confirming the un-subscription from the Play N Win Competition Pack.
  - All Play N Win Competition Pack Members will be sent regular SMS updates and details about the current and the upcoming competitions, informing about the prizes and charges with the terms and conditions URL of the specific competition.
  - All Play N Win Competition Pack Members will be eligible to play and win the prizes offered in each competition subject to payment of daily charges, as will be detailed in the terms and conditions of that respective competition. These prizes may vary from one competition to the next.

criteria of a competition, as laid out in the terms and conditions of the respective competitions will be sponsored and distributed by the Organizer or a third party, as set out in the terms and conditions of that competition. These prizes shall be distributed by the Organizer through any means, and at any time, as it may deem fit. Prizes will differ from one competition to the next. These prizes will be mentioned in the individual competition's terms and conditions separately. The prizes shall not be distributed from the amount charged by OnMobile or Vodafone India for playing any competition under Play N Win Competition Pack.

6. By subscribing to the Play N Win Competition Pack, You, confirm and waive the applicability of rules and regulations of the National Do Not Call Registry and You agree to receive promotional messages and alerts including without limitation daily updates on the score under the current competition and updates about current and upcoming competitions from the Organizer, as it may in its sole and absolute discretion decide.
7. By subscribing to the Play N Win Competition Pack, Play N Win Competition Pack Members consent to the following information relating to them to be exchanged between Vodafone India, OnMobile and their concerned vendors and/or published or otherwise communicated to in any media that the Organizer may deem fit, for the purpose of winner announcement for each competition organized under Play N Win Competition Pack: name, mobile phone number, score and/or photograph ("Information"). The Play N Win Competition Pack Members also consent to the Information being shared by OnMobile with its affiliates and service providers and to the Information being processed and stored in the servers of OnMobile or its service providers, inside or outside India.
8. You acknowledge and agree that all copyright and trademarks and all other intellectual property rights in the SMS content, WAP or Website and all material or content related to the Play N Win Competition Pack shall remain, at all times, owned by the Organizer, Vodafone India and their respective owners. All material and content contained in this Website is made available for your personal and non-commercial use only. Any other use of the material/ content on this Website, WAP site and/ or any information disseminated by SMS or any other means of communication is strictly prohibited.
9. The Organizer, at its sole discretion, may or may not provide a cash alternative to any of the prizes being offered in any of the competitions that are launched as a part of Play N Win Competition Pack.



- 10.** All prizes offered in any of the competitions of Play N Win Competition Pack are subject to availability. Organizer reserves the right to provide alternate models or brands for any of the prizes without prior intimation or consent of the participants of any competition under the Play N Win Competition Pack.
- 11.** After the selection and validation of the winners of all the prizes under a specific competition of Play N Win Competition Pack, the winners will be contacted, through calls, for 3 consecutive days on the number of the winner(s) registered with Vodafone India, and will be given further details as to how, when and where they can redeem their respective prizes. In the event the winners do not answer the calls of the Organizer, an SMS will be sent to the MSISDN of the winners intimating them regarding their winnings and providing them the details as to how, when and where they can collect their respective prizes (“Intimation”). The prizes must be claimed by the winners within 30 days from the date of Intimation to the winner, failing which, the prize(s) will be deemed to be forfeited by the Organizer under the respective categories under the competition. The prizes offered under any competition may be given to the winners of that particular competition during a special event, the venue, date and time of which shall be announced by the Organizer, at its sole discretion, subsequent to completion of the relevant competition. In the event that any of the winners cannot be reached over the phone or through SMS for a period of 3 days from the date of Intimation on their Vodafone India number, or are ineligible or are disqualified or unable to receive the prize, for any reason whatsoever, the Organizer reserves the right to forfeit the prizes at its sole discretion, and give it to the next eligible winner. All costs and expenses for collecting the prize unless otherwise specified, shall be borne solely by the winners under each competition and the prize shall not be transferable and no request shall be entertained by the Organizer for such transfer. - 13.** The prizes offered in any competition will be sponsored and distributed by OnMobile/designated third party.
- 14.** Any Play N Win Competition Pack Member providing any incorrect information or concealing/withholding any information from the Organizer with an intent to participate and/or win any prize/s in any competition under Play N Win Competition Pack will automatically be disqualified from participating in it and winning the different categories of prizes under the competitions. Such act of providing incorrect information or concealing/withholding any information, including without limitation incorrect declaration of information relating to name, age, identity, address, mobile connection of Vodafone India number, domicile, payment of

In case of winners holding a post-paid connection of Vodafone India number and is entitled to a prize, the value of which exceeds [Rs. 5,000/-], self-attested copy of the latest bill issued by the operator in respect of the Vodafone India number registered with the Organizer under the Play N Win Competition Pack;
  - In case of winners holding a pre-paid connection of Vodafone India number and is entitled to a prize, the value of which exceeds [Rs. 5,000/-], an affidavit in the format provided by the Organizer, declaring that the winner is the rightful user of the Vodafone India number and the same is registered with the operator in the name of the winner; and
  - Letter of compliance with rules and regulations and declarations in the format as may be required by the Organizer, Vodafone India or applicable law.
- 17.** The employees of Vodafone India / OnMobile and their group companies, affiliate or associate companies shall not be eligible to win any of the prizes offered in any of the competitions launched as a part of the Play N Win Competition Pack.
- 18.** These Terms and Conditions are subject to force majeure circumstances including without limitation, floods, natural disasters, war, act of terror, political unrests, technical snags, act of God or any circumstance beyond the reasonable control of Vodafone India and/or OnMobile ("Force Majeure Event"). Neither OnMobile nor Vodafone India shall be liable for any delay or adverse effect caused to Play N Win Competition Pack or any competition(s) thereunder as a result of a Force Majeure Event. OnMobile and/or Vodafone India shall intimate the suspension of Play N Win Competition Pack or any competition thereunder caused as a result of such Force Majeure Event to the Play N Win Competition Pack Members.
- 19.** The Terms and Conditions stated herein shall be read along with the terms and conditions of the competition(s) that may be launched as part of the Play N Win Competition Pack and the Play N Win Competition Pack Members accept and agree to be legally bound by the terms and conditions of each competition.
- 20.** In the event of any discrepancy between these Terms and Conditions and the terms and conditions of any specific competition, so far as the same impact the Terms and Conditions of subscription to Play N Win Competition Pack or are specifically provided hereunder, the Terms and Conditions hereof shall prevail. In



the event of any such discrepancies impacting the terms and conditions of any specific competition only the terms and conditions of that competition shall prevail and override these Terms and Conditions.

- 21.** Subject to any applicable law (a) warranties of any kind whatsoever, whether express or implied, are hereby expressly disclaimed by Vodafone India and/ or OnMobile including, but not limited to, meeting of the Play N Win Competition Pack Members or Subscriber's requirements or aspirations, timeliness, security, the results or reliability of any scheme, or the delivery, quality, quantity, merchantability, fitness for use or non-infringement in respect of any goods, services, benefits or awards acquired or obtained through any of the competitions of Play N Win Competition Pack or any transactions effected through Play N Win Competition Pack; (b) The Subscriber expressly agrees that his/her subscription to Play N Win Competition Pack or participation in any competition thereunder offered by Vodafone India is at the his/her sole risk and is governed by the Terms and Conditions herein; and (c) No advice or information whether by representations, oral, written or pictorial derived from the Website or through Play N Win Competition Pack shall be construed to mean the giving of any warranty of any kind by Vodafone India or OnMobile.
- 22.** Vodafone India, OnMobile or any of their group entities or affiliates, their respective directors, officers, employees, agents, representatives, shall not be liable for any loss or damage whatsoever that may be suffered, or for any personal loss or injury that may be suffered (including loss of life), by a Play N Win Competition Pack Member or a participant of any competition there under and/or any third party, directly or indirectly, by use or non-use of the prizes offered in the individual competitions offered under Play N Win Competition Pack.
- 23.** Vodafone India and/ or OnMobile may assign any or all of their rights under these Terms and Conditions to their affiliates without consent of the Subscribers or Play N Win Competition Pack Members.
- 24.** The Play N Win Competition Pack Members participating in each individual competitions under Play N Win Competition Pack shall indemnify and keep indemnified Vodafone India and OnMobile and their officers, directors, employees, customers, affiliates and agents harmless from and against any and all claims, losses, suits, proceedings, action, liabilities, damages, expenses and costs (including attorney's fees and court costs) which OnMobile or Vodafone India may incur, pay or become responsible for as a result of breach or alleged breach of the representations or obligations of the Play N Win Competition Pack Members under the Terms and Conditions hereunder or under the terms and conditions of the specific competition, any failure by the Play N Win Competition Pack Member participating in an individual competition to comply with applicable law and any third party claim in respect of misuse of any information of a third party. Vodafone India and OnMobile shall have the right to defend themselves, pursuant to this Clause, at the cost of the Play N Win Competition Pack Member. - 26.** This offer under the Play N Win Competition Pack cannot be used in conjunction with any alternative offer or promotion.
- 27.** These Terms and Conditions are subject to guidelines/ directions issued by the Department of Telecommunications (“DoT”), Telecom Regulatory Authority of India (“TRAI”) or any other statutory authority from time to time.
- 28.** The decision of the Organizer in respect of all transactions/issues pertaining to the Play N Win Competition Pack shall be final and binding.
- 29.** Neither Vodafone India nor OnMobile shall be responsible for any claims arising out of technical failures before, during, between or after the completion of any competition in the Play N Win Competition Pack, including but not limited to any technical failures in the telephone lines, mobile connectivity, any action that has been initiated/ actioned/completed through the Subscribers mobile phone, failure of servers or the failure to provide the correct competition score updates or any mistakes arising out of technical snags or resultant inability of the listener for participation. Further, neither Vodafone India nor the Organizer shall be responsible for any claims arising out of any failure(s) which is beyond the reasonable control of the Organizer or Vodafone India.
- 30.** The Subscriber(s) and the Play N Win Competition Pack Member(s) hereby agree and undertake not to hold the Organizer, Vodafone India and/or any of their group entities or affiliates, their respective directors, officers, employees, agents, vendors, responsible for or liable for, any actions, claims, demands, losses, damages, costs, charges and expenses, either direct or remote that You may/might have suffered, sustained or incurred, or claim to suffer, sustain or incur, by way of and /or on account of Your subscription to the Play N Win Competition Pack or participation in any of the competitions in relation thereto.
- 31.** The Organizer and Vodafone India reserve the right to extend, cancel, discontinue, prematurely withdraw, change, alter or modify any part of the Play N Win Competition Pack or any part thereof including the Terms and Conditions, individual competitions and prizes/gifts at their sole discretion at any time during its validity as may be required including in view of business exigencies, changes by regulatory authorities, statutory changes and for other reasons beyond its control.
