



## **Pre Due Date Contest– 20 April 2016 – 19 Jun 2016**

By entering into this contest which is conceptualized and organized by Vodafone India Limited (hereinafter referred to as "**VIL**") for their valid post-paid cellular mobile telephony subscribers in Mumbai Telecom Service Area (hereinafter referred to as "**Subscribers**") you hereby agree to abide by the terms and conditions herein below ("**Contest**").

Herein, a valid Subscriber means having valid subscription of VIL's cellular mobile telephony services as per Law.

### **I. Definition**

Mumbai Service Area: Mumbai

### **II. Eligibility to participate in the Contest:**

This Contest is open for subscription for all Subscribers who fulfil the following criteria:

- Subscriber must be of or above 18 years of age;
- Subscriber must be a resident of India;
- Subscriber must pay **his/her bill of his/her number before the due date;**
- Subscriber must belong to Mumbai Service Area only;
- Subscriber must not have been subject of any criminal proceeding;
- Subscriber must not be of unsound mind; and
- Subscriber must not be under any legal disability e.g. insolvency, restraint by court order etc. and / or is prohibited from entering any contractual relationship

No fee is payable for participation in the Contest.

### **III. Terms and Conditions:**

- 1) The Contest is organized by VIL and is open from 20.04.2016 till 19.06.2016 (both days inclusive), only for the valid Subscribers of VIL. VIL reserves the right to extend or shorten the Contest period, as it deems fit without any prior written notice to its subscribers.
- 2) This Contest is specifically valid for bill cycles 04- Apr -16, 07- Apr -16, 11-Apr-16, 15- Apr -16, 18- Apr -16, 25- Apr -16, 28- Apr -16, 01- May -16, 04- May -16, 07- May -16, 11- May -16, 15- May -16, 18- May -16, 25- May -16, 28- May -16, 01- June -16

3) Process for participation in the Contest:

➤ **Step1:**

- During the duration of the Contest, a Subscriber should make payment towards his/her Vodafone Postpaid Mobile Bill **on or before the applicable date for bill cycle** (currently 1<sup>st</sup>, 4<sup>th</sup>, 7<sup>th</sup>, 11<sup>th</sup>, 15<sup>th</sup>, 18<sup>th</sup>, 25<sup>th</sup> and 28<sup>th</sup> of the calendar month are considered as bill cycle dates which bill cycle date depending on the criteria including activation date is assigned to Subscriber).
- 'Payment' refers to posting of the cheque realized, cash received or online payment received from the Subscriber towards the outstanding bill, on or before the specified date/s irrespective of the due dates date/s (such dates shall be specified by VIL from time to time via communication through SMS or any other mode).

➤ **Step2:**

- After completing the Step 1, the Subscriber requires to answer a simple question.
- Answer in the form of a SMS requires to be sent to 54044 (toll free).

Notwithstanding the foregoing, if the operation of or participation in the Contest is prohibited in any part of Mumbai, thereof as per applicable law, the Subscribers from such part thereof shall not be eligible to subscribe to or participate in the Contest. No further notice shall be given by the Vodafone, in this regard.

4) Awards: Vouchers worth Rs.2000 each. (1 Winner per Bill Cycle)

- By participating in the Contest, the Subscriber merely becomes eligible to win an award ("**Award**").
- Vodafone reserves the right to change the Award to be awarded to the winners of the Contest ("**Winner**").
- Winner will be decided basis by Vodafone. Wherever the Winner is required to be selected through draw due to a tie, the selection of the Winner will be by way of a random computer-generated draw amongst correctly answered entries.
- Vodafone reserves absolute and sole discretion to choose the Winner. The Subscriber shall be bound by the decision taken by Vodafone & shall not raise any dispute in this regard in any manner whatsoever

5) Each Subscriber, irrespective of his number of subscription and/or bill cycle, on being selected as a Winner, may win only one Award in the Contest and therefore no winning subscriber (including company, partnership firm, individual etc. can be eligible to win more than one Award). To clarify; in case a person who is a subscriber of more than one Vodafone Postpaid number/s he/she is eligible to participate in the Contest with all valid Vodafone numbers, however the participating person will be entitled to win only one Award.

6) No winner shall have right to select the aforesaid Awards and a Winner getting one category of Award shall not be eligible to win another set of Award/s in this Contest.

- 7) The Winner shall not be entitled to the Award, in case he/ she fails to clear all outstanding dues payable to VIL and / or is not an Valid/Active Vodafone Subscriber on the date of claiming the Award. In case, participant has made payment of his/her bills, through any mode other than cash, than the selection as winner and/or eligibility to the Award shall be subject to realisation of the said payments. Herein, Active VIL Subscriber means a subscriber whose Vodafone mobile number subscription is valid and whose Vodafone number is active on VIL's network at the time of distribution of the Awards by VIL.
- 8) The Winner/s may be announced through website 'www.vodafone.in' or by SMS and/or through any other manner as VIL may deem appropriate. The Winner will be required to confirm his/her acceptance of the Award within 48 hours of receiving information about the same. Winners will have to collect the Award from the designated redemption centre within 15 days of announcing the Winners on self-certification of their authenticity.
- 9) The Award for the Contest will be given only to the Winner in whose name the Mobile phone number is registered and is the Subscriber's responsibility to produce such document and/or credentials to prove his/her identity. It is the responsibility of the Winner to produce such identity proof and/or credentials at his/her own cost.
