

TERMS AND CONDITIONS – SALMAN DHAMAAL COMPETITION

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE PARTICIPATING IN THIS COMPETITION KNOWN AS "SALMAN DHAMAAL COMPETITION". BY PROCEEDING WITH PLAYING THE SALMAN DHAMAAL COMPETITION, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS ("Terms and Conditions"). IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT PARTICIPATE IN THE SALMAN DHAMAAL COMPETITION.

Terms and Conditions

- 1. "Salman Dhamaal Competition" (hereinafter referred to as the "Competition") is conceptualized, organized and hosted by OnMobile Global Limited, a company incorporated under the Companies Act, 1956 and having its registered office at Tower# 1 94/1 C & 94/2, Veerasandra Village, Attibele Hobli, Anekal Taluk, Electronic City Phase 1, Bangalore- 560100- India("OnMobile" or "Organizer") and is open for participation for active¹ pre-paid and post-paid category of Subscribers² (hereinafter referred to as "Subscriber(s)") of Vodafone India Limited, Vodafone Mobile Services Limited, Vodafone West Limited, Vodafone East Limited, Vodafone South Limited, Vodafone Digilink Limited, Vodafone Cellular Limited and Vodafone Spacetel Limited (hereinafter referred to as "Vodafone India") during the period from 4th November 2014, 00:00:01 hrs to 11th February 2015, 23:59:59 hrs ,both days inclusive (hereinafter referred to as the "Competition Period"). Organizer reserves the right to extend or shorten the Competition Period, as it deems fit.
- 2. The Competition is open for all active Subscribers who satisfy the eligibility criteria mentioned in Clause 3 below and who belong to the following Vodafone India telecom circles ("Circle(s)") of ANDHRA PRADESH, ASSAM, NORTH EAST, BIHAR, DELHI, JAMMU & KASHMIR, GUJARAT, HARYANA, KARNATAKA, KERALA, MAHARASTRA, MADHYA PRADESH, ORISSA, MUMBAI, PUNJAB, HIMACHAL PRADESH, RAJASTHAN, UTTAR PRADESH EAST, UTTAR PRADESH WEST, KOLKATA, WEST BENGAL, CHENNAI and TAMIL NADU. Notwithstanding the foregoing, if the operation of or participation in the Competition is prohibited in any State and/or territory or part thereof as per applicable law, the Subscribers from such State and/or territory or part thereof shall not be eligible to subscribe to or

3. Eligibility

This Competition is open for participation for all Subscribers who fulfil the following criteria:

- He/she must be an active Subscriber;
- He/she must not have been the subject of any criminal proceeding;

- He/she must not be under any legal disability e.g. insolvency, restraint by court order etc. and / or is prohibited from entering any contractual relationship.

- For the purposes of these Terms and Conditions, wherever the context so requires "You" or "Your" shall mean any natural person who is a Participant.

- Agree that You are entering into this Competition as an independent party and nothing herein
 establishes an employer-employee relationship between You and Vodafone India or between
 You and OnMobile and You are acting voluntarily, using Your own time and resources to
 participate in this Competition, solely at Your own risk;
- Warrant that You have read understood and agreed to conform to these Terms and Conditions;
- Warrant the accuracy, truthfulness and currency of all information that You have submitted; and
- Warrant that prior to playing this Competition, it shall be deemed that You have read and have agreed to be bound by the Terms and Conditions herein.

The Competition will be available in the below mentioned languages:

English, Hindi, Gujarati, Marathi, Punjabi, Bengali, Malayalam, Telugu, Kannada and Tamil on IVR ("Interactive Voice Response") and in English and Hinglish languages on SMS.

A Participant, by participating in the Competition, hereby agrees to the Terms and Conditions mentioned below and gives his/her irrevocable consent to the process of selecting the winners under this Competition as set out herein, and any appropriate changes that may be made to this Competition by the Organizer including due to any legal or regulatory requirement, instructions

from any judicial or a quasi-judicial body or due to any natural calamity beyond the reasonable control of the Organizer, its affiliates and associates or for any reason whatsoever. Participants who are roaming outside their home Circle will be barred from playing the Competition.

- Further, the Participants who participate in the Competition and are chosen as winners of each category of prizes in accordance with the winner selection process under the Terms and Conditions of the Competition shall be required to be the registered Vodafone India Subscribers of the winning mobile phone number and not merely the players using such mobile number ("Winner(s)"). 5. Charging:

 - (i) Participation in the Competition through calls:

 - (ii) Participation in the Competition through SMS:

Each Participant shall be charged Rs 3/- per SMS sent to the number 5670330 during the Competition Period, unless otherwise specified herein.

- (iii) A Participant will be charged only if he/she plays the Competition, in accordance with these Terms and Conditions. There will not be any automatic deduction of charges for this Competition.
- (iv)The charged amount will not be refunded to Participants under any circumstances.

6. Competition on Voice

- Competition will be available on the toll-free numbers 5670330, 567035 and 56703.
- All the Participants can play the Competition by calling the toll-free numbers 5670330 or 567035 or 56703.
- Participants will be informed of the rules, prizes to be won and Terms and Conditions URL of the Competition on calling the number 5670330 or 567035 or 56703.

- Participants may send PRI, RUL, SCORE or TNC as an SMS to 5670330, without additional charges
 for such SMS's, to know about the details of the prizes applicable under this Competition,
 applicable rules and Terms and Condition URL and current Level (defined below) score or the
 total score of the Participant in all the Levels respectively.
- All questions under this Competition shall be based on information available to the public at large.
- The Competition consists of questions with 2 answer options each.
- All Participants may choose to play all questions at once, else he/she can continue playing the questions on any of the days during the Competition Period.
- Level 1 will consist of 50 questions, Level 2 will consist of 100 questions and Level 3 will consist of 150, Level 4 will consist of 300 questions and Level 5 will consist of 400 questions, which may be played by the Participants.
- On completing answering all the questions under each Level, an appropriate prompt will be
 played intimating the Participant of the relevant Level and the updated score in that Level which
 will be followed by questions of the subsequent Level.
- In the event that the Participant is a Competition Pack Member (as defined under the terms and conditions of the Competition Pack), regular SMSs will be sent to his/her number registered with Vodafone India informing him/her of the other competitions active at the time of and during this Competition Period; if the Participant is not a Competition Pack Member, informational SMSs will be sent to his/her number registered with Vodafone India regarding other competitions active at the of and during this Competition Period, and the prizes offered therein. - For all Participants who are participating in the Competition for the first time, a welcome SMS will be sent to the number of the Participant registered with Vodafone India, informing him/her about the prizes to be won and the URL of the Terms and Conditions. After completion of each Level of questions, a welcome SMS will be sent to the number of the Participants introducing them to the relevant subsequent Level, prizes to be won in that Level and the charging amount for that Level.
- Level 1 will consist of 50 questions, Level 2 will consist of 100 questions and Level 3 will consist of 150, Level 4 will consist of 300 questions and Level 5 will consist of 400 questions which may be played by the Participants.
- A Participant shall be charged Rs 3/- for every SMS sent to the number 5670330, unless otherwise mentioned. If a Participant has not been charged for a particular question, the answer to such uncharged question shall be disregarded for the purposes of Winner selection. - For every right answer the Participant will get 1 point. There is no negative marking for a wrong answer.
- After every right or wrong answer, the Participant will be sent an appropriate SMS on his/her number registered with Vodafone India with his/her updated score and given the next question and answer options.
- If Participant stops playing after answering the nth question then when he/she sends an SMS, he/she will get the (n+1)th question.
- If a Participant does not receive the (n+1)th question after answering the nth question, for any reason whatsoever, then when he/she sends the keyword 'WIN' or 'GO' or 'YES' or 'BIKE' or 'CASH' on the number 5670330, he/she will be sent the (n+1)th question on his/her number registered with Vodafone India.

8. Competition on USSD:

- All Participants may play the Competition by dialing the Unstructured Supplementary Service
 Data ("USSD") string *567*4#. If a Participant dials the USSD string *567*4# for the first time, a
 Welcome SMS will be sent to that number of the Participant registered with Vodafone India,
 informing the Participant about the charges and prizes to be won and the link for the Terms and
 Conditions.
- This will be followed by question and answer options on USSD channel.
- Level 1 will consist of 50 questions, Level 2 will consist of 100 questions and Level 3 will consist of 150, Level 4 will consist of 300 questions and Level 5 will consist of 400 questions which may be played by the Participants.
- All the questions have 2 answer options each and participants can answer by sending A or B, as a response to the questions.
- For every right answer, the Participant will get 1 point. There is no negative point for wrong answers.

- After every right or wrong answer, the Participant will be sent one USSD message with the right or wrong answer response, along with the score details and the next question and answer options.
- In case of an invalid USSD input by the Participant, the Participant is sent a message on USSD stating that the input provided by him/her is invalid and will contain details of how to answer the question correctly. This will be followed by another question and answer options.
- If a Participant stops playing after answering the nth question then when he/she dials USSD string *567*4# again, he/she will get the (n+1)th question on USSD.
- If the Participant stops playing after answering the nth question then he/she can continue playing by dialing USSD string *567*4# again, to receive the next question.
- The Participant is given the questions one after the other till he/she finishes answering all the questions.
- Once the Participant answers all the questions, an exit message will be sent on USSD. The same
 will happen if the user dials USSD string after he/she has answered all the questions or if he/she
 tries to answer a question after having answered all the questions.
- The Competition can be played only once by a Participant.

1stPrize:-

Every Day Early Bird - 2nd Prize

The Every Day Early Bird-2nd Prize will be conducted for each day of the Competition. In case in any of the Circles or Circle-Groups, the talk-time recharge value or denomination offered in the Competition is not available, the Winners will be provided with the nearest value or denomination available for talk-time, data or SMS recharge which could be equal to or closest to the recharge value or denomination offered. All taxes and charges including but not limited to State tax, cess, operator charges etc. on such recharge will be applicable and will be borne by the Winner.

- In case of a tie in the selection of the Every Day Early Bird 1st Prize and the Every Day Early Bird –2nd Prize, for Tamil Nadu and Chennai Circle, the Winner will be the MSISDN that has achieved the relevant score as detailed above, first in point of time, which shall be electronically recorded by an independent system of the Organiser.
- In case of a tie in the selection of the Every Day Early Bird 1st Prize and Every Day Early Bird 2nd Prize, for all other Circle-Groups**, the Winner will be selected through a system generated process, which will be scrutinized by an independent audit mechanism.
- In case of a tie in the selection in any of the other prizes, 1 round of tie-breaker will be conducted for all the tied MSISDNs on Voice. In case of a further tie in the score and time taken, in the tie-breaker, the selection will be conducted by checking the time taken by the MSISDNs to answer x-1, x-2 questions in the tie-breaker. i.e., if the tie-breaker has 35 questions, and there is a tie in this, then, the time taken for an MSISDN to answer 35-1=34 questions will be considered. In case of a tie in this, then the time taken to answer 34-1=33 questions, and so on will be considered.
- If a Participant plays the Competition over both the channels (voice & SMS), his/her score will only be cumulative and not exclusive for each of the channels. i.e., if the Participant has started playing the Competition on voice and has scored 2 points in 3 questions, if he/she drops the call and resumes playing through SMS, he/she will be given the 4th question, and if he/she answers the question correctly, his/her score will be 3. And this will be the score that will be considered for the Winner selection for all the prizes.
