4. Eligibility

- a. Competition will be available on 5040455 (Toll-free) for subscribers of Vodafone.
- b. Once a Vodafone subscriber subscribes to RBT or an existing RBT subscriber sets a new song as their RBT, during the Competition period, then they become eligible to participate in the Vodafone Callertune Bonanza.
 - i. Based on the charged amount, if the participant becomes an RBT subscriber and if the participant is charged for activation on RBT service, then only participant will be given welcome message, if participant gets activated on RBT service and the charged amount is zero then this participant will not be given welcome message and this participant will not be eligible to play contest
