PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE PARTICIPATING IN THIS COMPETITION KNOWN AS "**WIN A CAR COMPETITION**". BY PROCEEDING WITH PLAYING THE **WIN A CAR COMPETITION**, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS ("**Terms and Conditions**"). #### **Terms and Conditions**

- **1.** This **"WIN A CAR COMPETITION"** (hereinafter referred to as the **"Competition**") is an optional Competition, conceptualized, organized and conducted by OnMobile Global Limited, a company incorporated under the Companies Act, 1956 and having its registered office at Tower# 1 94/1 C & 94/2, Veerasandra Village, Attibele Hobli, Anekal Taluk, Electronic City Phase 1, Bangalore - 560100, India (hereinafter referred to as "**OnMobile**" or "**Organizer**"), for enabling active Subscribers who use the Vodafone India Subscriber Identity Module ("SIM") on a regular basis for purposes other than to participate in the Competition, pre-paid and post-paid category of Subscriber(s) who are the rightful user of the Vodafone India connection, in whose name the mobile phone connection number (MSISDN) is registered with Vodafone India (hereinafter "Subscriber(s)") as specified in Circles stated in Clause 2 herein, of either Vodafone India Limited or Vodafone Mobile Services Limited (hereinafter individually or collectively referred to as "Vodafone India") to participate in the Competition. In the event the MSISDN is registered in the name of a company/ firm, the employee who is authorized to use the connection shall submit a No Objection Certificate (NoC) and authorization of the employer duly permitting the employee to use the number for participation in the Competition, receive the prizes and accept the Terms and Conditions applicable for the Competition. - 2. # 4. Subscription Process to the Competition and Charges:

Subscribers can initiate the participation in the Competition by calling 56789 charging at Rs. 9/min. For the avoidance of doubt, please note that a Subscriber can play the Competition only through IVR.

- Once a Subscriber follows the above-methods for initiation of the Competition, he/she will be considered as a Participant (hereinafter referred to as "**Participant**") of the Competition and he/she can start playing questions under the Competition.
- Subscriber can call any of the below short code ("**SC**") and if he/she is eligible to participate in Competition, (please refer below for eligibility) application will re-route same call to Competition application (without disconnecting the call).

- Logic of deciding Winner would be on the basis of highest point gainer and quickest answers given by key press.
- The subscriber would be prompted contest directly (from above mentioned short codes). Once user plays all the 30 questions of the week, normal entertainment application would be played. The user can continue playing for other weeks as per the weekly schedule.
- Competition will also be charged same as 56789 i.e. Rs. 9/min.
- 30 questions with 2 options will be played per user per week.
- 360 questions for 12 weeks, each correct answer will gives 1 point and wrong answer will give 0 point to the Participant.

# 5. Questions and Scoring

The Competition consists of a total of 360 questions, with 2 answer options each and the Participant can answer only 30 questions per week. All questions are in multiple choice format and the answer to each must be selected from one of the 2 options only.

# 6. Competition on Voice (IVR)/ OBD:

- Competition will be open for all the Subscribers of the above mentioned Circles of Vodafone India on the toll free number at 56789 (toll free) or on all SCs aforementioned on IVR or they can receive a call on OBD to play the Competition.
- Participant will be informed of the rules, prizes to be won and Terms and Conditions URL of the Competition on calling the toll free number 56789 or all SCs mentioned above.
- After every question and answer options, a "beep" prompt will be played. Participant can answer by dialing 1 for 1<sup>st</sup> option or 2 for 2<sup>nd</sup> option on the phone keypad only after the "beep" prompt.
- Once the Participant presses 1 or 2 on his/her phone keypad as his/her answer for the relevant question, Rs. 9/min- shall be immediately charged.

If the charging is unsuccessful, a "not charged" prompt will be played and the call will be disconnected. Such answer of the Participant shall be disregarded and this will remain as an unanswered question and may be given to the Participant again sometime later during the Competition Period. Such uncharged answer/s shall be disregarded for the purposes of Winner selection process.

- After every right answer, the Participant will be given his/her score, followed by the next question and the answer options and the process to answer the subsequent question. After every wrong answer the Participant will be played an appropriate prompt and given the next question and answer options.
- To listen to a question again Participant may press \*.
- If a Participant stops playing the Competition, then he/she may resume playing by calling the toll free number 56789 or other SCs aforementioned, to receive the next question and answer options.
- If the Participant stops playing the Competition after answering the nth question then when he/she calls back, he/she will be played the (n+1)th question.
- If the Participant stops playing the Competition without answering the nth question, then when he/she calls back, he/she will be played the nth question, which maybe different than the question received previously i.e., if a Participant listens to the 4<sup>th</sup> question but drops the call without answering the 4<sup>th</sup> question, then when he/she calls back, he/she will be played the 4<sup>th</sup> question which may be different from what he/she received previously.

## 7. Prizes and Winner Selection Process

### a) Grand Prize :-

The selection for the Grand Prize will be conducted after the Competition gets over. One MSISDN across all circle groups, with highest score in the least amount of time during that Competition Period will be selected as the winner of Grand Prize of Renault Qwid Car worth up to Rs. 5,00,000/-.

### b) Weekly First Prize:

The selection for the Weekly First Prize will be conducted after the Competition gets over. One MSISDN across circle groups, with highest score in the least amount of time during that week will be selected as the Winner of Iphone 5s worth up to Rs. 50,000/-.

One MSISDN can win this prize only once in this Competition.

### c) Weekly Second Prize:

# d) Weekly Third Prize:

The selection for the Weekly Third Prize will be conducted after the Competition gets over. One MSISDNs across circle groups, with the highest score in the least amount of time during that week will be selected as the winner of Talk time worth up to Rs. 1,000/-.

One MSISDN can win this prize only once in this Competition.

In case of a tie in the selection of Winners for Weekly 2<sup>nd</sup> and 3<sup>rd</sup> Prize, in the Competition, the Winner will be the MSISDN that has achieved the relevant score as detailed above, first in point of time, which shall be electronically recorded by an independent system of the Organizer.

- **20.** Organizer, Vodafone India and their affiliates shall be entitled to use, in any manner, the details of the Participant, including the information i.e. name, photograph etc. for their sales, marketing and promotional purposes, including the prizes awarded to them, if any. By subscribing to, and participating in the Competition, all participating Subscribers hereby agree and consent to the same.
