

TERMS AND CONDITIONS – WIN CAR COMPETITION

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE PARTICIPATING IN THIS COMPETITION KNOWN AS "WIN CAR COMPETITION". BY PROCEEDING WITH PLAYING THE WIN CAR COMPETITION, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS ("Terms And Conditions"). IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT PARTICIPATE IN THE WIN CAR COMPETITION.

- 1. "Win Car Competition" (hereinafter referred to as the "Competition") is conceptualized, organized and hosted by OnMobile Global Limited, a company incorporated under the Companies Act, 1956 and having its registered office at Tower# 1 94/1 C & 94/2, Veerasandra Village, Attibele Hobli, Anekal Taluk, Electronic City Phase 1, Bangalore-560100- India ("OnMobile" or "Organizer") and is open for participation for active pre-paid and post-paid category of Subscribers (hereinafter referred to as "Subscriber(s)") of Vodafone India Limited, Vodafone Mobile Services Limited, Vodafone West Limited, Vodafone East Limited, Vodafone South Limited, Vodafone Digilink Limited, Vodafone Cellular Limited and Vodafone Spacetel Limited (hereinafter referred to as "Vodafone India") during the period from 27th November 2013, 00:00:01 hrs to 25th January 2014, 23:59:59 hrs (hereinafter referred to as the "Competition Period"). Organizer reserves the right to extend or shorten the Competition Period, as it deems fit, and any such change shall be published on the website, http://vodafone.contestzone.in and www.vodafone.in ("Website").
- 2. The Competition is open for all active Subscribers who satisfy the eligibility criteria mentioned in Clause 3 below and who belong to the following Vodafone India telecom circles ("Circle(s)") of ANDHRA PRADESH, ASSAM, BIHAR, DELHI, GUJARAT, HARYANA, HIMACHAL PRADESH, KARNATAKA, KERALA, KOLKATA, MAHARASTRA, MADHYA PRADESH, MUMBAI, NORTH EAST, ORISSA, RAJASTHAN, WEST BENGAL, UTTAR PRADESH EAST, UTTAR PRADESH WEST, JAMMU & KASHMIR, PUNJAB, CHENNAI & TAMIL NADU.

3. Eligibility

This Competition is open for participation for all Subscribers who fulfil the following criteria:

- He/she must be of or above 18 years of age;
- He/she must be a resident of India;

¹ An active Subscriber shall mean the Subscriber who uses the Subscriber Identity Module ("**SIM**") on a regular basis for purposes other than to participate in competitions under this Competition or any other competitions offered by the Organizer and Vodafone India, jointly.

² Subscriber shall mean the rightful user of the Vodafone India connection, pre-paid or post-paid, in whose name the mobile phone connection number (MSISDN) is registered with the operator. In the event the number / connection is registered in the name of a company/ firm, the employee who is authorized to use the connection shall submit a No Objection Certificate (NoC) and authorization of the employer duly permitting the employee to use the number for participation in the Competition, receive the prizes and accept the terms applicable for the Competition.

- Warrant the accuracy, truthfulness and currency of all information that You have submitted; and

A Participant, by participating in the Competition, hereby agrees to the Terms and Conditions mentioned below and gives his/her irrevocable consent to the process of selecting the winners under this Competition as set out herein, and any appropriate changes that may be made to this Competition by the Organizer including due to any legal or regulatory requirement, instructions from any judicial or a quasi-judicial body or due to any natural calamity beyond the reasonable control of the Organizer, its affiliates and associates or for any reason whatsoever. Participants who are roaming outside their home Circle will be barred from playing the Competition.

 - (i) for answering each question under Level 1, Rs.2/- per question shall be charged to the Participant;

 - (iii) for answering each question under Level 3, Rs. 4/- per question shall be charged to the Participant.

6. Competition on Voice

- Competition will be available on the toll-free number 5670330 or 567035.
- All the Participants can play the Competition, by calling the toll-free number 5670330 or 567035.
- Participants will be informed of the rules, prizes, Terms and Conditions URL of the Competition, on calling the number 5670330 or 567035 to play the Competition
- All questions under this Competition shall be based on general information available to the public at large.
- The Competition consists of questions with 2 answer options each.
- All Participants may choose to play all questions at a time, else he/she can continue playing on any of the days during the Competition Period.
- On completing answering all the questions under each Level, an appropriate prompt will be played intimating the
 Participant of completion of the relevant Level followed by questions of the subsequent Level. Once the
 Participant finishes answering all questions under all three Levels, an exit prompt will be played and the call is
 dropped.
- In the event that the Participant is a Competition Pack Member, regular SMSs will be sent to his/her number registered with Vodafone India informing him/her of the Win Gold Competition; if the Participant is not a Competition Pack Member, informational SMSs will be sent to his/her number registered with Vodafone India regarding Win Gold Competition of the Competition Pack and the prizes therein.

³ Recharge is the amount that will be given to the Winners as talk-time, based on the available denominations/offers in the respective Circle or State. In case in any of the Circles or Circle-groups, the talk-time recharge value or denomination offered in the Competition is not available, the Winners will be provided with the nearest value or denomination available for talk-time, / data or SMS recharge which could be equal to or closest to the recharge value or denomination offered. - For the purposes of selecting the Winner of the Level 1-Daily Prize in the Tamil Nadu and Chennai Circle, the Participant who is the first to score 5 points, during the Competition Period, will be selected as the Winner of the of the Level 1-Daily Prize for the TN and Chennai Circle. In case of a tie in the selection of the Level 1-Daily Prize, for all other Circle-groups, the Winner will be selected through a system generated process scrutinized by an independent audit committee.
- In case of a tie in the selection in any of the other prizes under any Level, 1 round of tie-breaker will be conducted for all the tied MSISDNs on voice. In case of a further tie in the score and time taken, in the tie-breaker, the selection will be conducted by checking the time taken by the MSISDNs to answer x-1, x-2 questions in the tie-breaker. i.e., if the tie-breaker has 35 questions, and there is a tie in this, then, the time taken for an MSISDN to answer 35-1=34 questions will be considered. In case of a tie in this, then the time taken to answer 34-1=33 questions, and so on will be considered.

- 9. - 15. All costs and expenses for collecting the prize unless otherwise specified shall be borne solely by the Winners under this Competition and the prize shall not be transferable and no request shall be entertained by the Organizer for such transfer.
