

Vi – DAILY DELIGHTS OFFER

A. INTRODUCTION

Mobile Premier League

1. For MPL coupon, Vi customers can generate the code from MyVi web (<https://www.myvi.in/vi-daily-delights>) or by sending MPL as sms to 199 from their Vi mobile
2. Bonus cash upto maximum Rs 125 and minimum Rs 50. Early birds get higher bonus cash
3. Usage of bonus cash varies from game-to-game and contest-to-contest
