# TERMS AND CONDITIONS GOVERNING THE OFFER "LIMITED PERIOD SALE - CASHBACK VOUCHER ON UL RECHARGES"

#### A. INTRODUCTION

THIS DOCUMENT IS AN ELECTRONIC RECORD IN TERMS OF THE INFORMATION TECHNOLOGY ACT, 2000 AND RULES THERE UNDER AS APPLICABLE. THIS ELECTRONIC RECORD IS GENERATED BY A COMPUTER SYSTEM AND DOES NOT REQUIRE ANY PHYSICAL OR DIGITAL SIGNATURES.

THE FOLLOWING TERMS & CONDITIONS SHALL BE APPLICABLE TO THE ELIGIBLE SUBSCRIBER OF VODAFONE IDEA LIMITED ("VODAFONE IDEA/VIL/Vi") PREPAID SUBSCRIBERS AVAILING SPECIFIC RECHARGE PLANS AS MENTIONED UNDER THE OFFER DETAILS AND AVAILING (SUBJECT TO ELIGIBILITY) THE BENEFITS KNOWN AS "LIMITED PERIOD SALE - CASHBACK ON UL RECHARGES " ("OFFER") DURING THE OFFER PERIOD AS MENTIONED HEREIN.

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE AVAILING THIS OFFER KNOWN AS "LIMITED PERIOD SALE - CASHBACK ON UL RECHARGES ". #### **B. DEFINITIONS**

#### 1. Description :

- a. All Eligible Subscribers, whose Vi Number is successfully recharged with the Eligible Plans via any channel during the validity of the offer shall be entitled to a cashback coupon as per grid. ("Cashback") would be credited in the form of the vouchers of equivalent value.
- b. This Offer does not apply to non-VIL customers.

- d. All consumer plans are meant only for the use of retail customers and are not meant for commercial/non-retail use.
- e. The Eligible Subscriber shall receive the Cashback in the form of the vouchers on his Vi App/Website account associated with the Vi number on which the recharge was done.

- f. The Eligible subscribers shall receive the vouchers in their account within 1 week post recharging with the above mentioned Eligible Plans during offer period as mentioned below.
- g. These vouchers are linked to the number recharged. Those customers who do not already have the Vi App/Website account can redeem the vouchers by logging into Vi App/Website with their respective MSISDNs.
- h. The Eligible Subscriber shall be able to view the vouchers within 1 week after doing the recharge. He/She can use the same for future recharges in the Vi App/Website. Voucher will only be applicable on applicable Unlimited Pack recharges done on Vi App/Website, mentioned herein above.

No further notice shall be given by VIL in this regard.
