#### A. INTRODUCTION

THIS ELECTRONIC RECORD IS GENERATED BY A COMPUTER SYSTEM AND DOES NOT REQUIRE ANY PHYSICAL OR DIGITAL SIGNATURES. THE CONTEST IS AN OPTIONAL CONTEST CONCEPTUALIZED, ORGANIZED AND HOSTED BY ONE97 COMMUNICATIONS LIMITED, A COMPANY INCORPORATED UNDER THE COMPANIES ACT, 1956 AND HAVING ITS REGISTERED OFFICE AT , 1st Floor, Devika Tower, Nehru Place, New Delhi – 110019 and corporate office at B-121, Sector 5, Noida, UP 201301 AND ITS CORPORATE OFFICE AT \_\_\_\_\_\_\_ (HEREINAFTER REFERRED TO AS ""One97" OR "ORGANIZER") FOR THE ELIGIBLE RIGHTFUL SUBSCRIBERS OF VODAFONE IDEA LIMITED, (HEREINAFTER REFERRED TO AS "VODAFONE IDEA").

THE FOLLOWING TERMS & CONDITIONS SHALL BE APPLICABLE TO ALL VODAFONE IDEA POSTPAID & PREPAID SUBSCRIBERS PARTICIPATING IN THE CONTEST KNOWN AS "SET & WIN COMPETITION ("COMPETITION / CONTEST") DURING THE CONTEST PERIOD AS MENTIONED HEREIN.

## E. CONTEST DETAILS — ACTIVATION, STEPS AND RESTRICTIONS

#### Refer Exhibit B.

- 21.1. a. Once a Vodafone Idea Subscriber subscribes to RING BACK TONE service (referred to as "RBT") or an existing RBT subscriber sets a new song as their RBT, during the Competition Period, then they become eligible to participate in the Competition.

- 21.10. g. Competition will be available on 5040455 (Tollfree) for Vodafone Subscribers & 53222 (Toll-free) for Idea Subscribers. Eligible Subscribers can play the Competition by dialing 5040455 (Vodafone) & 53222 (Idea) and answering the questions on IVR by pressing the relevant key for the answers.
- 21.11. h. Each question will have two (2) answer options

- 21.13, i. For every right answer, the Participant will get ten (10) points. There is no negative marking for a wrong answer.
- 21.14. j. After every right/wrong answer, the Participant will be given its score, followed by the next question.
- 21.15, k. Questions will be given to the Participant on RANDOM basis.
- 21.16. I. If the Participant gives an invalid input, then an SMS will be sent to the Participant describing it as an invalid answer,
- 21.17. m. If the Participant stops playing the Competition after answering the nth question, then when Participant dials the IVR again, Participant will continue with the (n+1)th question. The Participant can continue playing by dialing 5040455(Vodafone) & 53222(Idea), to receive the next question.
- 21.18. n. If the Participant has completed all the allotted questions as per their eligibility (i.e., number of questions allotted basis the charged amount) and dials the IVR again, they will be listening to a prompt informing that they have already answered all allotted questions and that they can answer more questions by downloading more songs in the RBT service.
