- 8. - b) The Organizer at its sole discretion may send engagement OBD to the Participants to continue with the Challenge.
- c) Customer needs to subscribe in to above said service and post subscription to service and upon charging on every event day, they will be asked 5 multiple choice skill based questions every day
- d) On playing & upon correctly answering the questions subscriber will be getting the score which will be added to their profile.
- e) Each correct answer will carry 10 points. There will be no negative marking for wrong answer.
- f) Questions will be allotted to the subscribers basis his charging on that particular day, eg. If subscriber is charged for Rs 5 on the particular day he can play all 5 questions, but if he is charged for Rs 4 in that case he will be given 4 questions and so on.
