

TERMS AND CONDITIONS GOVERNING THE OFFER "100% CASHBACK OFFER"

A. INTRODUCTION

THIS DOCUMENT IS AN ELECTRONIC RECORD IN TERMS OF THE INFORMATION TECHNOLOGY ACT, 2000 AND RULES THERE UNDER AS APPLICABLE. THIS ELECTRONIC RECORD IS GENERATED BY A COMPUTER SYSTEM AND DOES NOT REQUIRE ANY PHYSICAL OR DIGITAL SIGNATURES.

THE FOLLOWING TERMS & CONDITIONS SHALL BE APPLICABLE TO VIL PREPAID SUBSCRIBERS AVAILING specific recharge plans as mentioned under the Offer Details AND PARTICIPATING (SUBJECT TO ELIGIBILITY) IN THE OFFER KNOWN AS "100% CASHBACK OFFER" ("Offer") DURING THE OFFER PERIOD AS MENTIONED HEREIN.

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE PARTICIPATING IN THIS OFFER KNOWN AS "100% CASHBACK OFFER". BY PARTICIPATING IN THE OFFER, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS ("TERMS AND CONDITIONS"). - a. "Subscriber" shall mean the rightful user of the VIL mobile connection who is on prepaid subscription, in whose name the mobile phone number (MSISDN) is registered with VIL.
- b. "Active Subscriber" shall mean a Subscriber who uses the Subscriber Identity Module ("SIM") of VIL on a regular basis for purposes other than to participate in any offer or contest offered by VIL.
- c. "Eligible Products" shall mean all those prepaid recharge plans as specified below under the Offer details.
- d. "Eligible Subscriber" shall mean an Active Subscriber who is a prepaid customer of VIL and whose number has been recharged with Eligible Products to avail the Offer. An Eligible Subscriber must also satisfy the following criteria at the time of participation and during continuation of Offer:-

4.6. C. OFFER DETAILS – DESCRIPTION, ELIGIBLE PRODUCTS, STEPS AND RESTRICTIONS

4.1. 1. DESCRIPTION

(d) All consumer plans are meant only for the use of retail customers and are not meant for commercial/ nonretail use. Following usage by customers will be deemed to be Commercial/ non-retail usage and shall be chargeable as per the governing policy

(e) The Eligible Subscriber shall receive the Cashback in the form of the vouchers equivalent to the value of the successful recharge value of the Eligible Product. ("Vouchers") in Eligible Subscriber's MyIdeaApp ("MIA") associated with the Idea number, on which the recharge was done thru MyIdeaApp during the offer period.

(f) The Eligible subscriber shall receive the Vouchers in his /her MIA account within 24-48 hrs. of recharging its Idea MSISDN with the Eligible Products as mentioned hereinabove.

(g) These vouchers are linked to the number recharged. Those customers who do not already have MIA can get the vouchers by downloading MIA from the Android Play store with the eligible MSISDN and do a self-recharge with aforementioned MRPs.

(h) The Eligible Subscriber shall be able to view the Vouchers at any time in his MIA.

(i) The Eligible Subscriber shall be entitled to redeem the Vouchers for any future recharges mentioned under Eligible Product only by using MIA. The Eligible Subscriber can redeem a maximum of INR 50/- from these vouchers against each future recharge. The last Voucher shall be adjusted to round off the remaining balance.

(j) The Voucher balance credited in MIA account under this Offer is NOT redeemable for cash or to be used for any other purchases by the Eligible Subscriber.
