Terms and Conditions:

The CHASE YOUR DREAM SEASON 12 (hereinafter referred to as "Challenge") is conceptualized, organized and conducted by OnMobile Global Limited having its registered office at Tower #1 94/1C & 94/2, Veerasandra Village, Attibele Hobli, Anekal Taluk, Electronic City Phase1, Bengaluru, Karnataka 560100 (hereinafter referred to as Onmobile) in association with Vodafone Idea Limited, a company incorporated under the provisions of the Companies Act, 1956 and having its registered office at Suman Tower, Plot No. 18, Sector – 11, Gandhinagar – 382 011 and its corporate office at 10th Floor, Birla Centurion, Century Mills Compound, Pandurang Budhkar Marg, Worli, Mumbai 400030.

Onmobile and Vodafone Idea Limited shall hereinafter be jointly or individually as the context may require be referred to as "Organizer/s".

1. Eligibility Criteria to participate:

This Challenge is available only to the Active Subscribers1 of Idea (prepaid and postpaid) and who fulfill the following criteria:

- · Subscriber must be of or above 18 years of age;
- · Subscriber must be a resident of India:

1 Active Subscriber shall mean the Subscriber who uses the Subscriber Identity Module ("SIM") on a regular basis for purposes other than to participate in this Challenge or any other challenges offered by the Organizers.

Subscriber shall mean the rightful user of the Idea connection, in whose name the mobile phone number (MSISDN) is registered with the operator. In the event the number / connection is registered in the name of a company orfirm, the employee who is authorized to use the MSISDNshall submit a No Objection Certificate and authorization of the employer duly permitting the employee to use the MSISDN for participation in the Challenge, receive the gratifications and accept the terms applicable for the Challenge.

- Subscriber must not have been either convicted and / or prosecuted for commission of any criminal offence nor be of an unsound mind;
- Subscriber must not be under any legal disability e.g. insolvency, restraint by court order etc. and / or is prohibited from entering any contractual relationship
- Active Subscribers of Idea who fulfill the above eligibility criteria and participate in/register for the Challenge shall hereinafter be referred to as "Participant/s". The employees of the Organizers and of their group companies, affiliates or associate companies shall not be eligible to participate in the Challenge.

- Warrant that You have read understood and agreed to conform to these Terms and Conditions.
- Warrant the accuracy, truthfulness and currency of all information that You have submitted.
- You are acting voluntarily, using your own time and resources to participate in the Challenge solely at your own risk.

The Terms and Conditions can be amended or varied from time to time or withdrawn and therefore, please visit the Website periodically to keep yourself updated and informed.

2. Nature of Challenge Procedure and Gratification

The Challenge is available on IVR and SMS only. The Organizer at its sole discretion may send OBD to the Participants to continue with the Challenge.

The subscriber may register for the Challenge either by calling the toll-free number 55256 or sending SMS "DREAM" to 55256 or through USSD String *777#.

All questions are in multiple choice format and the answer to each must be selected from one of the 2 options only. For every right answer, the Subscriber will get one [1] point. There is no negative marking for a wrong answer.

In IVR, the Participant will press "1" for option 1 or press "2" for option 2 on their phone keypad to answer each question of the Challenge. In SMS, the Participant have to reply "A" for option 1 or reply "B" for option 2.

The challenge consists of total 450 skill based questions. 5 questions per day. To start, post registration as above, Dial 55256 or send SMS "GOLD" to 55256

After every answer, the Participant will be given an appropriate response followed by the updated score and given the next question and answer options.

The Participants may discontinue participating in the Challenge anytime by calling 155223 / Sending SMS "STOP" to 155223.

During the playing of the challenge if a Participant drops call/ stops replying on SMS, the same day the Participant will get the same unanswered question. Post which Participant will receive the nth question and (n+1)th question. If the Participant does not receive question for any reason, the same process as above has to be followed. If a Participantparticipates in the Challenge over all the channels (IVR/SMS/USSD), the Participant's score will only be cumulative and not exclusive for each of the channels

Participant can subscribe and unsubscribe to the Challenge any number of times during the Challenge validity.

Below is the selection criteria *for all types of gratification:

i) Highest score ii) Minimum time **

- * Selection criteria to be applied in context of a type of gratification applicable for a day/month/week/specific period/entire Challenge period.
- **Time calculation for IVR will start as soon as Subscriber hears "Beep" sound after the question is put to the Participant and will end as soon as the Participant answers that question by pressing relevant key option. Time calculation for SMS will start as soon as the question is put to the Subscriber and will end when the answer is received by the Organizer.

 However the Participants agree that an SMS sent by the

Participant may not be received by the Organizers instantly due to various factors outside the control of the Organizers such as network failure or system failure. The time for recording answer shall be the time at which the Organizer receives the SMS with answer and not the time at which the Participant sends SMS with answer.

In the selection of the Bumper, Circle Bumper, Cricket Week, iPhone Week, Weekly Gratification and Surprise Bumper Gratification, in case of a tie in the score and in the time taken to answer, 1 round of tie-breaker will be conducted for all the tied MSISDNs on voice. In case of a further tie in the score and time taken, in the tie-breaker, the selection will be conducted by checking the time taken by the MSISDNs to answer x-1, x-2 questions in the tie-breaker. i.e., if the tie-breaker has 35 questions, and there is a tie in this, then, the time taken for an MSISDN to answer 35-1=34 questions will be considered. In case of a tie in this, then the time taken to answer 34-1=33 questions, and so on will be Considered. In case of a tie in the selection of Daily Bumper Gratification and Daily 1st Gratification the Highest Scorers will be selected which MSISDN has achieved the score 1st in point of time. In case of a further tie, all eligible MSISDNs will be gratified. The Participants who fulfill the selection criteria mentioned herein will be declared as "Highest Scorer/s" of that gratification type.

In the selection of the Highest Scorers of all the gratifications except Bumper and Circle Bumper Gratification and Surprise Bumper Gratification the score considered for selection will NOT include the scores accumulated by users by answering missed questions if any and will only consider the respective question of each particular day.

Scores of users who are charged later for the earlier days will NOT be consider for all the gratifications except Bumper Gratification, Circle Bumper Gratification and Surprise Bumper Gratification.

For all the gratifications, the points scored by an MSISDN from the questions that the MSISDN is entitled to answer in a day, based on that day's charged value will only be considered for selection.

The time taken for answering a question on "Voice" mode, is calculated from the time OnMobile's system plays 'beep' (after question) till the answer DTMF input received by system.

On SMS channel time taken is calculated from the time system pushes the question till the answer input received by system.

Note: Highest Scorers (including spouse of Highest Scorers and immediate/first blood relatives of

Highest Scorers) of previous 3 challenges organized by Onmobile for Vodafone Idea Limited who have got a

Bumper Gratification shall not be eligible for the Bumper Gratification Honda City under this Challenge. This condition is applicable only for the Bumper Gratification.

Highest Scorers (including spouse of Highest Scorers and immediate/first blood relatives of Highest Scorers) of previous challenge organized by OnMobile for Vodafone Idea Limited who have won a Circle Bumper Gratification shall not be eligible for the Circle Bumper Gratification under this Challenge.

The Highest Scorer of any type of Bumper Gratification, Circle Bumper Gratification and Surprise Bumper Gratification having different MSISDN's will not be eligible for more than 1 type of Bumper gratification under this Challenge. Participants who are charged Rs 5 will get to answer 5 questions.
