## Terms and Conditions:

The **Recharge Challenge for Gold & Car – Season 10** (hereinafter referred to as a "Challenge") is conceptualized, organized and conducted by OnMobile Global Limited having its registered office at Tower #1 94/1C & 94/2, Veerasandra Village, Attibele Hobli, Anekal Taluk, Electronic City Phase-1, Bengaluru, Karnataka 560100 (hereinafter referred to as OnMobile) in association with **Vodafone Idea Limited**, a company incorporated under the provisions of the Companies Act, 1956 and having its registered office at Suman Tower, Plot No. 18, Sector – 11, Gandhinagar – 382 011 and its corporate office at 10<sup>th</sup> Floor, Birla Centurion, Century Mills Compound, Pandurang Budhkar Marg, Worli, Mumbai 400030

OnMobile and Idea shall hereinafter be jointly or individually as the context may require be referred to as "**Organizer/s**".

### 1. Eligibility Criteria to participate:

This Challenge is available only to the Active Subscribers of Idea (prepaid) and who fulfill the following criteria:

Subscriber must be of or above 18 years of age;

Subscriber must be a resident of India;

Subscriber must not be a resident of Telangana state;

Subscriber must not have been either convicted and/or prosecuted for commission of any criminal offence nor be of an unsound mind;

Subscriber must not be under any legal disability e.g. insolvency, restraint by court order etc. and / or is prohibited from entering any contractual relationship

Subscriber must have done recharge of any Top Ups (excluding combo packs, choice recharge, magic recharge and unlimited packs) of any denomination ("Applicable Packs") on or before 23:59Hrs 22nd, August 2018. For any recharge done after 00:00 hours of 00:00Hrs 23rd August 2018 Subscriber shall not be allowed to participate.

Roaming Participants cannot participate in the challenge outside home circle on IVR channel. Instead Participants can participate in the challenge on SMS channel while on roaming network. The points scored while roaming outside home circle on SMS channel will be considered for Winner selection.

Active Subscribers of Idea who fulfill the above eligibility criteria and participate in/register for the Challenge shall hereinafter be referred to as "Participant/s". The employees and family members of the Organizers and of their group companies, affiliates or associate companies shall not be eligible to participate in the Challenge.

By participating in this Challenge, You/Participant:

Warrant that You have read understood and agreed to conform to these Terms and Conditions.

Warrant the accuracy, truthfulness and currency of all information that You have submitted.

You are acting voluntarily, using your own time and resources to participate in the Challenge solely at your own risk.

### 2. Nature of Challenge Procedure and Gratification

The Challenge is available on IVR, and SMS only. The Organizer may after taking consent from the Participant, send OBD to the participants to continue with the Challenge.

To subscribe through SMS reply "START" to 552560

To initiate questions and start playing SMS reply "PLAY" to 552560

To Subscribe and Play on IVR (Voice) by calling on 552560.

Post obtaining the two level consent for Participating, the Participant will be successfully subscribed for the Challenge. The Challenge will be available in voice in English, Hindi, Telugu, Gujarati, Tamil, Kannada, Malayalam, Marathi and Bengali languages.

All questions are in multiple-choice format and the answer to each must be selected from one of the two options only. For every right answer, the Participant will get one [1] point. There is no negative marking for a wrong answer.

In IVR, the Participant will press "1" for option 1 or press "2" for option 2 on their phone keypad to answer each question of the Challenge. In SMS, the Participant have to reply "A" for option 1 or reply "B" for option 2.

1<sup>st</sup> Free question (general knowledge) - Participants will have to answer appropriately by Call/Reply on 552560, which will be free.

There will be total 540 skill based questions. 6 questions per day. To start, post registration as above, dial 552560 or send SMS "PLAY" to 552560.

After every answer, the Participant will be given an appropriate response followed by the updated score and given the next question and answer options.

The Participants may discontinue participating in the Challenge anytime by calling 155223 / Sending SMS "STOP" to 155223.

Participant can subscribe and unsubscribe to the Challenge any number of times during the Challenge validity.

During the playing of the challenge if a participant drops call/ stops replying on SMS, the same day the participant will get the same unanswered question. Post which Participant will receive the nth question and (n+1)th question. If the Participant does not receive question for any reason, the same process as above has to be followed.

If a Participant participates in the Challenge over all the channels (IVR/ SMS), the Participant's score will only be cumulative and not exclusive for each of the channels.

Below is the selection criteria \*for all types of gratification:

i) Highest score

ii) Minimum time \*\*

One individual irrespective of the MSISDN can win only one of the Bumper Gratification, National Bumper Gratification, , and Circle free Bumper Gratification.

In the selection of gratification, except Bumper Gratification, National Bumper Gratification, Circle Free Bumper Gratification, the score considered for selection will not include the scores accumulated by participants by answering missed questions if any and will only consider the respective question of each particular day.

One MSISDN can Win Special Cash Offer, Special Bike Friday Gratification, Weekly Gratification, Daily Bumper Gratification, Daily 1st Gratification, and DailyEarly Bird Gratification, only once in the Challenge.

Scores of participants who are charged later for the earlier days will not be considered for gratifications, except Bumper Gratification, National Bumper Gratification, Circle Free Bumper Gratification.

The time taken for answering a question on "Voice" mode, is calculated from the time OnMobile's system plays "beep" (after question) till the answer DTMF input received by system. On SMS channel time taken is calculated from the time system pushes the question till the answer input received by system, for the purpose of determining the relevant Gratifications under this Challenge, respectively.

Note: If a participant plays the Challenge over all the channels (Voice/SMS), participant's score will only be cumulative and not exclusive for each of the channels. i.e.: if the participant has started playing the Challenge on voice and has scored 2 points in 3 questions, if participant drops the call and resumes playing through SMS, the participant will be given the 4th question, and if participant answers the question correctly, participant's score will be 30. And this will be the score that will be considered for the selection for all the Gratifications.

In the selection of the challengers of all the above gratifications except Bumper Gratification, the score considered for selection will NOT include the scores accumulated by users by answering missed questions if any and will only consider the respective question of each particular day.

\*The Participant also can answer questions of the Future Days of the challenge; post answering Present, and Missed Questions of the past days. Charging for the played Future days' Questions will happen on those specific Future days. Score of these future days' questions will be considered for gratification selection, only if the participant is charged on those respective future days.

(E.g. Participant subscribes to the 90 days challenge on Day 10.

In this case, Participant will be presented questions of Day 10, followed by questions of Day1 to Day 9, which were missed by the Participant earlier.

Post answering all these questions (i.e. Day 1 to Day10) Participant can answer future days' questions from Day 11 to Day 90. Score of these future questions for Day 11 to Day 90 will be considered for gratification selection only if the Participant is charged on those specific days i.e. Day 11, Day 12,...till Day 90.)

Scores of users who are charged later for the earlier days will NOT be consider for any of the above gratifications except Bumper Gratification.

For all the above gratifications, the points scored by an MSISDN from the questions that the MSISDN is entitled to answer in a day, based on that day's charged value will only be considered for selection.

\* Selection criteria to be applied in context of a type of gratification applicable for a day/month/week/specific period/entire Challenge period.

\*\*Time calculation for IVR will start as soon as Participant hears "Beep" sound after the question is put to the Participant and will end as soon as the Participant answers that question by pressing relevant key option. Time calculation for SMS will start as soon as the question is put to the Participant and will end when the answer is received by the Organizer.

However the Participants agree that an SMS sent by the Participant may not be received by the Organizers instantly due to various factors outside the control of the Organizers such as network failure or system failure. The time for recording answer shall be the time at which the Organizer receives the SMS with answer and not the time at which the Participant sends SMS with answer.

In case of a tie in the selection in the Bumper Gratification, National Bumper Gratification, Circle Free Bumper Gratification, Special Cash Week Gratification, Special Bike Friday and Weekly Gratification in Score 1 round of tie-breaker will be conducted for all the tied MSISDNs on Voice. In case of a further tie in the score and time taken, in the tie-breaker, the selection will be conducted by checking the time taken by the tied MSISDNs to answer x-1, x-2 questions in the tie-breaker. i.e., if the tie-breaker has 35 questions, and there is a tie in this, then, the time taken for tied MSISDNs to answer 35-1=34 questions will be considered. In case of a tie in this, then the time taken to answer 34-1=33 questions, and so on will be considered. In case of a tie in the selection of gratifications for Daily Bumper Gratification, and Daily 1<sup>st</sup> Gratification the MSISDN that has achieved the relevant score as detailed above, first in point of time, which shall be electronically recorded by an independent system of the Organizer. The Participants who fulfill the selection criteria mentioned herein will be declared as "Highest Scorer/s" of that gratification type.

Note: Every day first question time taken will not be considered for any gratification selection.

The process of Highest Scorer selection for each category of gratification will be witnessed by an independent third party auditor appointed by the Organizer ("Independent Auditor") who shall after selection of Highest Scorers will certify such process.

\*In case of zero balance: No questions, no charges

\* In case of insufficient balance – Remaining missed questions of that day can be carried forward to any subsequent day after recharge

Based on the amount charged, participant will be allowed to answer questions

Participants who are charged Rs 3 will get to answer 6 questions

Participants who are charged Re 2 will get to answer 4 questions

Participants who are charged Re 1 will get to answer 2 questions

\*Participant can answer the questions of any missed days of the Challenge after paying charges for the missed questions. Missed days of Challenge mean such days of the Challenge when a Participant could not continue with the Challenge for any reason whatsoever.

The aforesaid charges paid by the Participant are towards the service and no additional charge is collected from the Participant for participating in the Challenge.

14. The Organizers make no representation of having a business relationship or tie up with any such companies, individuals or any other organization whose products are offered as gratifications in the Challenge. All trade names shall continue to remain owned by their respective owners.

Photocopy of PAN card;

Address Proof;

Affidavit only in case of Bumper Highest Scorer – that the Highest Scorer (including spouse of Highest Scorer and immediate/first blood relatives of the Highest Scorer) has not got any Bumper in last 3 challenges organized by OnMobile for the subscriber of Vodafone Idea Limited. The content for such Affidavit shall be provided by OnMobile. Affidavit should be submitted by the Highest scorer to OnMobile at Participant's own cost within 10 days from the date of intimation, failing which Organizers reserves the right to award Bumper Gratifications to the next eligible Highest Scorer.

Authorization letter or NOC - In case MSISDN is registered in the name of a company or firm, the employee who is authorized to use the MSISDN shall submit a No Objection Certificate and authorization letter of the employer. Letter of compliance with rules and regulations and declarations in the format as may be required by the Organizers or applicable laws (if applicable).

17. The gratification(s) under this Challenge are neither assignable nor transferable under any circumstance, unless specifically provided hereunder. No other person or agent can claim the gratification on behalf of the Highest Scorer, unless otherwise expressly mentioned herein. Further in case of death of the Higher Scorer after being selected as a Higher Scorer, the gratification can be claimed by the legal heir of the deceased MSISDN provided, such legal heir shall produce the death certificate and legal heir certificate within 15 days of such intimation by the Organizers. 18. The Meet And Greet event is subject to the availability of celebrity. The Organizer as per the availability of the celebrity may reschedule the Meet And Greet event or at their sole discretion reserve the right to substitute gratification(s) of equal or greater value at any time. However under no circumstance shall the Highest Scorer of the Challenge be entitled to redeem any category of gratification for cash.

19. To claim gratification/s under the Challenge, the MSISDNs/Participants chosen as the Highest Scorers shall be required to be Active Subscribers of Idea. The Highest Scorers shall not be entitled to the gratification in case the participant fails to clear all outstanding dues payable to Idea.

20. The Organizers shall not be responsible for any claims arising out of any failure(s) which is beyond their reasonable control.
