TERMS AND CONDITIONS GOVERNING THE #AiConicFANfest PROGRAM

A. INTRODUCTION

THIS #AiConicFanfest Program (Hereinafter "Program") IS OPTIONAL FOR THE SUBSCRIBERS OF VODAFONE IDEA LIMITED (HEREINAFTER REFERRED TO AS "VIL/VODAFONE IDEA"). B. DEFINITIONS

"Subscriber/You" shall mean a subscriber in whose name the Subscriber Identity Module (SIM) is registered with VIL.
