# A. INTRODUCTION

THE FOLLOWING TERMS & CONDITIONS SHALL BE APPLICABLE TO THE ELIGIBLE SUBSCRIBER OF VODAFONE IDEA LIMITED ("VODAFONE IDEA/VIL/Vi") POSTPAID SUBSCRIBERS AVAILING SPECIFIC POST-PAID PLAN AS MENTIONED UNDER ELIGIBLE PLAN AND AVAILING (SUBJECT TO ELIGIBILITY) THE BENEFITS KNOWN AS "FESTIVE DELIGHTS OFFER" DURING THE OFFER PERIOD AS MENTIONED HEREIN. THIS IS A LIMITED PERIOD OFFER.
