

TERMS AND CONDITIONS GOVERNING THE "INDEPENDENCE DAY" OFFERS

A. INTRODUCTION

THIS DOCUMENT IS AN ELECTRONIC RECORD IN TERMS OF THE INFORMATION TECHNOLOGY ACT, 2000 AND RULES THERE UNDER AS APPLICABLE. THIS ELECTRONIC RECORD IS GENERATED BY A COMPUTER SYSTEM AND DOES NOT REQUIRE ANY PHYSICAL OR DIGITAL SIGNATURES.

THE INDEPENDENCE DAY OFFERS - EXTRA DATA, INSTANT DISCOUNT AND SPIN THE WHEEL ("**OFFER/S**"), ARE CONCEPTUALIZED, ORGANIZED AND HOSTED BY VODAFONE IDEA LIMITED ("**VODAFONE IDEA/VIL/Vi**") FOR THE ELIGIBLE SUBSCRIBERS OF VIL.

BY PARTICIPATING IN THE OFFER, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS ("TERMS AND CONDITIONS"). IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT PARTICIPATE IN THE OFFER.

FOR THE PURPOSES OF THESE TERMS AND CONDITIONS, WHEREVER THE CONTEXT SO REQUIRES "YOU" OR "YOUR" SHALL MEAN ANY NATURAL PERSON WHO BEING AN ELIGIBLE SUBSCRIBER HAS PARTICIPATED IN THE OFFER.

B. DEFINITIONS

- a. "**Subscriber**" shall mean the rightful user of the VIL mobile connection who is on prepaid subscription, in whose name the mobile phone number (MSISDN) is registered with VIL.
- b. "**Active Subscriber**" shall mean a Subscriber who uses the Subscriber Identity Module ("SIM") of VIL including Subscribers who have done FRC, for purposes other than to participate in any offer or contest offered by VIL.
- c. "**Eligible Subscriber**" shall mean an Active Prepaid Subscriber of VIL who has availed the Offer. An Eligible Subscriber must also satisfy the following criteria at the time of participation and during continuation of Offer:-
 - i. Subscriber must be an Indian citizen belonging to any one of the cities / Circles of VIL as mentioned herein;
 - ii. Subscriber must not have been subject of any criminal proceeding;
 - iii. Subscriber must not - be of an unsound mind;
 - iv. Subscriber must not be under any legal disability e.g. minority, insolvency, restraint by court order etc. and / or is otherwise prohibited from entering into any contractual relationship;
 - v. Subscriber must recharge on the Vi App with the prepaid packs as prescribed for the relevant Offer.

C. OFFER DETAILS – DESCRIPTION, , STEPS AND RESTRICTIONS

1. DESCRIPTION

Extra Data

- a. The Eligible Subscriber who recharges on Vi app with a long validity unlimited recharge pack above Rs. 199 during the Offer Period, will be entitled to extra assured data at no charge over and above the standard recharge benefits.

- c. The extra data Offer is available only on eligible recharge packs and only for the recharges done through Vi app.
- d. The extra data Offer is open from 12/08/2023 to 18/08/2023 (“Offer Period”)
- e. Customer gets additional data benefit over and above the standard product benefit which he/she is entitled under the existing recharge pack with no additional charge. e.g. with Recharges 449, customer will get additional 2GB data/day for 56 days, therefore total data quota will be 4GB/day for 56 days.
- f. The extra data Offer is available only once for one MSISDN during the Offer Period.

Instant Discount

- a. The Eligible Subscribers who recharges on Vi app with recharge pack of Rs. 1449 or Rs. 3099 will be entitled to instant discount of Rs. 50 and Rs. 75 respectively in the recharge price.
- b. To get the discount, the Eligible Subscriber has to first apply the coupon code available at Vi app before proceeding with the recharge transaction.
- c. On applying the code the Eligible Subscriber has to pay only the balance amount to buy the recharge.
- d. The instant discount Offer is open from 12/08/2023 to 18/08/2023.
- e. The discount coupon code to be applied at the time of recharge and cannot be claimed later.
- f. The instant discount is available only on the above two recharge packs and only for the recharges done through Vi app.
- g. The instant discount Offer is available only once for one MSISDN during the Offer Period.

Spin the Wheel Challenge

- (a) Eligible Subscribers who recharges on Vi app for specified recharge pack will be entitled to an assured gift every hour after spinning the wheel and answering a qualifying challenge question correctly.

Each of the above mentioned Offer is an independent offer and for a limited period from 12/08/2023, 2023 till 18/08/2023, 2023 ("**Offer Period**").

E. OFFER AREA

- i. All existing VIL telecom service areas.
- ii. Notwithstanding the foregoing, if the operation of or participation in the Offer is prohibited in any State and/or territory or part thereof as per applicable law, the Subscribers from such state and/or territory or part thereof shall not be eligible to subscribe to this Offer. No further notice shall be given by VIL in this regard.

F. MODIFICATION OF OFFER

- a. VIL reserves the right, at their sole discretion, to modify these Terms & Conditions of the Offer or any part thereof at any time during the Offer Period and without prior notice to You, if so required in view of business exigencies and/or guidelines issued / amended by TRAI, Department of Telecom (DOT) and/or statutory changes and the same shall be binding on the participating Subscribers availing this Offer.
- b. If VIL modifies these Terms, the modified terms will be posted on www.myvi.in. You are therefore advised to check this Website regularly for any update(s) or amendment(s) made to these Terms and Conditions and in the event the modified or amended Terms and Conditions are not acceptable to You, You should discontinue participating in the Offer. Your continued participation in the Offer will constitute Your acceptance of the latest revised Terms and Conditions.

G. WITHDRAWAL OF OFFER

- a. VIL reserves the right to extend, cancel, discontinue, suspend or prematurely withdraw the Offer at any time during its validity as may be required in view of business exigencies and/or changes by TRAI, Department of Telecom (DOT) and/or statutory changes without any notice to You and the same shall be binding on the participating Subscribers availing this Offer.

- a. The employees of VIL and their group companies, affiliate or associate companies shall not be eligible to participate in the Offer.
- b. You agree that this Offer is being made purely on a "best endeavour" basis and subject to acceptance of these Terms and Conditions. Your participation in the Offer is voluntary and You expressly agree to avail the Offer at your sole risk. VIL shall not be responsible for any loss, injury or any other liability to any Subscriber arising due to participation in the Offer.

- c. VIL makes no representation or warranty of any kind whatsoever, whether express or implied, including, but not limited to, meeting of Your requirements or aspirations, timeliness, security of the Offer and/or any delay or failure to avail the Offer including due to technical or network problems. Further, You understand that the goods provided as prize may carry manufacturer's guarantee and in case of any deficiency in the goods, You will contact the manufacturer only.

- l. Subscriber may contact the customer care regarding any queries, complaints, disputes pertaining to the Offer.
- m. You hereby authorize VIL to collect your personal information including name, address and mobile number etc. and share with its partners so as to enable You to avail the Offer.
