

## TERMS AND CONDITIONS GOVERNING THE Parents Day Challenge

### A. INTRODUCTION

THIS **PARENTS DAY CHALLENGE** (HEREINAFTER “**CHALLENGE**”) IS AN OPTIONAL FOR **VODAFONE IDEA LIMITED** (HEREINAFTER REFERRED TO AS “**VIL**”) SUBSCRIBERS. ### B. DEFINITIONS

“**Eligible Subscriber/You**” shall mean a subscriber in whose name the mobile phone number i.e. Subscriber Identity Module (SIM) is registered with VIL.

**Activity 2:** The activity will be done on our social media platform, Twitter. Participants will be commenting on our Challenge post on Twitter with the ‘things that our parents say on phone’ and of which total 5 winners will be chosen and given shopping vouchers for their interesting/unique answers.

**Method of getting the gifts:** Total top 10 winners from all three platforms, who submit the entries with the best articulation will be selected as the winner.

**Parents Day Winner Announcement:** The winner will be announced in the following week after the Challenge.
