

TERMS AND CONDITIONS GOVERNING THE “EXTRA DATA OFFER”

A. INTRODUCTION

THIS DOCUMENT IS AN ELECTRONIC RECORD IN TERMS OF THE INFORMATION TECHNOLOGY ACT, 2000 AND RULES THERE UNDER AS APPLICABLE. THIS ELECTRONIC RECORD IS GENERATED BY A COMPUTER SYSTEM AND DOES NOT REQUIRE ANY PHYSICAL OR DIGITAL SIGNATURES.

THE OFFER IS CONCEPTUALIZED, ORGANIZED AND HOSTED BY VODAFONE IDEA LIMITED (HEREINAFTER REFERRED TO AS “VODAFONE IDEA/VIL”) FOR THE ELIGIBLE SUBSCRIBERS OF VIL

THE FOLLOWING TERMS & CONDITIONS SHALL BE APPLICABLE TO ALL VIL - PPREPAID IDEA SUBSCRIBERS PARTICIPATING IN THE OFFER KNOWN AS “**EXTRA DATA OFFER**” (“OFFER”) DURING THE OFFER PERIOD AS MENTIONED HEREIN.

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE AVAILING IN THIS OFFER”. BY AVAILING IN THE OFFER, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS (“TERMS AND CONDITIONS”). IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT PARTICIPATE IN THE OFFER.

FOR THE PURPOSES OF THESE TERMS AND CONDITIONS, WHEREVER THE CONTEXT SO REQUIRES “YOU” OR “YOUR” SHALL MEAN ANY NATURAL PERSON WHO BEING AN ELIGIBLE SUBSCRIBER HAS PARTICIPATED IN THE OFFER.

B. DEFINITIONS

- a. “**Subscriber**” shall mean the rightful user of the VIL (Idea) connection who is on prepaid subscription, in whose name the mobile phone number (MSISDN) is registered with Vodafone Idea. In the event the user number / connection is registered in the name of a company/ firm, the employee who is authorized to use the MSISDN shall submit a No Objection Certificate (NoC) and authorization of the employer duly permitting the employee to use the number for subscribing for this Offer and accept the terms applicable herein.
- b. “**Active Subscriber**” shall mean a Subscriber who uses the Subscriber Identity Module (“SIM”) of Idea on a regular basis for purposes other than to participate in any offer or contest offered by Vodafone Idea.
- c. “**Eligible Subscriber**” shall mean an Active Prepaid Subscriber of VIL who has availed the Offer. An Eligible Subscriber must also satisfy the following criteria at the time of participation and during continuation of Offer:–
 - i. Subscriber must be an Indian citizen belonging to any one of the cities / Circles of Vodafone Idea as mentioned herein;

1. Offer Benefits

- a. This Offer is available for Vi App prepaid recharges as per the table mentioned below.
- b. Customer gets additional data benefit only over and above the standard product benefit which he/she is entitled under the existing plan at no extra cost. e.g. with Recharges on Vi App by 299, customer will get additional 5GB data/day for 3 days

- d. The additional data benefits for all Eligible Subscribers will be provisioned within 3-5 mins of Vi App mode recharge

2. Offer Activation Steps:

This is an exclusive offer ONLY for Vi customers recharging via Vi App starting 22/09/2023 till 26/09/2023.

On recharge of Rs299 & above, a Vi user is eligible to get 5GB EXTRA (valid for 3 Days) at no extra cost.

On recharges between Rs199 and Rs299, a Vi user is eligible to get 2GB EXTRA (valid for 3 Days) at no extra cost.

The following recharges are not eligible for the above EXTRA DATA benefit: Rs129, Rs149, Rs155 and Long validity recharges.

3. Restrictions:

All consumer plans are meant only for the use of retail customers and are not meant for commercial/ nonretail use. Any of such usage by Eligible Subscribers will be deemed to be commercial/ non-retail usage and shall be chargeable as per the governing policy. These recharges mentioned herein are not intended for commercial usage

D. OFFER PERIOD

1. This is a limited period offer by VIL, available from 22nd September, 2023, 00:00:01 hrs. till 26th September, 2023 90 days from then unless revoked by VIL ("**Offer Period**").
2. VIL reserves the right to extend or shorten the Offer Period, as it deems fit.

E. OFFER AREA

- i. All existing VIL telecom service areas.
- ii. Notwithstanding the foregoing, if the operation of or participation in the Offer is prohibited in any State and/or territory or part thereof as per applicable law, the Subscribers from such state and/or territory or part thereof shall not be eligible to subscribe to this Offer. No further notice shall be given by VIL in this regard.

F. UNREASONABLE USE

1. It is unreasonable use of the Service/Promotion where Your use of the Service/Promotion is reasonably considered by VIL to be fraudulent use, to be contrary to the way the Service/Promotion is intended to be used ("Intended Use"), or to adversely affect the VIL Network or other VIL customers' use of or access to the Service/Promotion or the VIL Network.
