

## **TERMS AND CONDITIONS GOVERNING THE**

### **“Vi – HMD SUPER SAVER OFFER”**

#### **A. INTRODUCTION**

THIS DOCUMENT IS AN ELECTRONIC RECORD IN TERMS OF THE INFORMATION TECHNOLOGY ACT, 2000 AND RULES THERE UNDER AS APPLICABLE. THIS ELECTRONIC RECORD IS GENERATED BY A COMPUTER SYSTEM AND DOES NOT REQUIRE ANY PHYSICAL OR DIGITAL SIGNATURES.

THE FOLLOWING TERMS & CONDITIONS SHALL BE APPLICABLE TO VODAFONE IDEA LIMITED (HEREINAFTER “**VODAFONE IDEA/VIL**”) NEW PRE-PAID SUBSCRIBERS PURCHASING A NEW SELECT **HMD / NOKIA FEATURE PHONE** AND SATISFYING THE REQUIRED CONDITIONS IN THE OFFER KNOWN AS “**Vi HMD SUPER SAVER OFFER**” (HEREINAFTER KNOWN AS “**OFFER**”) DURING THE OFFER PERIOD AS MENTIONED HEREIN.

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE PARTICIPATING IN THIS OFFER. BY PARTICIPATING IN THE OFFER, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS (“TERMS AND CONDITIONS”). IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT PARTICIPATE IN THE OFFER.

FOR THE PURPOSES OF THESE TERMS AND CONDITIONS, WHEREVER THE CONTEXT SO REQUIRES “YOU” OR “YOUR” SHALL MEAN ANY NATURAL PERSON WHO BEING AN ELIGIBLE SUBSCRIBER HAS PARTICIPATED IN THE OFFER.

#### **B. DEFINITIONS**

“**Subscriber**” shall mean an individual who purchases a new prepaid Vi SIM for mobile connection and in whose name the mobile phone number (MSISDN) will be registered with VIL.

“**Eligible Subscriber**” shall mean a Subscriber who satisfies the following criteria:

- Subscriber must be an Indian citizen belonging to telecommunication service areas of VIL as mentioned herein;
- Subscriber must not have been subject of any criminal proceeding;
- Subscriber must not be of an unsound mind;
- Subscriber must not be under any legal disability e.g. minority, insolvency, restraint by court order etc. and / or is otherwise prohibited from entering any contractual relationship
- Subscriber must purchase the Eligible Device and successfully complete the mandatory FRC (First Recharge) **of ₹140 within 30days of new SIM activation.**

“**Eligible Device**” shall mean HMD Mobile India Private Limited (HMD Mobile) manufactured 2G Feature Phone as listed below in Annexure A, purchased on or after 24th December 2025 and activated for the first time on the VIL network, by an Eligible Subscriber during the Offer Period.

“**Eligible Recharge/Recharges**” refers to the FRC (First Recharge) of ₹ 140 and subsequent recharges of ₹ 140.

#### **C. OFFER DETAILS/OFFER BENEFITS**

- a. The Eligible Subscriber fulfilling the eligibility criteria mentioned above will be entitled to Unlimited Calls + 2GB data + 300 SMS for 28 days.
- b. The Offer entitles an Eligible Subscriber to unlimited calls as available with ₹199 recharge in ₹140 recharge for 28 days plus 2GB data and 300 SMS, making effective savings of ₹59 on every Eligible Recharge for 12 months and thereby making the Eligible Device of approx. ₹ 800 effectively free in 14 Recharges.
- c. The Offer benefits will be available on all Eligible Recharges performed during 12 months from the date of FRC.

#### **D. RESTRICTIONS AND OTHER CONDITIONS:**

- a. The Subscribers not fulfilling the eligibility criteria will be not be entitled to extra benefits available with the Offer and will receive only Unlimited Calls for 15 days as available with ₹140 open market recharge.
- b. The Offer can be availed only once on a mobile number. That is any handset (IMEI) that has become eligible once for the Offer, cannot become eligible for the Offer in future, even in case of a different mobile number.
- c. After every Eligible Recharge, You need to be on the Eligible Device till the validity of the Eligible Recharge to enjoy the Offer benefits.
- d. If the Eligible Subscriber switches to any other device, Offer benefits will be temporarily stopped until the Eligible Subscriber switches back to the Eligible Device.
- e. To continue using the VIL services during the validity of the Eligible Recharge on any other device, you need to recharge with any prepaid unlimited recharge pack

#### **E. OFFER PERIOD**

This is a limited period Offer from **14th January 2026 00:00 hrs till 30<sup>th</sup> June 2026** ("Offer Period") 23.59 Hrs. VIL reserves the right to extend or shorten the Offer Period, as it deems fit.

#### **F. GENERAL**

- a. You agree that this Offer is being made purely on a "best endeavour" basis and subject to acceptance of these Terms and Conditions. Your participation in the Offer is voluntary and You expressly agree to avail the Offer at your sole risk. VIL shall not be responsible for any loss, injury or any other liability to any Subscriber arising due to participation in the Offer.
- b. VIL makes no representation or warranty of any kind whatsoever, whether express or implied, including, but not limited to, meeting of Your requirements or aspirations, timeliness, security of the Offer and/or any delay or failure to avail the Offer including due to technical or network problems. To the extent you choose to avail this Offer, you do so at your own initiative and You shall remain responsible for compliance with the Terms and Conditions herein, any applicable laws, including but not limited to applicable local laws. VIL shall not be responsible for any claims arising out of technical failures before, during or after the completion of the Offer including but not limited to any technical failures in the mobile connectivity, internet connectivity. Further, VIL shall not be responsible for any claims arising out of any failure(s) which is beyond the reasonable control of VIL.
- e. You agree that the terms and conditions of the Eligible Recharge on the VIL website shall be additionally applicable to this Offer.
- f. Offer is not redeemable or refundable for cash, and cannot be exchanged against any other offer benefit;
- g. Offer is non-transferable to any third party.
- h. This Offer cannot be combined with any other offer provided by VIL.
- i. VIL reserves the right to modify, cancel, discontinue or prematurely withdraw the Offer and no further notice shall be given by VIL. - j. Any claims, issues, damages or losses with respect to the Eligible Device shall be the sole responsibility and liability of the manufacturer of the device/handset i.e. HMD Mobile. VIL (including its affiliates or group companies) hereby disclaims, any and all claims, losses and liabilities, arising out of, or in connection with the Eligible Device.
- k. The Offer may not be used for any commercial purpose by the Eligible Subscriber. VIL reserves the right to take back the Offer if it detects any fraudulent usage, or misuse of the service/ benefit.
