

**TERMS AND CONDITIONS GOVERNING THE
Speed se likho Contest**

A. INTRODUCTION

THIS **Speed se likho Contest** (HEREINAFTER “**Contest**”) IS OPTIONAL FOR **VODAFONE IDEA LIMITED** (HEREINAFTER REFERRED TO AS “**VIL**”) SUBSCRIBERS OF Vi. THE SUBSCRIBER/S PARTICIPATING IN THE Speed se likho Contest SHALL BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS. IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT PARTICIPATE IN THE CONTEST

B. DEFINITIONS

“**Eligible Subscriber/You**” shall mean a subscriber in whose name the mobile phone number under Vi™brand Subscriber Identity Module (SIM) is registered with VIL. Within the territorial limits of Gujarat, Daman Diu, Dadranagar Haveli & Silvassa only.

C. Speed se likho Contest DETAILS

i) **Speed se likho Contest Period:** 00:00 hrs of 10th March 2021 to 23:59 hrs of 18th March 2021. VIL reserves the right to extend or shorten the period, as it deems fit. If, in any place or part thereof, as mentioned hereinabove in clause B is mentioned, the running of this Contest is prohibited as per local rules or laws, the Eligible Subscribers from such State and/or territory or part thereof shall not be eligible to participate in the Contest. No any further notice & or any communication will / shall be given by VIL, in this regard.

ii) **Speed se likho contest Description, Selection Process and Gratification:**

Activity: The contest will be done on Facebook and Instagram. Eligible Subscribers may participate in **Speed se likho contest** by taking part in the online contest.

1. Every participant will be eligible for 01 winning entry during the entire contest duration from 00:00 hrs of 10th March 2021 to 23:59 hrs of 18th March 2021 only.
2. All winners will be chosen from the winning entries through a lucky draw and a skill based question. The lucky draw will be conducted by an independent agency whose decision will be final & binding to all participants & winners thereof.
3. There will be a total of 20 winners chosen from 04 lucky draws and skill based questions which will be conducted on 12th, 14th, 16th and 18th of March 2021 each day respectively.
4. There will only be 05 winners chosen in each lucky draw and skill based question as mentioned hereinabove at point No. 03 subject to valid number of entries
