

**TERMS AND CONDITIONS GOVERNING THE**  
**"Vi vivo V50e OTT BUNDLE OFFER"**

**A. INTRODUCTION**

THIS DOCUMENT IS AN ELECTRONIC RECORD IN TERMS OF THE INFORMATION TECHNOLOGY ACT, 2000 AND RULES THERE UNDER AS APPLICABLE. THIS ELECTRONIC RECORD IS GENERATED BY A COMPUTER SYSTEM AND DOES NOT REQUIRE ANY PHYSICAL OR DIGITAL SIGNATURES.

THE FOLLOWING TERMS & CONDITIONS SHALL BE APPLICABLE TO VODAFONE IDEA LIMITED (HEREINAFTER "**VODAFONE IDEA/VIL**") PRE-PAID SUBSCRIBERS PURCHASING A NEW **vivo V50e** AND SATISFYING THE REQUIRED CONDITIONS IN THE OFFER KNOWN AS "**Vi vivo V50e OTT BUNDLE OFFER**" (HEREINAFTER KNOWN AS "**OFFER**") DURING THE OFFER PERIOD AS MENTIONED HEREIN.

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE PARTICIPATING IN THIS OFFER. BY PARTICIPATING IN THE OFFER, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS ("TERMS AND CONDITIONS"). IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT PARTICIPATE IN THE OFFER.

FOR THE PURPOSES OF THESE TERMS AND CONDITIONS, WHEREVER THE CONTEXT SO REQUIRES "YOU" OR "YOUR" SHALL MEAN ANY NATURAL PERSON WHO BEING AN ELIGIBLE SUBSCRIBER HAS PARTICIPATED IN THE OFFER.

**B. DEFINITIONS**

**"Subscriber"** shall mean the rightful user of the VIL mobile connection who is on prepaid subscription, in whose name the mobile phone number (MSISDN) is registered with VIL. In the event the user number / connection is registered in the name of a company/ firm, the employee who is authorized to use the MSISDN shall submit a No Objection Certificate (NoC) and authorization letter of the employer duly permitting the employee to use the number for subscribing for this Offer and accept the terms applicable herein.

**"Eligible Subscriber"** shall mean a Subscriber who satisfies the following criteria:

- Subscriber must be an Indian citizen belonging to telecommunication service areas of VIL as mentioned herein;
- Subscriber must not have been subject of any criminal proceeding;
- Subscriber must not be of an unsound mind;
- Subscriber must not be under any legal disability e.g. minority, insolvency, restraint by court order etc. and / or is otherwise prohibited from entering any contractual relationship
- Subscriber must purchase the **Eligible Device** and successfully recharge with **Eligible Recharge** (Rs. 1197 Prepaid Recharge) on or after **17th April 2025**.

**"Eligible Device"** shall mean device as listed below in Annexure A, purchased and activated for the first time on the VIL network, by an Eligible Subscriber on or after **17th April 2025**.

**“Eligible Recharge”** refers to the VIL **prepaid recharge of Rs. 1197.**

### **C. OFFER DETAILS/OFFER BENEFITS**

Eligible Subscriber, fulfilling the eligibility criteria mentioned above will be entitled for the following

**1) Telco benefits,**

- 3GB daily data
- Unlimited calls
- 100 SMS daily
- Validity 84 days

**2) Extra/additional benefits**

- 12 months of free Vi Movies & TV OTT subscription. The said 12 months free subscription will give OTT benefits equivalent to Vi Movies & TV Plus Pack (monthly subscription of Rs.248 per month). The free subscription will provide you access to premium OTT content from 17 leading OTT platforms like JioHotstar, ZEE5, Sony Liv, Lionsgate Plus, Fancode, Manorama Max, Klikk, Chaupal etc.
- The free 12 months subscription will be credited to the Eligible Subscriber in 4 instalments i.e. 3 months of subscription after every Eligible Recharge. The balance Eligible Recharges have to be made within 1 year of the first Eligible Recharge.
- At the time of the eligible recharge, ensure that the Eligible Device is successfully latched onto the VIL network.

### **Restrictions and Other Conditions:**

- a. The free Vi Movies & TV subscription will be credited in your Vi Movies & TV account within 60 minutes of successful Eligible Recharge.
- b. You will not be entitled to free Vi Movies & TV subscription benefit if your Eligible Device is not latched on to the VIL network at the time of making Eligible Recharge.
- c. The Offer can be availed only once on a mobile number. That is any handset (IMEI) that has become eligible once for the Offer, cannot become eligible for the Offer in future, even in case of a different mobile number.

### **D. OFFER PERIOD**

This is a limited period Offer from **17<sup>st</sup> April 2025 00:00 hrs** till **30<sup>th</sup> Jun 2025 23.59 hrs** (“Offer Period”). VIL reserves the right to extend or shorten the Offer Period, as it deems fit.

### **E. GENERAL**

- a. You agree that this Offer is being made purely on a “best endeavour” basis and subject to acceptance of these Terms And Conditions. Your participation in the Offer is voluntary and You expressly agree to avail the Offer at your sole risk. VIL shall not be responsible for any loss, injury or any other liability to any Subscriber arising due to participation in the Offer.

VIL makes no representation or warranty of any kind whatsoever, whether express or implied, including, but not limited to, meeting of Your requirements or aspirations, timeliness, security of the Offer and/or any delay or failure to avail the Offer including due to technical or network problems. VIL shall not be responsible for any claims arising out of technical failures before, during or after the completion of the Offer including but not limited to any technical failures in the mobile connectivity, internet connectivity. Further, VIL shall not be responsible for any claims arising out of any failure(s) which is beyond the reasonable control of VIL.
- e. You agree that the terms and conditions of the Eligible Recharge on the VIL website shall be additionally applicable to this Offer.
- f. Offer is not redeemable or refundable for cash, and cannot be exchanged against any other offer benefit;
- g. Offer is non-transferable to any third party.
- h. This Offer cannot be combined with any other offer provided by VIL.
- i. VIL reserves the right to modify, cancel, discontinue or prematurely withdraw the Offer and no further notice shall be given by VIL. This disclaimer shall apply to the fullest extent permitted by law and shall survive cancellation/ termination/ determination of this Offer.

This disclaimer shall apply to the fullest extent permitted by law and shall survive cancellation/termination/determination of this Offer.
