

TERMS AND CONDITIONS GOVERNING THE #ViTurns3 PROGRAM

A. INTRODUCTION

THIS **ViTurns3 Program** (HEREINAFTER “**PROGRAM**”) IS OPTIONAL FOR THE SUBSCRIBERS OF **VODAFONE IDEA LIMITED** (HEREINAFTER REFERRED TO AS “**VIL/VODAFONE IDEA**”). THE SUBSCRIBER/S PARTICIPATING IN THE PROGRAM SHALL BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS. IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT PARTICIPATE IN THE PROGRAM

B. DEFINITIONS

“**Subscriber/You**” shall mean a subscriber in whose name the Subscriber Identity Module (SIM) is registered with VIL.

C. PROGRAM DETAILS

I. Program Period:

25th September to 30th September 2023 only. VIL reserves the right to extend or shorten the period, as it deems fit. If, in any State and/or territory or part thereof, the running of this Program is prohibited as per local rules or laws or requires licenses, Subscribers from such State and/or territory or part thereof shall not be eligible to participate in the Program. No further notice shall be given by VIL, in this regard.

II. Program Description, Selection Process and Gratification:

The Program will take place on Vi's Facebook page, Instagram account, Twitter handle (hereinafter Vi Social Channels) for each day to celebrate Vi's 3rd anniversary. For the Program, VIL will push 3 skill-based questions on each of Vi's Social Channels. Participants will have to answer these questions correctly in the comment section of the posts.

Participants to be eligible for winning in the Program must follow/be a follower of VIL's Social Channels and must answer all the 3 questions correctly.

II. Method of getting the Prizes:

From the list of comments (on the posts) who have answered all the three questions correctly on each day, 3 winners will be selected by the third party auditor, using the computerized process from across all the Vi Social Channels. Total 18 winners will be selected from the entire Program who will be eligible to win Disney+ Hotstar(mobile), unlimited calls, 2GB/day for a year or winning vouchers worth Rs. 3000 each..

IV. Winner Announcement:

The winners will be announced on Vi's Social Channels within 60 days from the commencement of the activity. The winner will be chosen by a third-party auditor. The decision of the auditor in this regard shall be final and binding, no dispute, shall be entertained by VIL.
