TERMS AND CONDITIONS GOVERNING THE Vi20 FAN fest-contest CH ALLENGE

IN TRODUCTION

THIS **Vi20 FAN fest Contest______CHALLENGE** (HEREINAFTER "CHALLENGE") IS OPTIONAL FOR **VODAFONE IDEA LIMITED** (HEREINAFTER REFERRED TO AS "VIL_VODAFONE IDEA") SUBSCRIBERS OF VIL.
