

TERMS AND CONDITIONS GOVERNING THE VI FAN OF THE MATCH CONTEST/CHALLENGE

A. INTRODUCTION

THIS **VI FAN OF THE MATCH CHALLENGE** (HEREINAFTER **"CHALLENGE"**) IS OPTIONAL FOR **VODAFONE IDEA LIMITED** (HEREINAFTER REFERRED TO AS **"VIL/VODAFONE IDEA"**) SUBSCRIBERS. THE PARTICIPANT/S PARTICIPATING IN THE CHALLENGE SHALL BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS. IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT PARTICIPATE IN THE CHALLENGE

C. CHALLENGE DETAILS

I. Challenge Period:

The Challenge can be played only on those days between 26th March 2022 to 30th May 2022, when the matches are scheduled at 7.30 pm in the evening. VIL reserves the right to extend or shorten the period, as it deems fit. If, in any State and/or territory or part thereof, the running of this Challenge is prohibited as per local rules or laws or requires licenses, the Eligible Subscribers from such State and/or territory or part thereof shall not be eligible to participate in the Challenge. No further notice shall be given by VIL, in this regard.

II. Challenge Description, Selection Process and Gratification:

You can participate in the Challenge via Vi's Facebook page, Instagram account and Twitter handle for all matches, scheduled at 7.30 pm on match days.

For Facebook & Twitter: Participants will have to answer 20 questions correctly during every match in the comment section of the posts.

For Instagram: There are 2 options as follows:

- 1. Participants can respond to all 5 questions on Instagram in the comments section and then visit our Facebook page to respond to the remaining 15 questions. OR
- 2. They can directly visit our Facebook page to answer 20 questions correctly during every match in the comment section of the posts.

There are no charges to participate in the Challenge through any channel.

The daily 20 questions will be pushed through the channels mentioned above, during the relevant days of the live evening (7.30 pm) match. The Participants are free to play the Challenge through any of the channels mentioned above.

The questions will be skill based general knowledge questions based on cricket and historic cricket matches.

Participant will have to answer at least one question correctly to be eligible to win shopping voucher of the day.

Participant will have to answer all questions correctly to be eligible for the winner of the match for each match day.

II. Type of Gratification:

- One Daily Match prize of an iPhone
- 20 vouchers with one winner for each correct answer

IV. Method of selection:

- For each Daily Question prize, the Participants who have answered the relevant question correctly, will be shortlisted and one winner will be selected basis computerized audit process. This winner will be entitled for shopping voucher.
- For each Daily Match prize, the Participants who have answered all questions correctly, will be shortlisted and one winner will be selected basis computerized audit process. In the event, there are no Participants who have answered the questions correctly, then the Participants with the highest number of correct questions will be considered. This winner will be entitled for an iPhone.

- The Daily Question winner will be announced within 20 working days of each match day.
- The everyday match winner of the iPhone will be announced within 20 working days of the match date.

Winners will be contacted through email or through phonefor 3 consecutive times, and will be given further details as to how, when and where they can redeem their respective gratification(s).
