#### A. INTRODUCTION

THE FOLLOWING TERMS & CONDITIONS SHALL BE APPLICABLE TO VODAFONE IDEA LIMITED (HEREINAFTER "VODAFONE IDEA/VIL") PRE-PAID SUBSCRIBERS PURCHASING THE ELIGIBLE PACKS AND USING ELIGIBLE SMARTPHONE DURING THE OFFER PERIOD AS MENTIONED HEREIN (HEREINAFTER KNOWN AS "SMARTPHONE PROGRAM /OFFER").

- d. "Eligible Smartphone" shall mean any 4G/5G smartphone, the IMEI of which was not live on VIL network during last 6 months prior to the commencement of the Offer.
- e. "Eligible Subscriber" shall mean an Active Subscriber who satisfies the following criteria during the Offer period:
  - i. Subscriber must be an Indian citizen belonging to Tamil Nadu, Punjab, Haryana, Kolkata & Rest of Bengal telecommunication service areas of VIL as mentioned herein;

### Description

Recharge discount will be given in the form of coupons on VIL's mobile application (VIL App).

# Steps for redemption & Restriction:

- a. Eligible Subscribers to download VIL App and purchase subsequent Hero recharges/Eligible Packs of Rs.299/& above for 24 months only through VIL App to redeem the recharge discount coupon of Rs.100/- on every such recharge.
- b. The Offer can be availed only once on a mobile number. That is any handset (IMEI) that has become eligible once for the Offer, cannot become eligible for the Offer in future, even in case of a different mobile number.
