#### TERMS AND CONDITIONS GOVERNING THE "ZEE5 PREMIUM BUNDLE OFFER"

#### A. INTRODUCTION

THIS DOCUMENT IS AN ELECTRONIC RECORD IN TERMS OF THE INFORMATION TECHNOLOGY ACT, 2000 AND RULES THERE UNDER AS APPLICABLE. THIS ELECTRONIC RECORD IS GENERATED BY A COMPUTER SYSTEM AND DOES NOT REQUIRE ANY PHYSICAL OR DIGITAL SIGNATURES.

THE FOLLOWING TERMS & CONDITIONS SHALL BE APPLICABLE TO VIL - PPREPAID VODAFONE IDEA LIMITED (VIL) SUBSCRIBERS SUBSCRIBING TO THE BELOW MENTIONED RECHARGE PACKS FOR PARTICIPATING IN THE OFFER KNOWN AS "ZEE5 PREMIUM BUNDLE OFFER" ("OFFER") DURING THE OFFER PERIOD AS MENTIONED HEREIN.

PLEASE READ THE FOLLOWING TERMS AND CONDITIONS CAREFULLY BEFORE AVAILING THIS OFFER".

BY AVAILING THE OFFER, YOU AGREE TO BE LEGALLY BOUND BY THESE TERMS AND CONDITIONS ("TERMS AND CONDITIONS"). IF YOU DO NOT AGREE TO THESE TERMS AND CONDITIONS, PLEASE DO NOT PARTICIPATE IN THE OFFER.

Non – Telco benefits:

The Offer provides ZEE5 Premium service ("ZEE5 service") of ZEE ENTERTAINMENT ENTERPRISES LIMITED ((HEREINAFTER "ZEE") at no extra cost on one year subscription basis to Eligible Subscribers. The ZEE5 service subscription expires after the period of one year.

You will continue to receive the benefit of ZEE5 service annual subscription provided You continue to avail regular VIL unlimited (UL) recharge of minimum INR 219 or any VIL UL recharge of higher denomination as You may like for a period of 12 months. You will get telco benefits as per the UL recharge pack you subscribe. For VIL UL recharge of INR 219, your telco benefits will be as under – 1GB/day and Unlimited Voice calls with validity of 28 days.

## 2. Offer Activation Steps:

The Eligible Subscribers would need to complete activation process to activate the ZEE5 service as mentioned below:

- 1. Eligible Subscriber has to recharge with the bundled recharge packs mentioned in table above from any source
- 2. Eligible Subscriber will get a confirmation SMS informing about the successful recharge
- 3. In this SMS, the Eligible Subscriber will also get a ZEE5 activation link that the subscriber will have to click in order to activate the ZEE5 annual subscription. The Eligible Subscriber has to click the said ZEE5 activation link and complete the below mentioned activation process within 28 days of recharge to avail the ZEE5 subscription, failing which the activation link will lapse and ZEE5 subscription will not be available.
- 4. Once the Eligible Subscriber clicks on the link, a webpage will be opened where Eligible Subscriber will be validated by VIL or by subscriber typing his/her MSISDN and OTP.
- 5. Once the Eligible Subscriber is validated, the page will show Activate now button along with a message asking the subscriber to click the button in order to activate the ZEE5 subscription.
- 6. The Eligible Subscriber clicks the button and his/her ZEE5 subscription is activated.
- 7. ZEE5 will send the Eligible Subscriber a username and temporary password that can be used to login to the ZEE5 app or website in order to enjoy the ZEE5 subscription.

#### 3. Other conditions:

ZEE5 service is for one year which is a once in a life time offer and Eligible subscriber can avail it once only on a VIL mobile number.

In case of any deactivation of VIL's services which may be due to mobile number portability option chosen by subscriber, or if the subscriber opts to avail VIL recharge pack that is different from the UL recharge packs mentioned herein etc., ZEE5 service subscription will get deactivated immediately on the date of deactivation of SIM Card or on the date of expiry of UL recharge packs mentioned herein and You will cease to avail the ZEE5 service on immediate basis.

In case of any temporary suspension of VIL's service which may be due to various reasons such as loss of SIM, VIL may at its discretion decide to suspend the ZEE5 service.

An existing ZEE5 pack user (who has availed ZEE5 service subscription directly from ZEE5) initiating any of the bundled recharge packs mentioned in table above for the first time will be provided ZEE5

service annual subscription from the date of activation of such subscription and not after the completion of existing ZEE5 pack validity.

Post completion of the ZEE5 service annual subscription period, there will be no auto renewal of ZEE5 service.

#### D. OFFER PERIOD

- a) This is a limited period offer by VIL available <u>till 31<sup>st</sup> March 2021 23:59hrs</u> unless revoked by VIL ("Offer Period").
- b) VIL reserves the right to extend or shorten the Offer Period, as it deems fit.

### F. OFFER AREA


