- 1. The "Always On" feature keeps you connected even after pack expiry.
  - a. Post expiry of your roaming pack, continue using IR pack benefits where you will be charged as per the standard rates till the usage value accumulates to Rs.749 for that day, post which you will be charged as per 1 day Roaming 749 Pack. The initial charging shall happen as per standard rates. Once the charges exceed the One-Day pack value for that country, then automatically 'Always On' with all its benefits applies to the customer to protect him/her from any further standard charges for the day. The "Always On" feature has a validity of 3 years once it gets activated.
- 2. IR service rental of Rs.149 per month will not be applicable for users active on IR packs in table above.

Outgoing call benefits are not applicable for calling premium rate numbers/special codes/toll free number abroad/Maritime/Satellite/Ship Cruise or Inmarsat.

All Roaming packs are meant only for the use of retail customers and are **not meant for commercial/non-retail use.** Any commercial/non-retail usage on these packs are subject to scrutiny and appropriate action as deemed fit, will be taken by Vodafone Idea limited. Non-retail usage is defined as cumulative duration of outgoing or incoming calls > 120 minutes per day and/or data usage > 2GB/day, which is far in excess of the average daily usage by individual subscribers in the course of international roaming.

### RoamSafe Feature

In order to safeguard a customer from accidental data usage when travelling abroad, the data service would be inactive by default in the following scenarios:

- I. A customer is roaming in any country without an international roaming pack.
- II. A customer is active on an international roaming pack, but roaming in a country where the pack is not applicable.

However, in such scenarios, if a customer wishes to use data which will be charged at standard international roaming rates (available at <a href="International Roaming - Country (myvi.in">International Roaming - Country (myvi.in</a>)), he/she can request to activate the service as below:

- I. To activate the data service, send **SMS ACT IRDATA to 199**
- II. This service will remain active for 2 Days and gets automatically deactivated after 2 Days. You can renew this service after every 2 Days by sending the SMS ACT IRDATA to 199.
- III. To deactivate data services, send SMS CAN IRDATA to 199

Note: The SMS would be charged at Rs15/SMS if sent from an international location

All Calls to Vi<sup>™</sup> Customer Care Number, on International Roaming, are free of cost. To check the customer care number for your state, please check FAQs on myvi.in or Vi app.

## **Other Terms & Conditions**

- 'VIL Postpaid Roaming Pack' or 'Pack' shall mean and include VIL Postpaid SIM Card and the international roaming pack purchased for use on such SIM Card.
- All pack activations will be basis Indian Standard Time (IST) and applicable until pack validity calculated as 1 day =24 Hrs from time of activation of the pack.
  - For e.g. Roaming 2999 pack If you requested for Roaming 2999 pack at 15:00 hrs IST on the 1st of Aug, you start availing pack benefits immediately on receipt of the activation confirmation SMS (approx. 30 mins after request). Benefits will be applicable till 14:59 hrs IST on the 10th of Aug. Post 10th Aug, if you are still in one of the pack countries, and without a pack, the 'Always On' feature will get activated

- If you are in UAE (1.5 Hrs. behind IST) & opting for a 10 day validity IR pack on 1st Aug 20:00 Hrs. UAE time. (21:30 Hrs. IST) Expiry date of pack will be 10<sup>th</sup> Aug 19:59:59 UAE time (21:29:59 IST), if you are is still in UAE, you will get discount up to 19:59:59 Hrs. UAE local time
- For activation of International Roaming packs, International Roaming (IR) service activation is mandatory.
- For IR service activation, based on the discretion of VIL's credit services, additional security deposit may or may not be payable.
- Future-dated pack deactivation: If a customer want to deactivate their future-dated roaming pack, before the pack gets activated, they need to call customer care.
- If international roaming (fixed validity) packs active, customer will be charged rental for each day of pack active irrespective of usage
- Discounted rates are applicable on local calls, international calls, SMS & data usage in International roaming within the validity of the pack
- There is no proration of rental charges. Rentals will be charged in full, irrespective of the usage done.
- If International Roaming pack is activated, customers can roam in any other country other than the countries mentioned in the respective packs as well, but would be charged as per standard international roaming rates.
- Benefits are valid only on international roaming usage and cannot be used for local/STD/ISD/National Roaming usage.
- International Roaming pack/quota benefits are not applicable for premium rate numbers / special codes / Toll free numbers abroad/Maritime / Satellite / Ship Cruise or Inmarsat. Calls to premium rate numbers or special numbers / special codes / Maritime / Satellite / Ship Cruise or Inmarsat will be charged at the rates charged by the visited network.
- Customers can switch off the data services from their mobile handset in case they don't wish to use mobile internet while roaming.

- Call duration is rounded upwards to the nearest 60 secs, since pulse rate for voice call is 60 seconds. Data usage is rounded upwards to the nearest multiple of 1 MB, since pulse rate for data is 1 MB. SMS beyond 160 characters (i.e. including blank space, words, characters, numbers, special characters, symbols etc.) is considered as 2 or more SMS (as the case may be).
- Caller Line Identification Number (CLI) is not guaranteed while any International roaming pack is active. That is, if a customer receives a call on his number while in IR, then it is not guaranteed that the number from whom he/she is receiving the call would be displayed.
- All voice call rates displayed as rates per minute.
- SMS code for activation is toll-free only if sent from India.
- VIL reserves the right to amend or withdraw the offer without prior notice.
- International Roaming packs for company paid connections cannot be activated online or through SMS/USSD/IVR/Website/App and customers need to contact their relationship managers for any requirements
- Usage in the bill is displayed basis the country local time

- Services under international roaming packs will be available subject to foreign operator's network conditions as well as Indian regulatory guidelines applicable from time to time: Services will be available subject to compatible handset, foreign operator's network conditions as well as Indian regulatory guidelines applicable from time to time. VIL cannot guarantee and makes no representation that International roaming services shall always be available or fit in terms of the coverage, reception quality, connectivity as Services are offered on best effort basis. VIL will not be liable for the coverage, reception quality, connectivity and Services while on International roaming.

- Charges may be delayed if the external carrier is delayed in advising VIL of roaming activity.
- You understand and agree that billing for the Services is dependent upon the Call Data Records (CDR's) sent by the International Roaming Partner. As per the process set forth by the GSMA, an International Roaming Partner can send CDR's within sixty (60) days after the usage event. There can be the events that International Roaming Partner sends CDR's:
  - o After your billing cycle date.
  - o Or your billing cycle date and the date of receipt of CDR are not the same.
  - In case of the above events VIL may not be able to send alarms to you for high usage and/or the customer uses services beyond the credit limit assigned. Also, in such cases you may be billed for international roaming usage in the current or subsequent bill cycles. In all cases you unconditionally agree to make the timely full payment of your bills for the usage of the Services.
- Data Alerts will be sent out at 50%, 90% and 100% of the data usage on pack.
- No alerts will be sent out on voice usage i.e. outgoing call minutes consumed.
- Video Calls feature provided by select international telecom service providers are NOT guaranteed on international roaming but might be successful in some networks. Video calls if successful will be charged as per the visited network tariff Type of calls (Outgoing local/national / international, incoming) and will be controlled by the roaming partner.
- VIL's Postpaid SIM and International Roaming Pack purchased by customer is intended for his
  / her own individual use and shall not, under any circumstances, be transferred / alienated to
  others.
- VIL's International Roaming Pack purchased by a customer is intended for his / her short term foreign travel for leisure, business travel, medical purposes etc. ('Foreign Travel'), and shall not, under any circumstances, be used as a substitute of local mobile connections available in a foreign country for long term stay of more than 60 days. VIL's International roaming packs cannot be used by a customer continuously for more than 60 days.
- In case of any breach of the terms and conditions herein and / or misuse / fraudulent use / unauthorized use or for the cases where the SIM is transferred / alienated and / or used for any commercial purpose, including telemarketing or otherwise, the preferential tariff plan for the international roaming pack shall be withdrawn, and normal roaming tariff/ charges including voice and data charges shall be applicable.
