

TERMS AND CONDITIONS GOVERNING THE OFFER
Amazon Prime Lite for VIL Prepaid user on VIL app

INTRODUCTION

- THIS DOCUMENT IS AN ELECTRONIC RECORD IN TERMS OF THE INFORMATION TECHNOLOGY ACT, 2000 AND RULES THERE UNDER AS APPLICABLE. THIS ELECTRONIC RECORD IS GENERATED BY A COMPUTER SYSTEM AND DOES NOT REQUIRE ANY PHYSICAL OR DIGITAL SIGNATURES.
- THE FOLLOWING TERMS & CONDITIONS SHALL BE APPLICABLE TO THE PREPAID SUBSCRIBERS OF VODAFONE IDEA LIMITED (“VODAFONE IDEA/VIL/VI”) SUBSCRIBING TO SPECIFIC RECHARGE PACKS AS MENTIONED UNDER THE OFFER DETAILS AND AVAILING THE BENEFIT KNOWN AS “**Prime Lite**” AS THE CASE MAY BE (HEREINAFTER “**OFFER**”) DURING THE OFFER PERIOD AS MENTIONED HEREIN.
